WHEN DO I NEED A TREE PERMIT IN BILOXI?

Any Pecan (Carya illinoinensis), Chinese tallow or Popcorn (Sapium sebiferum), Water Oak (Quercus Nigra), or member of the Pine genus (Pinus spp.); do not require a permit to remove anywhere in the City of Biloxi.

Routine trimming is any trimming that <u>does not impair the tree's aesthetic, ecological, or economic value</u>. Routine trimming does not require a permit. The reasons for pruning may include but are not limited to, reducing risk, maintaining or improving tree health and structure, improving aesthetics, or satisfying a specific need.

Crown cleaning, thinning, raising, reduction, or restoration (according to ANSI A300 "Tree, Shrub, and Other Woody Plant *Maintenance* - Standard Practices (Pruning)") shall be considered routine trimming.

<u>Substantial Pruning shall require a permit</u>. ANSI A300 5.0 Pruning Practices 5.5.3 Not more than 25% of overall foliage, 5.5.4 Not more than 25% of the foliage of a branch 5.5.7 "Topping and Lion's Tailing shall be considered unacceptable pruning practices for trees"

Zoning?

<u>Single-Family Residential Zoned Areas need a permit to</u>: Remove Live Oak, Magnolia, or Bald Cypress, which measures a minimum of 8" in diameter, measured 54" (4½ feet) above the ground.

Multiple-Family Residential (Apartments or Condos), Commercial, or Industrial Zoned Areas need a permit to:

- 1. Removal of (Live Oak, Bald Cypress, and Southern Magnolia) that are at least 8" diameter at DBH (diameter at breast height 54" above the ground).
- 2. Removal of any other tree or woody perennial plant, which has a single trunk, which measures 16" or more inches.
- 3. In addition, the City will place one or more signs on the property for which the permit is sought, clearly visible by the public from any roadway adjacent to the property, stating "A permit to remove five (5) or more protected trees has been requested for this property. The Planning Commission will hold a full public hearing regarding this case at 2:00 p.m. on (date) at 676 Dr. Martin Luther King, Jr. Blvd. For further information call the Community Development Director at 435-6280". No preliminary or final permit to remove trees may be issued until the above-mentioned sign has been posted for at least fifteen (15) days.

The application and tree site plan shall be reviewed and either approved or denied by the tree committee within seven (7) working days from submission thereof unless the permit must go before the Planning Commission for a full public hearing and such action shall be reported in writing to the applicant.

Who is authorized to approve the permit?

- The City Arborist has the authority to issue permits to remove diseased trees, or remove trees on City property, which are not protected.
- The Tree Committee shall review any permits to remove one to four healthy protected trees in any zoning area.
- The Planning Commission shall review any permit to remove five or more healthy protected trees in a multiple-family residential (apartments or condos), commercial, or industrial-zoned area.

Violators will go to court!

Any person who violates any provision of this chapter shall be charged with a misdemeanor in the Biloxi Municipal Court.

TIPS FOR SELECTING A TREE CARE COMPANY

- 1. Education, experience, and a good reputation are signs of a good arborist or tree care professional.
- 2. **Beware of an arborist who is eager to remove a living tree.** Removal clearly should be a last resort. If you have any questions or need additional information, please call 228-435-6280 or email zharris@biloxi.ms.us
- 3. Ask for local references other jobs the company or individual has done. Take a look at some, and if possible, talk with the former client.
- 4. Have more than one tree care company look at your job and provide solutions and estimates. Don't expect one to lower a bid to match another's; be willing to pay for the estimate if necessary. Getting two or more opinions and cost estimates are well worth your extra effort.
- 5. <u>A good tree care company will offer a wide range of services</u> (pruning, fertilizing, cabling/bracing, lightning protection, pest control, etc.).
- 6. A conscientious tree care company will only use climbing spikes when removing trees completely.
- 7. **Beware of door-knockers**. Most reputable companies have all the work they can handle without going door-to-door. Door-knockers are especially common after storms when non-professionals see a chance to earn some quick money. Often, storm damage creates high-risk situations for both workers and homeowners, and there is opportunity for even more damage to trees if work is not done correctly.
- 8. NEVER PAY IN ADVANCE. Never pay for work until you are completely satisfied. Never be rushed by bargains ("If you sign an agreement today, I can take ten percent off the price...").
- 9. Ask for certificates of insurance, including proof of liability for personal and property damage (such as your house and your neighbor's), and workman's compensation. Then **phone the insurance company to make sure the policy is current**. Under some circumstances, you can be held financially responsible if an uninsured worker is hurt on your property, or damage is done to a neighbor's property!
