WHEREAS, the City of Biloxi, Mississippi is an "Entitlement City" under the terms of the United States Department of Housing and Urban Development (HUD), Community Development Block Grant Program (CDBG), and Biloxi is a participating member of the Gulfport-Biloxi-Harrison County HOME Consortium; and

WHEREAS, the Regulations of the CDBG program require the preparation and adoption of a One Year Action Plan which serves as the annual application for CDBG Entitlement funds and HOME allocation; and

WHEREAS, the City has prepared the One Year Action Plan for the 2012 CDBG and HOME Program Year in accordance with Rules and Regulations governing the One Year Action Plan; and

WHEREAS, the said One year Action Plan for the 2012 CDBG and HOME Program Year includes, among other things, the anticipated use of the City's 2012 Program Year CDBG Entitlement of \$511,204, Program Income estimated to be available of \$146,213, a HOME allocation of \$189,225; and

WHEREAS, the said One Year Action Plan for the 2012 CDBG and HOME Program Year has been prepared in accordance with HUD requirements which include, among other things, interagency consultation, a public hearing, and a 30-day comment and review period for the Draft One Year Action Plan; and

WHEREAS, the Mayor and the City Council of the City of Biloxi, having considered citizens' comments, have determined that the One Year Action Plan for 2011 CDBG and HOME Program Year which is attached hereto as Exhibit A, will serve the best interests of the City of Biloxi.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILOXI, MISSISSIPPI, THAT:

Section One: The findings, conclusions, and statements of fact contained in the preamble are adopted and ratified.

Section Two: The One Year Action Plan for the City of Biloxi, Mississippi, 2012 CDBG and HOME Program Year be and is hereby adopted.

Section Three: A.J. Holloway, Mayor in and of the City of Biloxi, be and is hereby authorized to sign the required HUD certifications and to submit the said 2012 One Year Action Plan to HUD for review and approval.

CITY OF BILOXI, MISSISSIPPI 2012 ACTION PLAN

A. <u>Executive Summary</u>

The City of Biloxi's 2012 Action Plan identifies activities to be undertaken during the program year beginning January 1, 2012 and ending December 31, 2012. The Action Plan serves as the City's application to HUD for entitlement grants. The City of Biloxi anticipates receiving Community Development Block Grant (CDBG) funds from the U.S. Department of Housing and Urban Development for the 2012 calendar year in the amount of \$511,204. The City also anticipates receiving CDBG program income in the amount of \$146,213, bringing the total CDBG funds available for the 2012 calendar year to \$657,417.

Biloxi is not a formula entitlement recipient under the HOME, ESG, or HOPWA programs. The City of Biloxi is a participant in the Biloxi-Gulfport-Harrison County HOME Consortium, which received HUD approval in 2001. As a participating jurisdiction, Biloxi has received an annual allocation of HOME funds since 2001 and uses the funding for affordable housing initiatives. The City of Gulfport serves as the Lead Entity for the Consortium and is responsible for administration of the HOME program and compliance with all program rules and regulations. Biloxi expects to receive HOME funds totaling \$189,225 for the 2012 program year.

The activities described in the plan are intended to benefit primarily low-to-moderate income residents in the City of Biloxi. The plan describes the resources available, the programs, and the proposed accomplishments for the 2012 Action Plan.

Summary of Citizen Participation

The 2012 Action Plan was developed in a manner to insure participation by citizens, citizen groups, and agencies, particularly those agencies comprising the institutional structure delivering housing and supportive services to Biloxi's low- and moderate-income residents. The agencies were encouraged to submit written comments or data to the City. In order to insure that all citizens and agencies had an opportunity to participate in the development of the Action Plan, the City undertook the following:

- 1. Published "Notice of Availability of Information Relative to the City of Biloxi's 2012 Action Plan" on Thursday, August 11, 2011 in the *Biloxi-D'Iberville Press*.
- 2. Published "Notice of Public Hearing" on Thursday, August 18, 2011 and Thursday, August 25, 2011 in the *Biloxi-D'Iberville Press*.
- 3. Conducted public hearing on September 1, 2011.
- 4. Published "Notice of Availability of Draft 2012 Action Plan on Thursday, September 22, 2011 in the *Biloxi-D'Iberville Press*.

The City received one (1) written comment concerning the 2012 Action Plan and use of funds. The written comment was from Loaves and Fishes, Inc. Loaves and Fishes, Inc. requested the City continue to support the work of Loaves and Fishes, Inc. The City, from their General Fund, will continue its program support of Loaves and Fishes, Inc. by giving \$16,800 to the non-profit organization.

Summary of Needs and Priorities

The 2012 Action Plan focuses the City's housing and community development programs on the strengthening of low-and moderate-income neighborhoods and the quality of life for all. The City will allocate the majority of its 2012 CDBG funds for the purchase of equipment and supplies for a Senior Program administered through the City's Parks and Recreation Department. These activities will be held at the Synder Center and the Gruich Center which are both city buildings. The City will purchase the following items for these activities:

- Tic-Tac-Toe Floor Game
- Jumbo Connect Four Game
- Jumbo Checker Set
- Horseshoe Game
- Puzzles
- Large Bingo Set with cards and markers

The City will also use funds to purchase equipment and supplies for a Special Needs Service Program administered by the City's Parks and Recreation Department. These activities will be held at City Parks, the Snyder Center and the Gruich Center which are both city buildings. The City would like to purchase the following for these activities:

- Projector
- Flat Screen TV/DVD
- Adaptive games
- Adaptive swimming equipment
- Wheel chair swings (2)
- Tennis wheelchairs

The City also plans to utilize CDBG funds for Phase II of the Howard Avenue Reconstruction Project. All HOME funds will be utilized for the Homebuyer Assistance Program.

B. Sources of Funds

This section of the Action Plan attempts to identify resources that may be available during the program year to address the non-housing, housing, and supportive service needs of Biloxi's families who are principally low/moderate-income.

The City will support applications for federal and state funding for facilities and programs whose purposes and objectives are consistent with the Five-Year Consolidated Plan for Housing and Community Development Programs, 2010-2014, City of Biloxi. The table on page __ identifies some HUD funding sources for which applications from entities serving Biloxi residents will receive City support if the purpose for funding is consistent with the adopted Consolidated Plan.

HOME Program Consortium and as such is responsible for administrative duties
and overall compliance with HOME program rules and regulations.

The HOME Program Consortium funding will allow participating jurisdictions to fund programs to carry out multi-year housing strategies through assistance t60 first-time homebuyers and existing homeowners, property acquisition, rehabilitation, and new construction of site improvements, tenant base rental assistance, demolition, related relocation expenses, and other reasonable and necessary expenses related to the development of affordable housing.

The City proposed to use HOME funds available to add the priority need of affordable housing. The HOME funds will be used to provide homebuyer assistance to first-time homebuyers.

C. Statement of Specific Annual Objectives

The City of Biloxi's summary of priorities and specific annual objectives to be addressed by the end of the program year are outlined in Table 3A, Summary of Specific Annual Objectives, which is attached as Exhibit I.

D. Description of Activities

The City of Biloxi's summary of eligible programs or activities to be undertaken during the program year to address the needs and specific objectives identified in the 2010-2014 Consolidated Plan are outlined in Table 3C, Consolidated Plan Listing of Projects, which is attached as Exhibit II. Below is a description of activities that the City of Biloxi expects to undertake with CDBG and HOME funds to address priority needs in the Five-Year Consolidated Plan. Additionally, below are the eligible CDBG activities to be undertaken with local funds of the City of Biloxi.

1. Community Development Block Grant Program

Senior Program (\$10,000)

The City will allocate the majority of its 2012 CDBG funds for the purchase of equipment and supplies for a Senior Program administered through the City's Parks and Recreation Department. These activities will be held at the Synder Center and the Gruich Center which are both city buildings. The City will purchase the following items for these activities:

Howard Avenue Reconstruction, Phase II (\$527,417)

This project consists of the installation of storm drains, sanitary sewer lines and water replacement, widened sidewalks and landscaping along approximately ten blocks of Howard Avenue, from Ahern Street eastward to Myrtle Street (i.e., the "second phase"). This section of Howard Avenue is located in a low-to-moderate income area.

2. HOME (2012 Consortium Allocation)

Homebuyer Assistance Program (\$189,225)

The City will provide down payment assistance to first time homebuyers.

F. Allocation Priorities and Geographic Distribution

The priority needs listed in the 2012 Action Plan were selected due to the imminent need to address the problems. Activities undertaken are located in predominantly low- and moderate-income areas including minority concentration locations. Attached as Exhibit III is a map indicating low and moderate-income areas in the City and a map indicating minority concentration areas in the City. Also, attached as Exhibit III is a map of the location of the activities to be undertaken during the 2012 Action Plan program year.

1. City-wide Projects:

This section of Howard Avenue is located in a low-to-moderate income area.

G. Annual Affordable Housing Goals

The City of Biloxi's annual affordable housing goals to be accomplished during the Action Plan program year are outlined in Table 3B, Annual Housing Completion Goals, which is attached hereto and marked Exhibit IV.

H. Public Housing

1. Needs of Public Housing

The Biloxi Housing Authority (BHA) owns and manages eight public housing complexes in the City assisting nearly 1,500 public housing residents.

According to the City of Biloxi's 2010-2014 Consolidated Plan, the BHA reported that there were approximately 756 families on the waiting list for public housing, and there were only 17 vacancies. While there is an apparent need for additional public housing, there is also a great need for housing specifically designated for low-income elderly citizens. Furthermore, the BHA reported that a total of zero units were deemed to be below standard. While most developments were reported to be in good condition, only two of the developments were in need of light renovation.

In addition to these eight public housing sites, the Mississippi Region VIII Housing Authority provides Section 8 rental assistance through Section 8 certificates and vouchers

to hundreds of residents in the City of Biloxi. According to the 2010-2014 Consolidated Plan, there were approximately 275 families on the waiting list for Section 8 vouchers.

Although the 2012 Action Plan does not designate funding towards public housing, the City of Biloxi will continue to work with and support the Biloxi Housing Authority and the Mississippi Region VIII Housing Authority through the following actions:

- Continue to support the efforts of the Biloxi Housing Authority and the Regional Housing Authority to eliminate obsolete public housing.
- Support the Biloxi Housing Authority's efforts to repair and replace public housing damaged by Hurricane Katrina.
- Support the Biloxi Housing Authority's efforts to secure funds for additional assisted housing.
- Support the Biloxi Housing Authority's efforts to secure funds for additional assisted housing designated for elderly citizens.
- Support the Biloxi Housing Authority's efforts to improve the living environment at all assisted housing sites.

I. Homeless and Other Special Populations

This portion of the 2012 Action Plan attempts to identify what the City of Biloxi and agencies serving its jurisdiction will do to address the needs of the homeless and others with special needs outlined below.

The jurisdiction's strategy for addressing homelessness will focus to a great extent on the Salvation Army, South Mississippi AIDS Task Force, LIFE, Open Doors Homeless Coalition, Catholic Social Services, Gulf Coast Women's Center, Interfaith Hospitality Network, Back Bay Mission, Gulf Coast Rescue Mission, and others. The City of Biloxi will continue to support the efforts of these service providers who serve the homeless and those threatened with homelessness.

The City of Biloxi is an active participant in the Gulf Coast Continuum of Care, which is a multi-county-multi-agency effort to address the full continuum of care for the homeless. The City will continue to participate in the Continuum of Care and will actively support efforts to obtain HUD and other funding to broaden the spectrum of services available to the homeless and increase and improve the level of services. In addition, the City will continue to support efforts of the Open Doors Homeless Coalition to assess and address the needs of homeless persons and to obtain grant funding to assist those on the verge of becoming homeless.

Although the 2012 Action Plan does not designate CDBG funding to specifically address homeless needs, numerous social service agencies within the City of Biloxi who provide shelter and support services for homeless persons have been awarded financial assistance from the City's General Fund (See page 7). In addition, the City will continue to implement the following strategies to address homelessness:

1. Outreach Assessment to Address Homeless Needs

The City's strategy for meeting this need includes the following:

- The City and the various agencies serving the homeless with shelter, food, clothing, etc. will continue to seek to establish methods of assessing the needs of the homeless. Homeless persons will be interviewed in an attempt to determine their needs, both immediate and long-term, in order to ascertain what can be done to meet their present needs and most importantly, their long-term needs so that self-sufficiency and economic independence in a permanent housing environment can be attained.
- The City will continue to endorse and support the Salvation Army, South Mississippi AIDS Task Force, Meals on Wheels, Mental Health Association of Mississippi, Open Doors Homeless Coalition, Catholic Social Services, Gulf Coast Women's Center, Interfaith Hospitality Network, Back Bay Mission, Gulf Coast Rescue Mission, and other known agencies in development and implementation of its community outreach programs.

2. Helping Low-Income Families From Becoming Homeless

Helping low-income families avoid becoming homeless will be addressed by the City of Biloxi with the following actions:

- The City will support applications for funding that will ensure continued and expanded assistance programs to reduce the extent of cost burden on lowand moderate-income families to aid in keeping housing affordable. Programs such as Weatherization, LIHEAP, Section 8, Public Housing, FEMA rental and mortgage assistance, and others will be supported.
- The City will continue to support applications for funding and continued and expanded services for programs providing food, clothing, utility assistance, counseling, job training, day care, and others. Such agencies as the Gulf Coast Women's Center, American Red Cross, AIDS Task Force, Interfaith Hospitality Network, Catholic Social and Community Services, Loaves & Fishes, Moore Community House, Back Bay Mission, and others will be supported.
- The City will continue to support efforts of agencies to gain increased funding from FEMA to provide rental and mortgage assistance payments for those in crisis.
- The City supports efforts of the Open Door Homeless Coalitions to obtain grant funding through "Homeless Prevention and Rapid Re-housing Program" in order to assist those families on the verge of becoming homeless with counseling, financial assistance and long-term solutions.
- 3. Addressing the Emergency Shelter and Transitional Housing Needs of Homeless
 The need for additional expanded or emergency shelter facilities and supportive services
 has been clearly established from data supplied by entities such as the South MS AIDS
 Task Force, Back Bay Mission, Interfaith Hospitality Network, and others. Strategies for
 addressing the emergency shelter and transitional housing needs of homeless individuals
 and families include the following actions:

- The City will support applications from agencies currently providing emergency shelter and supportive housing to the homeless. Agencies such as the Gulf Coast Women's Center, the Women's Resource and Empowerment Center (a subsidiary of the Center for Environmental and Economic Justice), the Salvation Army, Gulf Coast Rescue Mission, and others will be supported in efforts to expand the capacity of such programs.
- The City will support agencies serving the jurisdiction, which will seek funding opportunities to establish a transitional housing program with facilities and supportive services.
- The City will continue to support the South Mississippi AIDS Task Force efforts to obtain ESG, HOPWA, and other funding to meet the growing unmet needs of homeless persons with HIV/AIDS and their families.

4. Activities to Address Non-Homeless Persons with Special Needs

The City and service providers will address the housing and supportive service needs of special groups including the following actions:

- The City has allocated funds in its 2012 Action Plan to for equipment for a City Administered Senior Program and for equipment for a City Administered Special Needs Services Program,.
- The City will support applications for federal and state funding to assist housing and supportive service providers in obtaining funds for continuation and expansion of services and facilities.
- The City will support agencies such as the Mississippi Regional Housing Authority No. VIII, the Biloxi Housing Authority, Catholic Community and Social Services, and others in their efforts to obtain more housing and housing assistance for the elderly through such programs as Public Housing Development Grants, Section 8 Certificates and Vouchers, HUD Section 201 and 811 Housing, Tax Credits, and others.
- The City will support applications for funding to assist agencies such as the Catholic Community and Social Services and American Red Cross with programs to assist the elderly with reducing utility costs and paying utility bills, i.e., Weatherization and LIHEAP. Programs such as Meals on Wheels, which delivers meals to homebound elderly; Coastal Family Health Center, and other home health programs will be supported in their efforts to assist the elderly and frail elderly.
- The City will support agencies and applications for funding to continue and expand programs and facilities to meet the needs of mentally, developmentally, and physically disabled persons. Agencies such as the South Mississippi AIDS Task Force, the South Mississippi Regional Center, LIFE, Gulf Coast Mental Health, and the Mental Health Association of Mississippi will be supported.

- The City will support efforts to continue and expand programs and facilities
 to address the needs of persons who have alcohol or drug addictions.
 Agencies such as the Coastal Family Health Center, South Mississippi AIDS
 Task Force, Salvation Army, Gulf Coast Rescue Mission, and others will be
 supported in their efforts to develop new facilities to house and counsel
 persons addicted to drugs and alcohol.
- The City will support Moore Community House, the Boys and Girls Club, and other agency efforts to expand or develop new facilities to house youth activities, child care, or to develop like facilities.
- The City will continue its support of the South Mississippi AIDS Task Force and will endorse the agency's efforts to develop housing capabilities for persons with HIV/AIDS and their families. The City will support efforts to expand the agency's capacity to house and provide an expanded comprehensive approach for assisting persons with HIV/AIDS and their families with food, housing assistance, medicines, transportation, home health care, and other related services.
- The City will endorse and support efforts to establish a health facility specifically devoted to health care for persons with HIV/AIDS and will endorse and actively support efforts to develop broad educational programs focused on AIDS prevention.
- The City will continue to support agencies and applications for funding for agencies providing a full array of services, which support the low- and moderate-income population and help persons to avoid homelessness. Such programs as the following, among others, will be supported as will applications for funding: American Red Cross, Meals on Wheels, Loaves & Fishes, Back Bay Mission, and others.
- The City will support agency efforts to assist public housing residents to make a transition to independent living. Agencies such as the Mississippi Regional Housing Authority, the Biloxi Housing Authority, the Salvation Army, the Boys and Girls Clubs, Moore Community House, Interfaith Hospitality Network, and others will be supported in their efforts to provide opportunities for public housing residents to seek gainful employment and economic self-sufficiency. Programs such as resident initiatives, economic development training, homeownership, comprehensive day care programs, and youth programs will be pursued, encouraged, and supported.

3. Steps to End Chronic Homelessness

Helping homeless persons make the transition to permanent housing and independent living is also assigned a high priority.

• The City will support agencies that seek additional transitional housing to accommodate those making the transition from homelessness to permanent independent living.

- The City will support the Mississippi Employment Security Commission, the Salvation Army, and others to seek training programs to assist those in transition to find gainful employment that will lead to self-sufficiency and economic independence.
- The City will support the agencies in their efforts to develop innovation in small businesses for the working poor and others of low-moderate-income.

J. Other Actions

Actions to Foster and Maintain Affordable Housing and Remove Barriers to Affordable Housing

The need for affordable permanent housing and affordable rental housing was identified by community leaders and citizens as one of the greatest challenges facing the City of Biloxi. To foster and maintain affordable housing and remove the barriers to affordable housing, the City of Biloxi will seek to accomplish the following:

- The City will continue to work with and support efforts of the Biloxi Housing Authority to expand public housing and improve existing public housing.
- The City will continue to participate in rental rehabilitation programs, the 312 Loan Program, Urban Renewal, and local rehabilitation loan and grant programs.
- The City will continue to support efforts of various agencies to obtain HOME funding to broaden much needed opportunities for homebuyer education and assistance for homeownership.
- The City's Zoning Ordinance and Subdivision Regulations provide for zero lot line developments and include other provisions that encourage new affordable housing developments.
- The City will continue to make funds available through the CDBG and HOME programs such as Meals on Wheels, Moore Community House, Gulf Coast Women's Center, Boys & Girls Club, and others for supportive services, which among other things, keep housing affordable.
- The City will continue to utilize HOME funds to increase homeownership for first-time homebuyers and down payment assistance programs available through the Gulfport-Biloxi-Harrison County HOME Consortium.
- The City will continue to work with and support those agencies that can assist individuals with credit repair and homebuyer education.
- The City will continue to implement the Fair Housing Plan and its outreach strategy in an effort to affirmatively further fair housing and eliminate discrimination.

2. Actions to Assist with Public Housing Improvements and Resident Initiatives To encourage public housing residents to become more involved with management and

participate in homeownership, the City will seek to accomplish the following:

- The City will support the Biloxi Housing Authority in its efforts to replace and demolish public or assisted housing units that are not feasible for repair.
- The City will continue to support minority and low- to moderate-income homeownership initiatives of the Regional Housing Authority and the Biloxi Housing Authority.
- The City will continue to support the Biloxi Housing Authority's efforts to seek funding to expand and improve public housing.
- The City will support the Biloxi Housing Authority's resident initiative program.
- The City will support efforts of the Biloxi Housing Authority to improve public housing units that are feasible for repair.

3. Actions to Reduce Lead-Based Paint Hazards

The reduction of lead-based paint hazards will require a coordinated effort on the part of housing providers in Biloxi. The City of Biloxi, the Biloxi Housing Authority, and the Mississippi Regional Housing Authority No. VIII will play the most significant roles in this effort.

- The City will continue to required abatement of lead-based paints in connection with implementation of its CDBG housing rehabilitation program. The program requires testing for the hazard and abatement, if necessary, in accordance with EPA requirements.
- The City's code enforcement efforts will require upgrading of structures to code standards thus eliminating or reducing the likelihood of exposure.
- The Biloxi Housing Authority will continue to require abatement of lead-based hazards prior to public housing rehabilitation or renovation.
- The Mississippi Regional Housing Authority No. VIII will abate any lead based paints reported in its LRPH units with funds from its Comprehensive Grant Program.
- The Regional Housing Authority will continue its inspection program, which requires that owners of any housing units inspected for Section 8 eligibility, scrape and repaint any surface areas where paint is chipping or peeling. The agency will continue its lead-based paint hazard educational program by providing informative literature to Section 8 families with children less than six years of age.

4. Anti-Poverty

The City of Biloxi recognizes that its actions have significant bearing on economic development and private investment in the community. The City of Biloxi remains proactive in its efforts to encourage economic development and redevelopment in the

community. The City has used such programs as Tax Increment Financing, the Urban Renewal Program, the CDBG Program, and others to revitalize and redevelop areas of Biloxi. This pro-development attitude has helped attract gaming venues, new business and industry, and in effect, created thousands of new jobs.

In addition to capitalizing on redevelopment opportunities and encouraging economic growth to create more jobs, the City will continue to do the following to help reduce the number of poverty level families:

- The City will continue to support programs of the Biloxi Housing Authority to train public housing residents and will support the establishment of such programs as day care and after-hour care, which will provide mothers a chance to seek and maintain gainful employment while children are being cared for by qualified agencies. Also, the City will support the establishment of local job training programs, which focus on jobs for Biloxi residents.
- The City will continue its commitment to maintain existing infrastructure, i.e., water, sewer, streets, etc., to serve business and industry and will continue its policy of upgrading and improving infrastructure to accommodate, encourage, and induce development.
- The City will continue street improvements on major thoroughfares to insure that traffic congestion does not adversely impact economic development efforts.
- The City has used programs such as the Community Development Block Grant Program and others to position the City so that development and redevelopment opportunities will be available.
- The City will continue its policy of encouraging investment and creation of jobs and will, to the maximum extent feasible, encourage investors to employ local residents.
- The City will continue to work with and support local agencies to expand affordable housing options.
- 5. Actions to Develop Institutional Structure and Enhance Coordination Between Public and Private Housing, Health and Social Service Agencies

In an effort to improve institutional structure and enhance coordination, the City of Biloxi will seek to accomplish the following:

- The City will take a pro-active role in implementation of the Consolidated Plan. Social service agencies and housing providers will work to insure that application for HUD programs affected by the Consolidated Plan are consistent with the Plan.
- The adherence to the Citizens Participation Plan will assist the City in its efforts to strengthen the institutional structure within the jurisdiction.

• The City will support coordinated efforts of the social service agencies in addressing the full continuum of care.

K. Program Specific CDBG Requirements

1. Community Development Block Grant Program (CDBG)

The CDBG program is authorized under Title I of the Housing and Community Development Act of 1974, as amended. The primary objective of Title I is the development of viable urban communities. These viable communities are achieved by providing decent housing, a suitable living environment, and expanded economic opportunities.

The City of Biloxi expects to have approximately \$511,204 for the CDBG program for the 2012 program year entitlement and an additional \$146,213 in program income. Eligible CDBG activities must meet one of the program's three national policy objectives listed below:

- Benefit low- and moderate-income persons;
- Aid in preventing or eliminating slums or blight; or
- Address a need with a particular urgency because existing conditions pose a serious and immediate threat to the health or welfare of the community.

This project consists of the installation of storm drains, sanitary sewer lines and water replacement, widened sidewalks and landscaping along approximately ten blocks of Howard Avenue, from Ahern Street eastward to Myrtle Street (i.e., the "second phase"). This section of Howard Avenue is located in a low-to-moderate income area.

L. 2012 HOME (Consortium Allocation)

The City of Biloxi is not an entitlement city under the HOME program, but it is a participant in the Gulfport-Biloxi-Harrison County HOME Consortium. The City expects to receive \$189,225 in HOME funds for the 2012 calendar year. The following is a description of the activities to be funded by the City's 2012 HOME allocation:

Homebuyer Assistance Program (\$189,225)

The City will provide down payment assistance to first-time homebuyers.

M. Monitoring Plan

During each program year, the City will regularly monitor its performance in spending CDBG funds and goals expected to be met through expenditure of the funds. The City will assess its performance at least once annually and will conduct a public hearing to inform the public of its progress in completing activities funded with CDBG funds.

The City of Biloxi's Department of Community Development will utilize existing policy and procedures to monitor the areas of program administration and regulatory compliance. The areas included are as follows:

• Program performance review, which comprises national objectives, eligible activities, contract objectives, scope of work, and contract budget.

- Financial management practices, which comprise the accounting system and internal control;
- Record keeping and reporting practices;
- General management practices; and
- Anti-discrimination compliance.

The following items will be discussed and determined at the annual public hearing:

- Has the City taken steps to ensure that the goals and objectives set forth in its Five-Year Consolidated Plan are being met?
- Have expenditures on approved CDBG projects been made in a timely manner, and has the City complied with all program requirements? If expenditures have not yet been made or projects have fallen behind schedule, what is being done to remedy the problem?
- Have code enforcement officials continued their efforts to ensure all affordable housing projects are up to code?
- How have sub-recipients utilized the funding provided?

Additionally, in an effort to monitor housing and supportive service agencies and to insure that priorities are addressed in a timely manner, the Department of Community Development staff will monitor quarterly each housing and supportive service agency. Any housing or support agency will receive a report on the quarterly monitoring visit and note, among other things, the timeliness of expenditures.

A full inspection of all houses that receive housing funds from the City of Biloxi will be required before disbursement of CDBG funds. Additionally, a city-wide Code Enforcement program will utilize its police powers to assure that residents and businesses are living and working in a safe and sanitary environment.

The Federal Office of Management and Budget (OMB) will assess the effectiveness of the federal program. This requires measuring outcomes as an integral part of receiving CDBG funds. Table 3-A Summary of Specific Annual Objectives and Table 3-B Annual Affordable Housing Completion Goals provide goals and objectives in meeting the goals and objectives of the Consolidated Plan.

The lead agency for the administration and implementation of the projects and activities proposed is the City of Biloxi's Department of Community Development. The City's Community Development has the necessary staff to provide for the appropriate administration of the activities proposed. The Department will work closely with the Department of Administration, the Department of Public Services, the Department of Public Works, the Department of Purchasing, CHDOs, supportive services agencies, and others as appropriate to gain maximum benefit from the CDBG dollars.

N. Citizen Participation

The City of Biloxi encouraged citizen participation throughout the development of the 2012 One-Year Action Plan. As the process is thoroughly detailed in the 2010-2014 Consolidated Plan, specific measures were taken to provide an opportunity for citizens, particularly those of low- and moderate-income, to play a role in the establishment of priorities and selection of activities to be carried out with CDBG funds. TO achieve this, the City accomplished the following:

- Published a Notice of Availability of Information Regarding the City of Biloxi's One-Year Action Plan;
- Published a Notice of Public Hearing for the 2012 One-Year Action Plan;
- Mailed letters to civic organizations and neighborhood associations encouraging them to attend the public hearings;
- Conducted a public hearing to give citizens an opportunity to comment on the housing and non-housing community development needs of the City and the proposed use of CDBG funds;
- Published a Notice of the Availability of a Draft of the 2012 One-Year Action Plan for a 30-day comment period; and
- Posted notices and made the Draft One-Year Action Plan available for public review at the City Hall, Public Library, and the Department of Community Development.

Summary of Citizens Comments

A public hearing to address and discuss the City's 2012 One-Year Action Plan was held on Thursday, September 1, 2011 at 5:30 PM. Minutes from the meeting, as well as the roster, handouts, and the official advertisement placed in the newspaper to announce the hearing can be found in Exhibit V.

CERTIFICATIONS

In accordance with the applicable statutes and the regulations governing the consolidated plan regulations, the jurisdiction certifies that:

Affirmatively Further Fair Housing – The jurisdiction will affirmatively further fair housing, which means it will conduct an analysis of impediments to fair housing choice within the jurisdiction, take appropriate actions to overcome the effects of any impediments identified through that analysis, and maintain records reflecting that analysis and actions in this regard.

Anti-displacement and Relocation Plan – It will comply with the acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as amended, and implementing regulations at 49 CFR 24; and it has in effect and is following a residential anti-displacement and relocation assistance plan required under section 104(d) of the Housing and Community Development Act of 1974, as amended, in connection with any activity assisted with funding under the CDBG or HOME programs.

Drug Free Workplace – It will or will continue to provide a drug-free workplace by:

- 1. Publishing a statement notifying employees that the unlawful manufacture, distribution, dispensing, possession, or use of a controlled substance is prohibited in the grantee's workplace and specifying the actions that will be taken against employees for violation of such prohibition;
- 2. Establishing an ongoing drug-free awareness program to inform employees about
 - (a) The dangers of drug abuse in the workplace;
 - (b) The grantee's policy of maintaining a drug-free workplace;
 - (c) Any available drug counseling, rehabilitation, and employee assistance programs; and
 - (d) The penalties that may be imposed upon employees for drug abuse violations occurring in the workplace;
- 3. Making it a requirement that each employee to be engaged in the performance of the grant be given a copy of the statement required by paragraph 1;
- 4. Notifying the employee in the statement required by paragraph 1 that, as a condition of employment under the grant, the employee will
 - (a) Abide by the terms of the statement; and
 - (b) Notify the employer in writing of his or her conviction for a violation of a criminal drug statute occurring in the workplace no later than five calendar days after such conviction;
- 5. Notifying the agency in writing, within ten calendar days after receiving notice under subparagraph 4(b) from an employee or otherwise receiving actual notice of such conviction. Employers of convicted employees must provide notice, including position title, to every grant officer or other designee on whose grant activity the convicted employee was working, unless the Federal agency has designated a central point for the receipt of such notices. Notice shall include the identification number(s) of each affected grant;
- 6. Taking one of the following actions, within 30 calendar days of receiving notice under subparagraph 4(b), with respect to any employee who is so convicted –

- (a) Taking appropriate personnel action against such an employee, up to and including termination, consistent with the requirements of the Rehabilitation Act of 1973, as amended; or

FACT SHEET

Summary

The 2012 One-Year Action Plan, a component of the City of Biloxi's Five-Year (2010-2014) Consolidated Plan, is a coordinated effort of the City of Biloxi, other local governments, the Biloxi Housing Authority, the MS Regional Housing Authority, social service agencies, private groups, non-profit organizations, and other interested residents, is a required document of the U.S. Department of Housing and Urban Development (HUD). The Consolidated Plan combines the requirements of the following four HUD Community Planning and Development formula grants:

- 1. Community Development Block Grant (CDBG)
- 2. HOME Investment Partnership (HOME)
- 3. Emergency Shelter Grant
- 4. Housing Opportunities for Persons with AIDS (HOPWA)

The three broad goals of the four HUD Community Planning and Development Programs are as follows:

- 1. To provide decent housing;
- 2. To provide suitable living environment; and
- 3. To expand economic opportunities

Biloxi is an entitlement city under the rules of HUD's Community Development Block Grant Program (CDBG) and as such, receives an annual allocation of funding (program year \$511,204) from CDBG. This annual allocation plus program income, \$146,213±, gives the City a total of approximately \$657,417± for CDBG projects proposed in the 2012 Action Plan. Additionally, as a participant in the HOME program, the City of Biloxi receives an annual HOME allocation (program year 2012, \$189,225±). Biloxi does not receive an annual allocation of funds under the HOPWA or ESG programs but must work with other agencies to compete for funding from these programs.

National Objectives of Community Development Block Grant Program

- 1. Projects that principally benefit low and moderate income persons. A project or activity will be considered to principally benefit low and moderate income persons if it is designed to meet the identified needs of low and moderate income persons.
- 2. Projects that prevent or eliminate slums or blight.
- 3. Projects designed to meet needs having a particular urgency.

*PROJECTS MUST MEET AT LEAST ONE OR MORE OF THE ABOVE NATIONAL OBJECTIVES.

Basic Eligible Activities for Community Development Block Grant

- 1. Acquisition of property for public purpose.
- 2. Public facilities infrastructure improvements including water improvements, wastewater improvements, solid waste improvements, streets and storm drainage improvements, etc.
- 3. Clearance, demolition and removal of buildings to other sites.

- 4. Urgent needs and emergency grants to address community development needs having particular urgency because existing conditions pose a serious and immediate threat to the health or welfare of the community.
- 5. Interim assistance requiring immediate action such as street improvements to alleviate emergency conditions.
- 6. Payment of non-federal share required in connection with a federal grant-in-aid program undertaken as part of CDBG activities.
- 7. Relocation payment and assistance for permanently or temporarily displaced individuals, families, businesses, and organizations, and reimbursement for loss of rental income incurred in holding housing units to be utilized by relocation of individuals and families displaced by program activities.
- 8. Acquisition, construction of rehab of privately owned utilities.
- 9. Construction of housing such as eligible rehabilitation, code enforcement, renovation of closed school buildings.
- 10. Special economic development activities.

HOME Investment Partnerships Program (HOME)

The HOME Program was created by the National Affordable Housing Act of 1990 (NAHA) and has been amended several times by subsequent legislation.

- 1. The intent of the HOME program is to:
 - a. Provide decent affordable housing to lower income households;
 - b. Expand the capacity of non-profit housing providers;
 - c. Strengthen the ability of state and local governments to provide housing; and
 - d. Leverage private sector participation.
- 2. Eligible HOME Activities:
 - a. Homeowner: Rehabilitation or construction of owner-occupied housing.
 - b. Homebuyer Activities: acquisition, rehabilitation, new construction, and/or down payment assistance that lead to homeownership.
 - c. Rental Housing: acquisition, rehabilitation or construction of affordable rental housing.
 - d. Tenant Based Rental Housing: assistance for rent security deposits and under certain conditions, utility deposits.
 - e. Community Housing Development Organizations (CHDOs): The City must reserve 15% of its annual allocation for activities undertaken by qualified CHDOs.
 - f. Planning and Administration Costs: The City must use up to 10% of their annual allocation for eligible and reasonable planning and administration costs.

The Community Development Department is responsible for overseeing the orderly growth and development of the City of Biloxi, which has been a daunting task in the past several years because of the tremendous economic boost the city has experienced with casino gaming and even more since since Aug. 29, 2005, when Hurricane Katrina destroyed 6,000 homes and businesses in Biloxi.

One of the most important tools of the Community Development Department is the Planning Commission, a panel of citizens appointed by the Mayor and confirmed by the City Council. The commission reviews zoning matters on a regular basis, and makes recommendations to the Mayor and City Council. In some areas, where construction is planned in historic areas of the city, plans also are reviewed by an Architectural and Historical Review Commission.

When construction is planned, a team of veteran inspectors reviews and oversees all aspects of the process for both residential and commercial projects.

The Community Development Department is also responsible for overseeing the administration of all federal and state programs, taxing and licensing businesses, and operating several city-owned museums and historic properties.

In recent years, the city has placed more emphasis on the appearance of streets and neighborhoods by strictly enforcing city codes involving appearance of property. This process is overseen by the department's Code Enforcement Division, which works closely with the Community Court division of the Legal Department.

The Community Development Department is currently in the process of updating the city's zoning and land-use ordinances. Although the ordinances have been amended numerous times in the past several years to help facilitate the tremendous growth of the city, the laws have not been completely overhauled since they were adopted decades ago.

There are 26 full time employees and 10 part time employees in the Community Development Department, as well as seven contract employees. The divisions of this department are: Federal-State Programs; Planning and Zoning; Building and Code Enforcement; Tax and Licensing; Museums and Cultural Affairs; and Economic Development.
