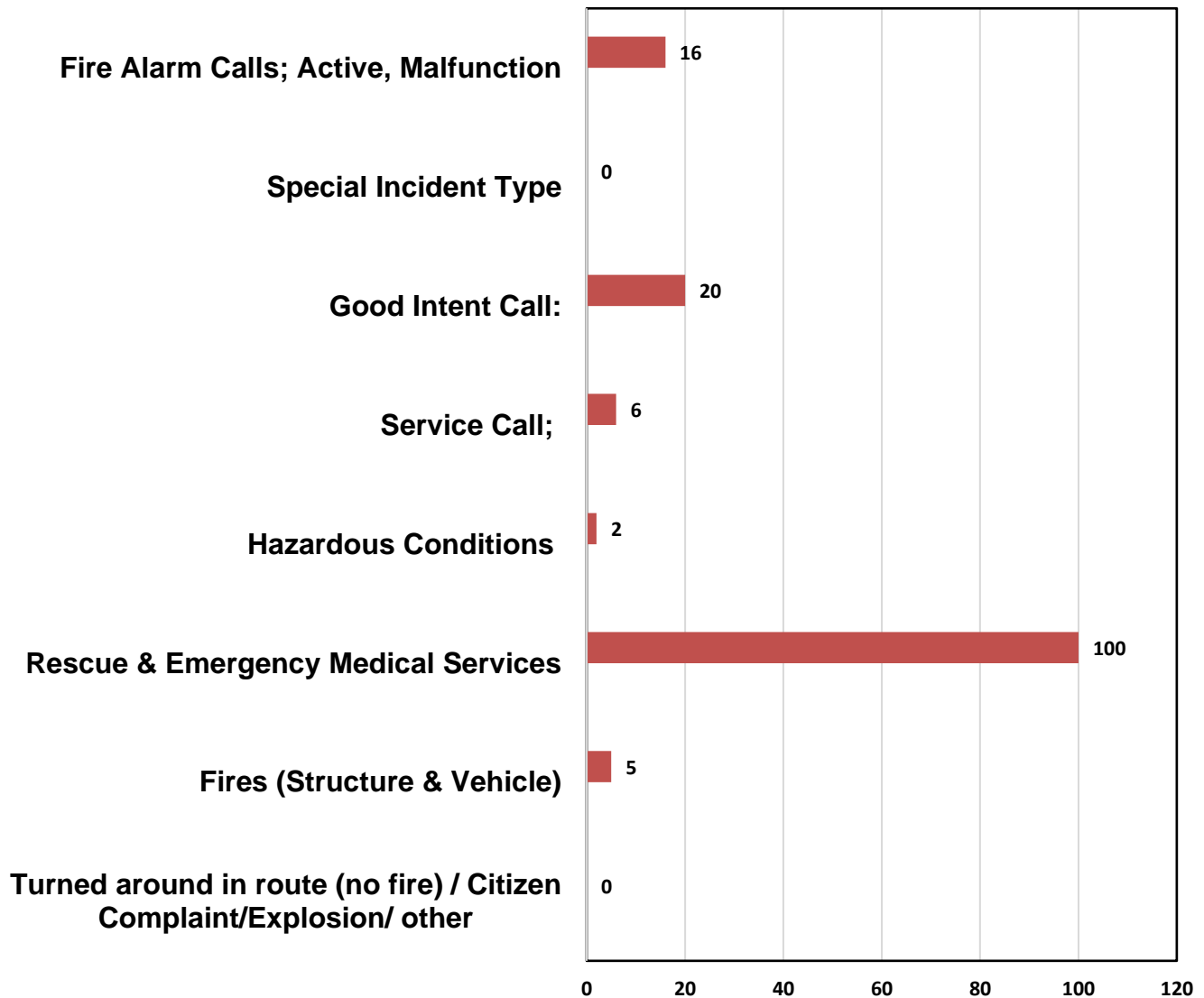

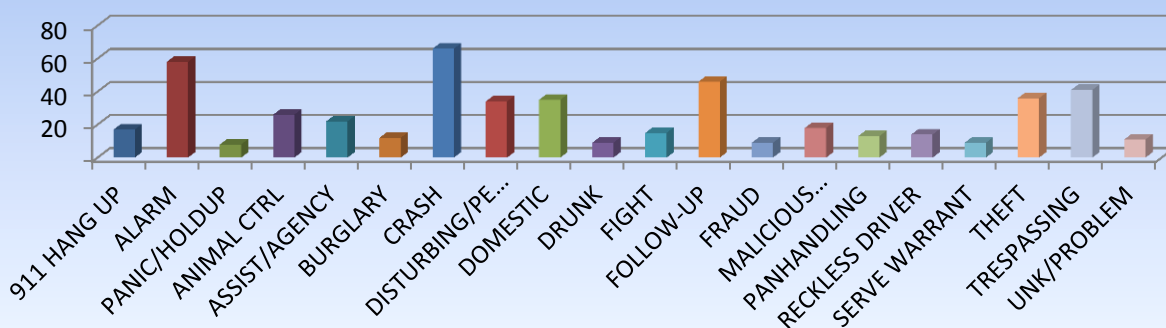

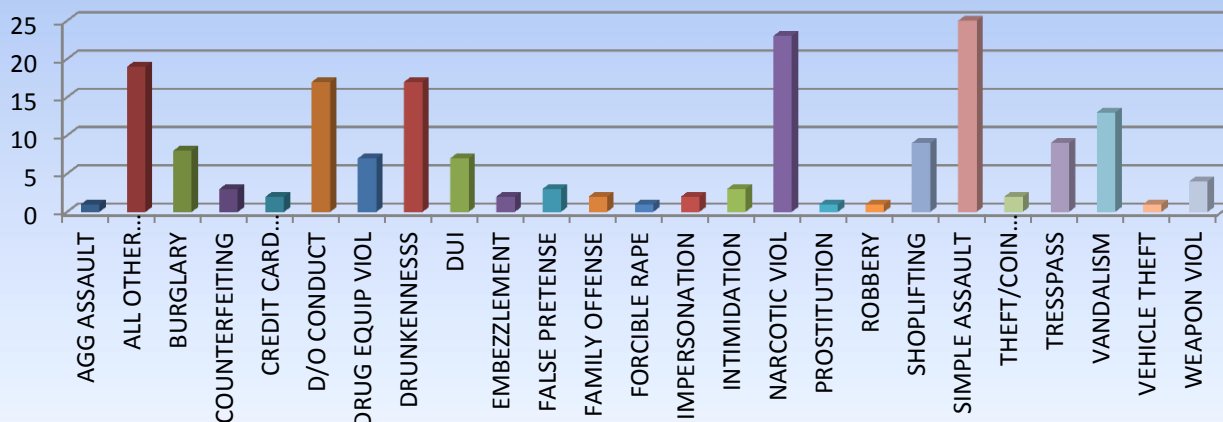

Last week in Community Development, the City Council approved an application to change the zoning for property located at 130 Pine Grove Avenue, from RM-30, High Density Multi-Family Residential to CB, Community Business. The change was necessary to expand the area for the Gulf Beach RV Park which is currently under construction on the adjacent property.

Also last week, the Architectural Historical Review Commission approved architectural designs for a new single family house to be constructed at 368 Meaut Street, and for a second free standing sign for the Hyatt Place Hotel at 1150 Beach Boulevard.

Last week, construction was completed, and a Certificate of Occupancy was issued for the Blind Tiger Restaurant located at 265 Beach Boulevard. The new restaurant opened on Friday. Build out plans were submitted last week for Tuesday Morning. The new retail tenant will be located in Edgewater Village next to the new Hibbett Sports.

This week, the DRC will review site plans for the rebuilding of the Gulf Coast Rescue Mission on Mission Lane, the new Waffle House to be located at 618 Beach Boulevard, and an application for a proposed expansion of the Old Biloxi Cemetery.
