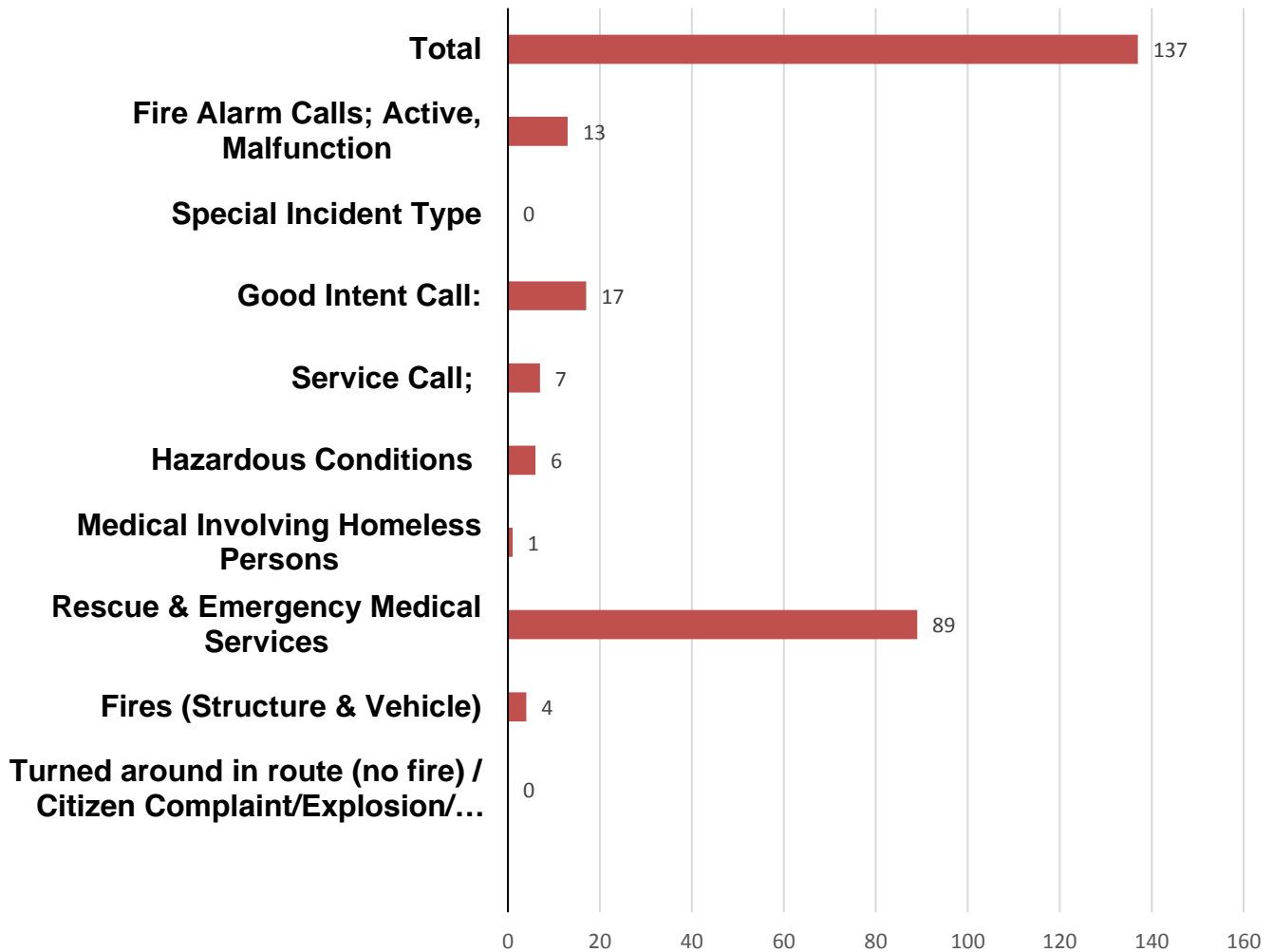

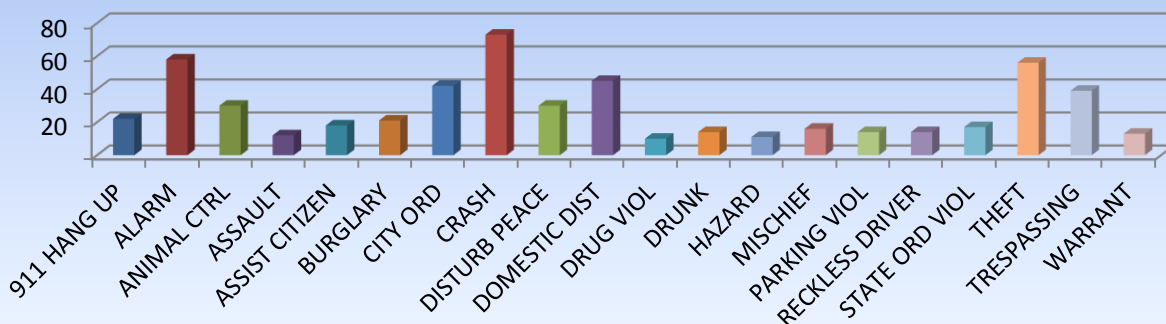

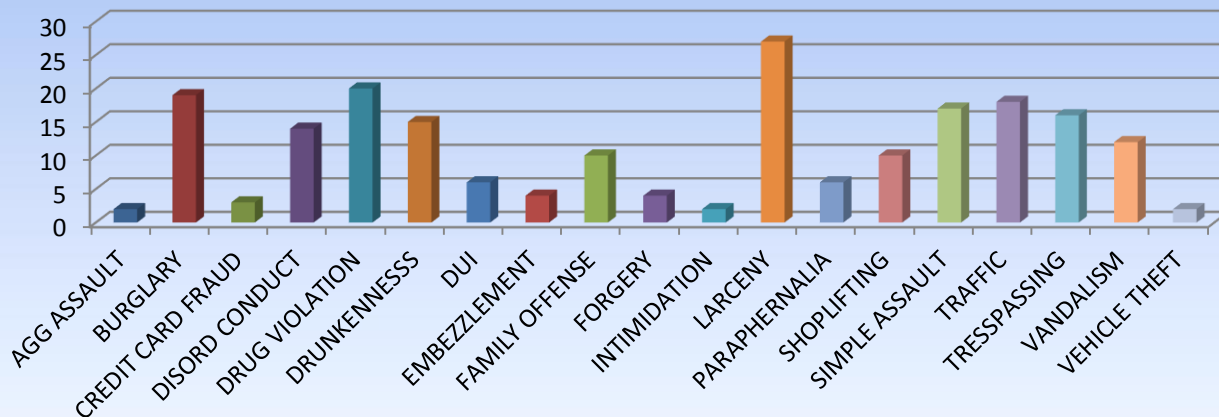

Last week in Community Development, the final certificate of occupancy was issued for the new Citizens Bank located at 1830 Popp's Ferry Road. A temporary certificate of occupancy was issued for the new Biloxi Jr. High School, as construction crews continue to complete punch list items.
