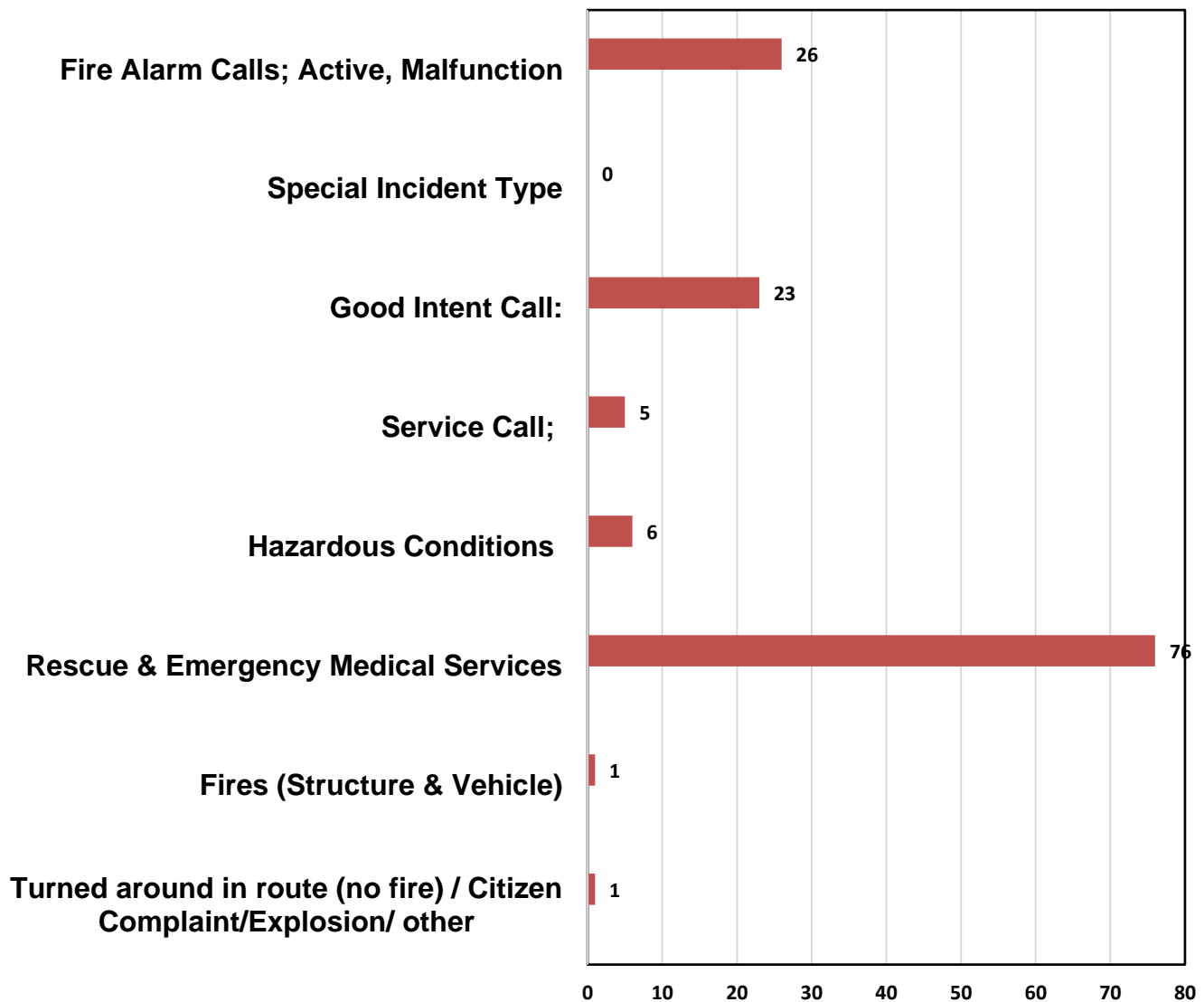

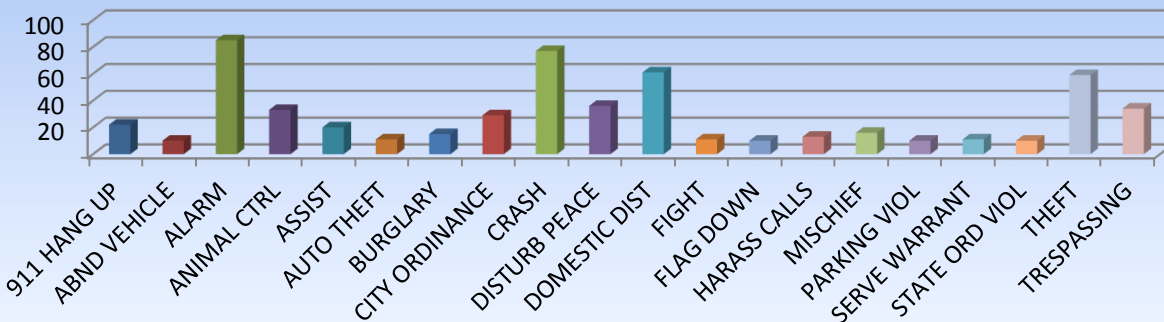

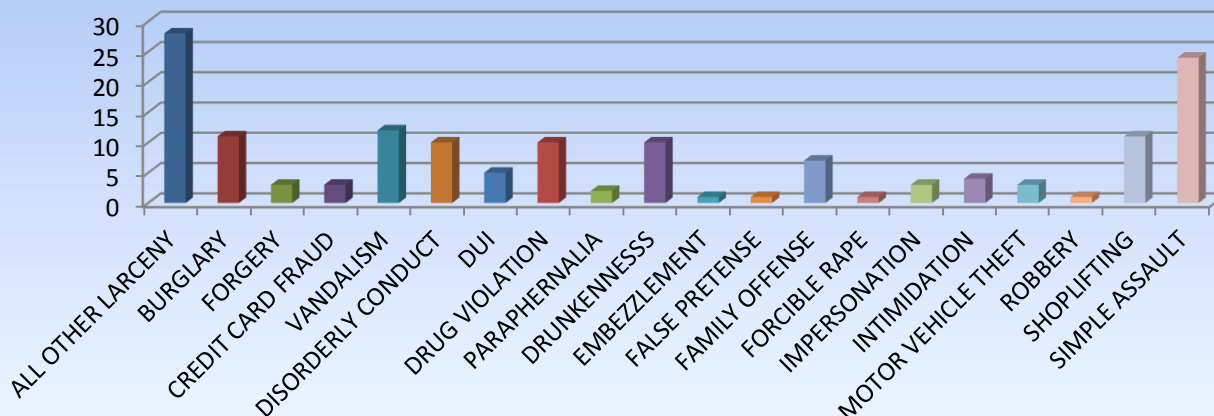

Last week in Community Development, repair work began on the Oak Street Pier next to the Blind Tiger Restaurant. Weather permitting; the decking should be completed sometime this week. A temporary certificate of occupancy was issued for the Gulf Beach RV Resort located at 2428-B Beach Boulevard.

Also last week, building permits were issued for four new single family houses, and sales tax revenues for the month of May were \$1,121,247.89, which is a \$79,915.02 increase from May 2016.
