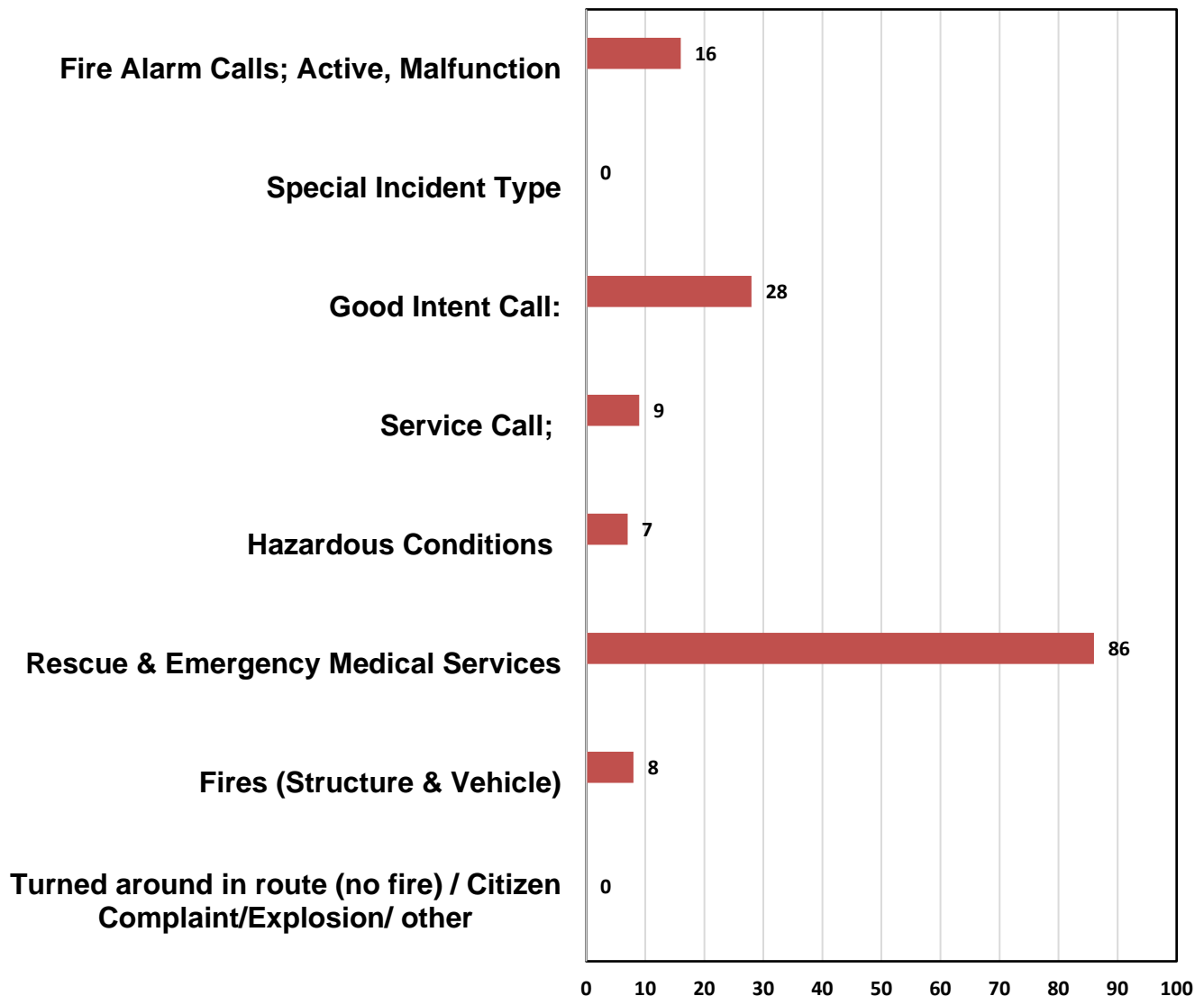

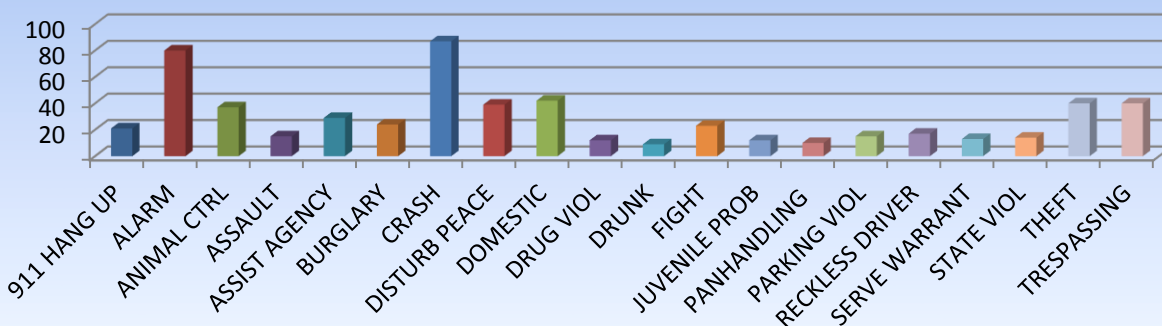

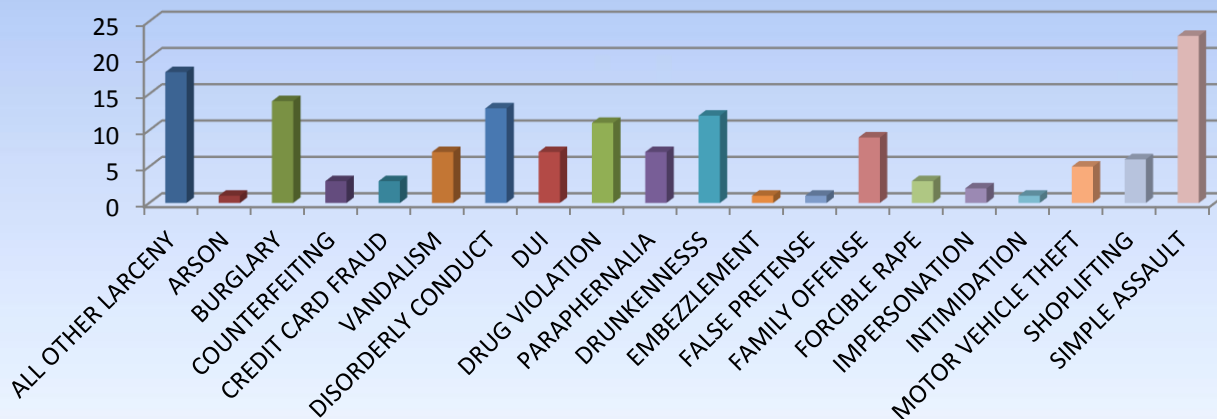

Last week, Community Development saw the openings of Bacchus in Biloxi, located at 1775 Beach Blvd., and Tuesday Morning, located in the Edgewater Village Shopping Center. Building Permits were issued for repairs to the Oak Street Pier located at 277-FB Beach Boulevard next to the Blind Tiger Restaurant. The repairs will begin immediately and should be completed in the next few weeks.

Also last week, the final subdivision plat for sub-phase one of the Hidden Springs Development was approved and filed in the Harrison County Courthouse. Building permits can now be issued for new single family houses.

Building construction plans have been submitted for the new Salt Grass Restaurant to be located on the north side of Beach Boulevard, across from the Golden Nugget Casino Resort. Plans review should be completed by next week.

Site work has begun on the La Quinta Inn and Suites to be located at 950 Beach Boulevard. The new hotel will have 66 suites, and a swimming pool.
