





Last week in Community Development, site work began on two new projects on Beach Boulevard: the Salt Grass Restaurant which will be located on Beach Boulevard, across from the Golden Nugget, and the Finish Line Go Cart Race Track which will be located on the former Slippery Sam's Property. A final certificate of occupancy was issued last week for the new Dunkin' Donuts on Cedar Lake Road next to Taco Bell. Also, building Permits were issued for two new single family houses, and a new metal building at 1937 Pass Road.

Several projects that are nearing completion include: Camping World at the corner of I-10 and Oaklawn Road, the South Port Line Restaurant and the addition to Southern Supply, both on Howard Avenue, also Sunbelt Lighting at I-10 and Cedar Lake Road.

- Small Craft Boat Launch NTP for after SKA tournament
- Snyder Center Roof can't verify location of leaks, until then leery about getting a bid, roof may still be under warranty if Mandals can see it when its looking
- Tennis Court Repairs Waiting for next budget year
- West Biloxi Boardwalk Corps Permits is approved pending necessary signatures
- Wetzel Subdivision One lot left to grade
- Woolmarket Master Plan Expect final plan by end of October for our review
- Woolmarket Drainage ready to start easement acquisition, started the environmental process
- Woolmarket water line on the shelf for now
