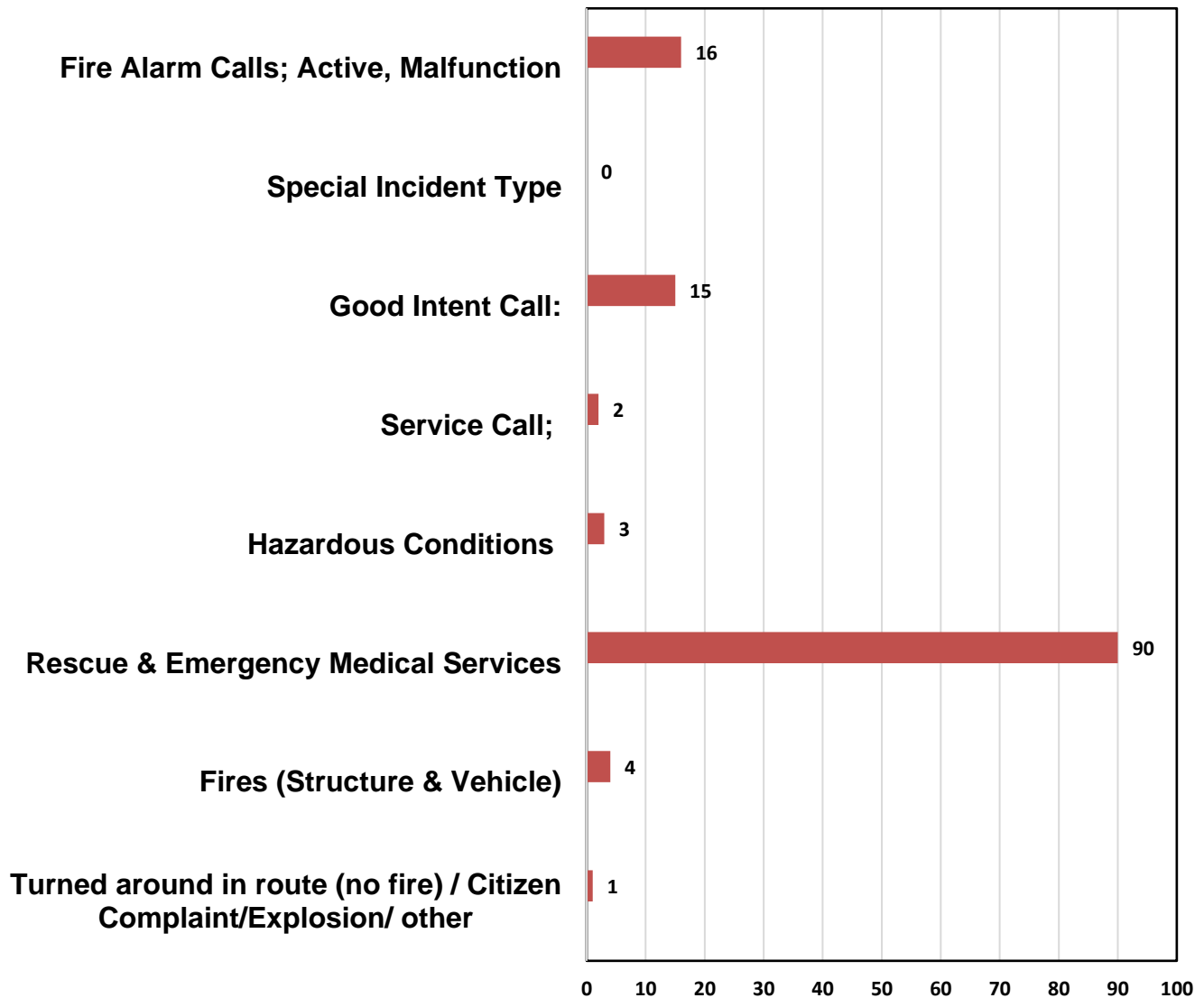

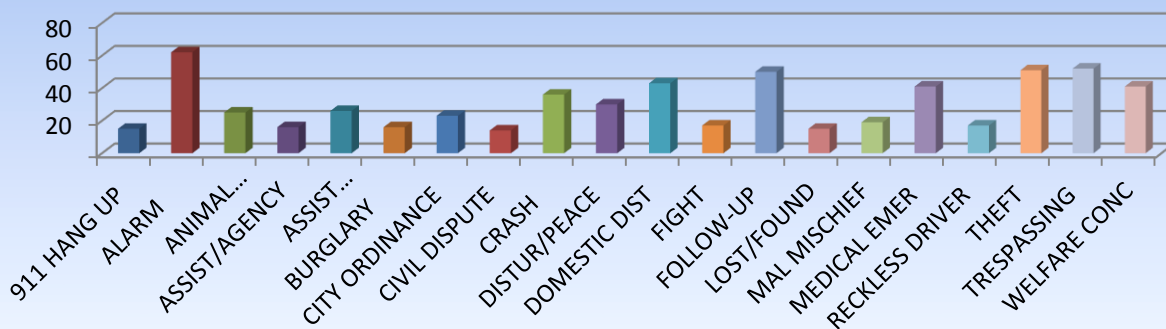

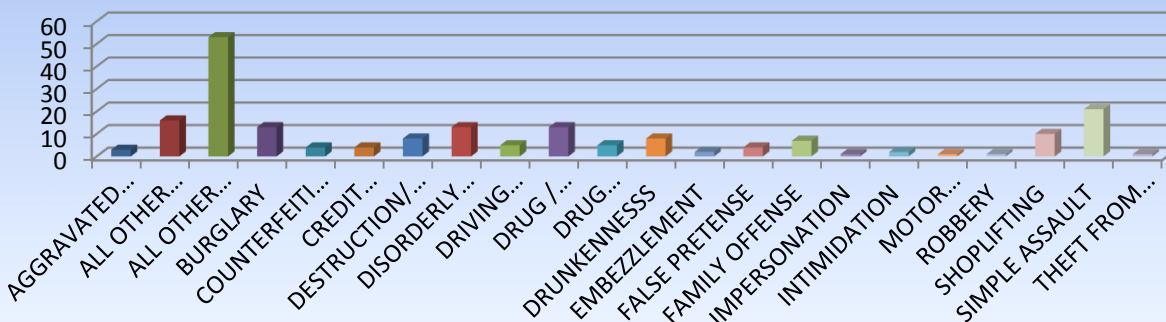

Community Development Activity Report, Aug. 22, 2016

Last week in Community Development, the Planning Commission voted 8-5, to approve variances for both, lot density, and landscape buffering, to allow for a 100 unit Hilton Garden Inn Hotel to be constructed at 648 Beach Boulevard. The proposed site is the former location of the Biloxi Specialty Hospital. Building plans will now be submitted for review and approval. The commission also approved a map amendment application for property located at 2432/2436 Pass Rd., to change the current zoning from LB-Limited Business to NB-Neighborhood Business to allow retail sales. This recommendation will now go before the City Council for final consideration.

There were 54 building permits issued last week with a construction valuation of \$667,450. Certificates of occupancy were issued for 12 structures, and licenses were issued for 10 new businesses and 45 renewals. Building plans were submitted for 2 new single family houses, and build out plans were submitted for a new City Gear retail store to be located in Edgewater Mall. Building inspectors performed 91 inspections, and code enforcement officers opened 110 cases and resolved 153.

The building permits issued included the new Marshall's Funeral Home to be located at 234-A Veterans Ave., a new commercial office building at 13010 Kayleigh Cove, and one new single family house. Also, the foundation permit has been released for the new Blind Tiger Restaurant on Beach Boulevard. Monthly sales tax revenues (July) topped one million dollars for the sixth time this year (2016).

This week, the Development Review Committee is expected to sign off on the Popp's Ferry Causeway Park, and the Architectural/Historical Review Commission will conduct a public hearing to consider the revised building design for the proposed La Quinta Inn & Suites to be located at Beach Boulevard and Hopkins.
