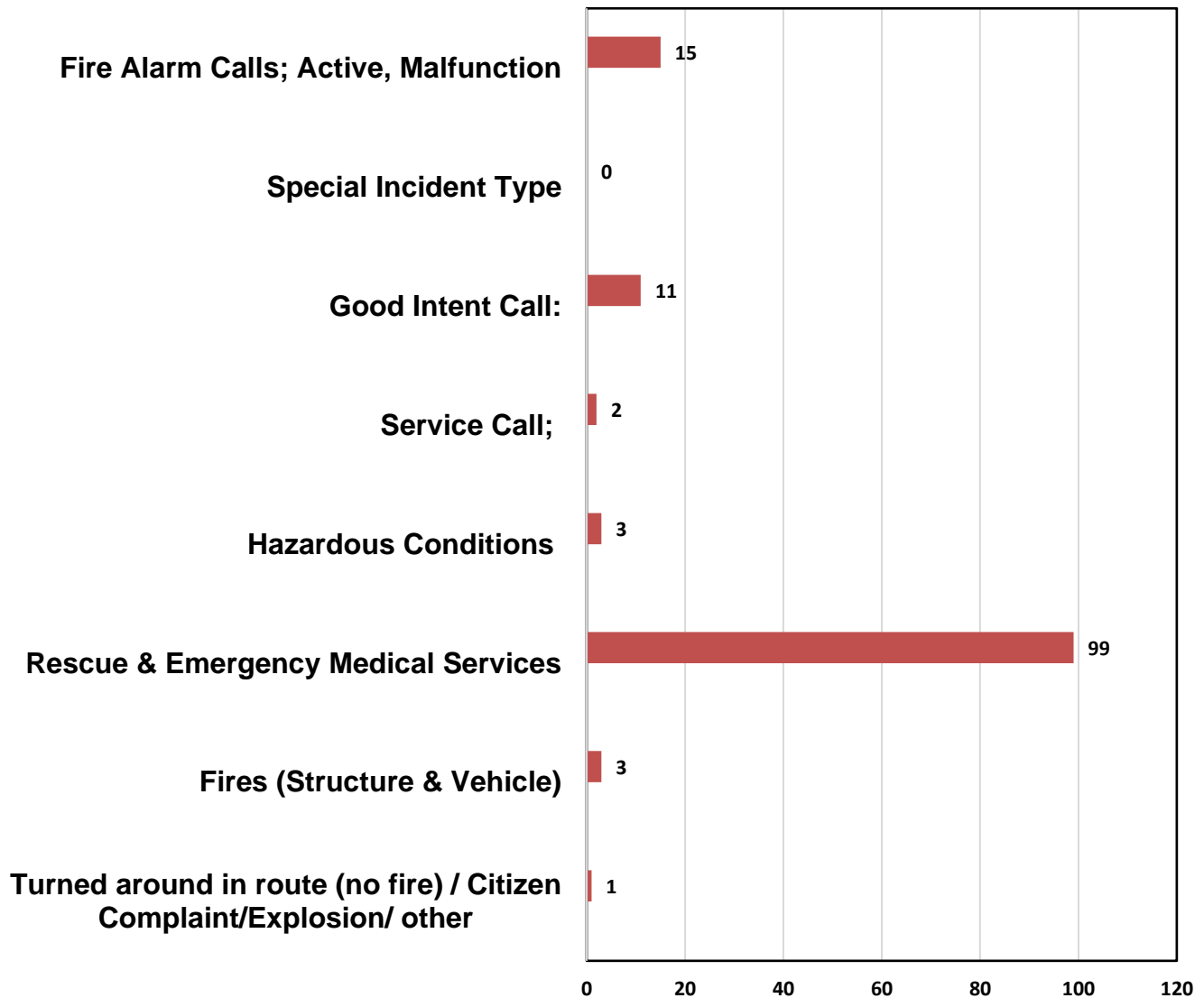

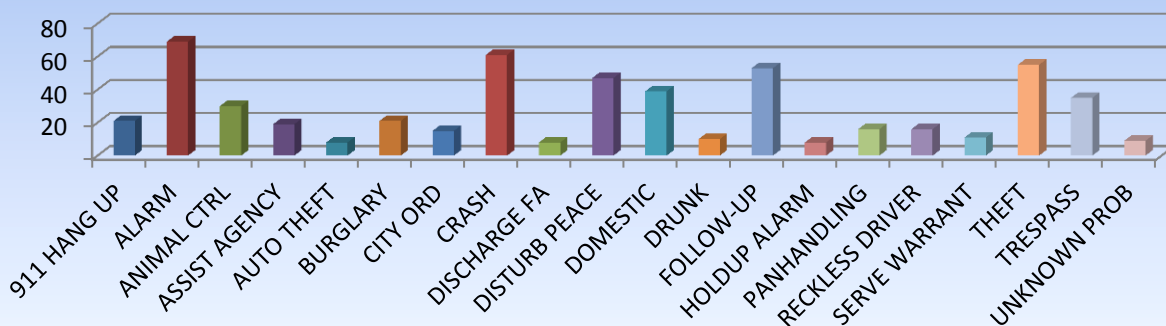

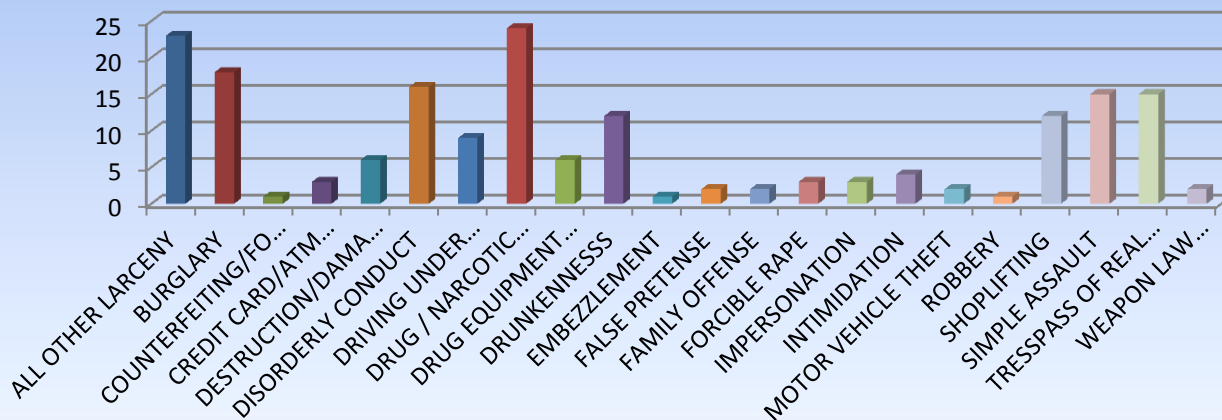

Last week in Community Development, the building department issued a building permit for the new La Quinta Inn & Suites to be located at the corner of Hopkins and Beach Boulevards. The proposed \$5.5 million hotel will be four stories in height and have 67 suites. Construction is scheduled to begin in mid-January.

Also last week, the Development Review Committee conducted an initial review of the site plan for the proposed SaltGrass Restaurant to be located at the northeast corner of Beach Boulevard and Myrtle Street. The proposed 9,400 sq. ft. elevated steakhouse will be positioned to save as many of the existing trees as possible. A public hearing before the Architectural and Historical Review Commission is scheduled for Jan. 12, 2017, for the Tree Commission on Jan. 19, 2017 and a second presentation to the DRC will be required prior to permitting.

Two cases that were scheduled to go before the Planning Commission at the meeting last Thursday were continued until future dates. The rezoning application for the recently annexed Pitcher Point Development in north Biloxi will be heard at the meeting scheduled for Jan. 5, 2017. The rezoning application for Williams Recycling located at 11606 Old Highway 67 was tabled and will be re-advertised sometime in 2017.

Sales tax revenues for November 2016 were \$996,134, which is an increase of \$52,091 over November 2015, and a year-to-date increase of \$241,974.
