





## **Community Development Update 07/11/2016**

Last week in Community Development, the City Council conducted the first reading of an application from Harrah's Casino Resort, for a Master Plan Update, to allow construction of the Blind Tiger Restaurant. The Council also conducted the first reading of an application, for property located at 12046 Lorraine Road, to change the zoning from RS-10, to NB, to allow a riverside café/bar. The second readings for both of these cases will be conducted at the Council meeting on July 19. Also at the meeting last week, the Council voted 6-0 to approve an application for Short-Term Rental for an existing duplex located at 265/285 Comfort Place.

On Thursday, the Biloxi Planning Commission voted unanimously to approve an application to create a Health Care Industry Overlay District. The Overlay District, if approved by the City Council, will provide a number of State tax, and other financial incentives for medical industry related businesses locating within a 5-mile radius of the existing Merit Health Hospital in Biloxi. The Planning Commission recommendation will now go before the City Council for final consideration.

The Development Review Committee, on Wednesday, conducted an initial review of a site plan proposal from U-Haul to convert the former Walmart structure on Pass Road into a retail, and interior storage facility for boats, recreational vehicles, and individual storage units. The proposal would occupy the entire site, and the 118 thousand sq. ft. structure.

37 building permits were issued last week with a construction valuation of \$366,975. Certificates of occupancy were issued for two structures, and a business license was issued for one new business. Building plans were submitted for a renovation project at Hard Rock Casino to create a noodle bar, an AT&T Retail Store at Edgewater Mall, and eight new single family houses. Building Inspectors performed 63 inspections, and code enforcement officers opened 142 cases and resolved 180.
