
Incident Type Percentage Graph





Community Development update for April 11-18, 2016

This week in community development, building plan reviews have been completed for the new Biloxi Junior High School on Jam Lane, and for the new Patio 44 Restaurant to be located downtown. Both projects should be ready for permitting sometime later this week. Building plans were also submitted last week for 8 new single family houses.

The site plan for the Blind Tiger was reviewed by the Development Review Committee last Wednesday. Recommendations for revisions, made by the committee members, have already been completed, and the plan has been resubmitted for final review this week. Site plans have been submitted to DRC this week for Sunbelt Lighting to be located on Cedar Lake Road, south of Love's Truck Stop, and for the new "Woolmarket Pharmacy" to be located on Shriner's Boulevard. The planning commission will hold a public hearing this Thursday to consider an application to expand Advanced Collision at 1746 Popp's Ferry Road.

32 building permits and 3 certificates of occupancy were issued last week. Business Licenses were issued for 3 new businesses. Building Inspectors performed 62 inspections, and code enforcement officers opened 238 cases and resolved 261. Sales tax revenues for last month topped \$1 million for the first time in March since 2005. The \$1,039,988 monthly total was also an increase of \$99,944 over March 2015.
