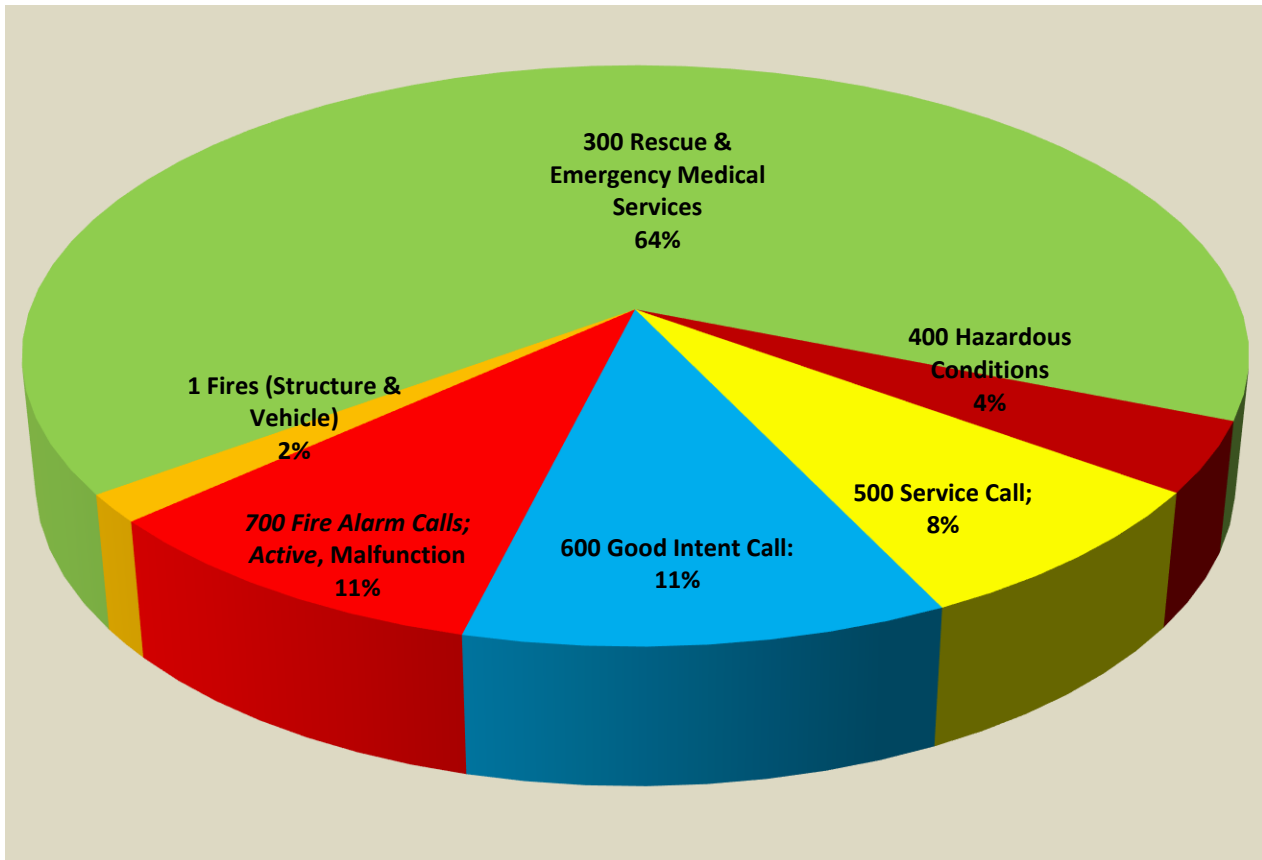

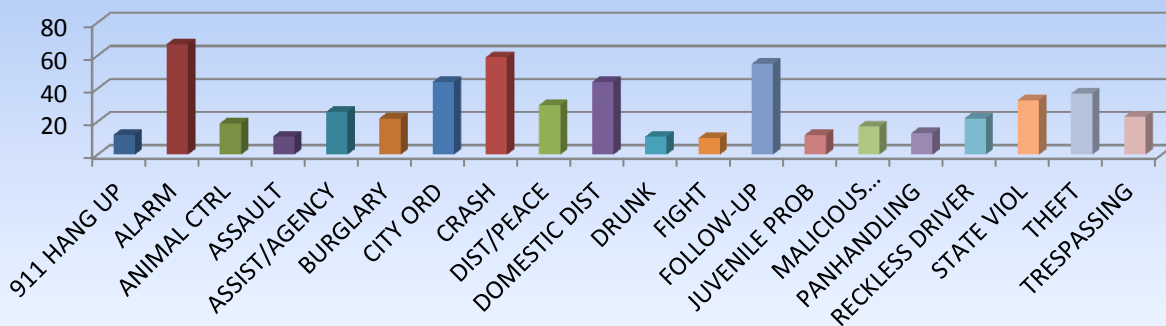

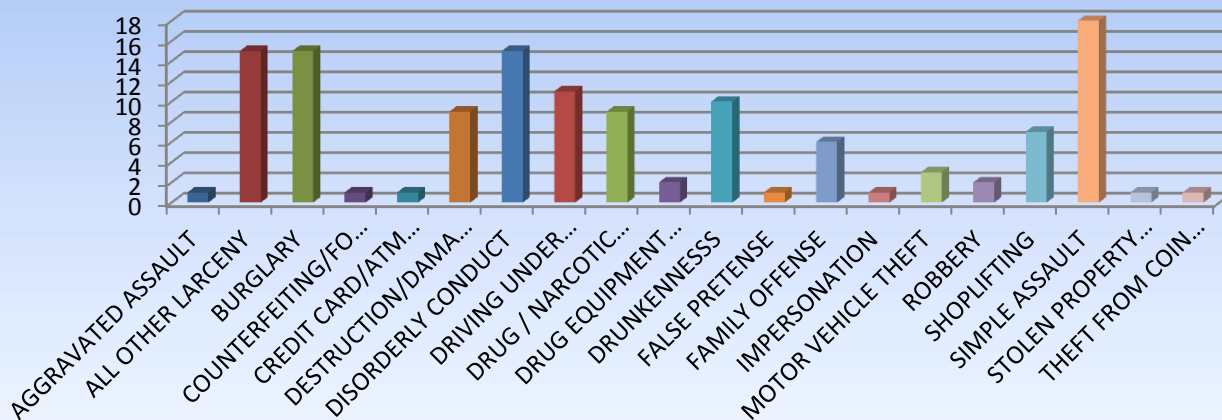

Community Development Update 5/16/2016

Last week in Community Development, the DRC approved a site plan for the addition of 16 units to the Briarfield Apartments located at 169 Briarfield Avenue. Also, the DRC agreed to allow the owners of property located at 12046 Lorraine Road to proceed to the Planning Commission for a public hearing, to request a change in zoning from RS-10 Single Family Residential to NB-Neighborhood Business. The purpose of the change is convert the existing structure on the property, into a riverside café/bar. This week the DRC is scheduled to approve the site plan for the proposed Woolmarket Pharmacy to be located at 13034 Shriners Boulevard.

Also last week, the building department issued 63 permits, with a construction valuation of \$1.2 million dollars, and 9 certificates of occupancy. Permits were issued for the new Buckle Store in Edgewater Mall, and 5 new single family houses. Business licenses were Issued for 4 new businesses and 3 renewals. Building inspectors performed 160 building inspections, and code enforcement officers opened 348 cases and resolved 249.
