





## **Projects**

- Allenwood Subdivision (fork at John Lee Rd.) Work on hold until lots under contract;
- Bayview Avenue Boardwalk Permits are approved; Revised plan estimated cost \$2.8 million; ready to move forward with design contract when funding is available;
- Bayview Ave. Bridge Replacement (State-Aid Project) Waterline has been removed from bridge; construction should be started in the next few weeks
- Belle La Vie Parkway 90% plans have been submitted, met with DE to discuss ways to reduce costs; discussed potential issues with wetlands – worst case scenario we may be 8-10 months getting a wetlands permit
- Building Façade Program Working on grant applications and requirements
- Campbell Dr. Drainage first phase for culvert and ditch cleaning PO on council agenda in April
- Canaan Fishing Dock Improvements received DMR & Corps permits, ready to move forward with design contract when funding is available
- Cedar Lake Bridge Repairs (Const. Funding 2021) Have executed MOA; need to get DE under contract
- Circle Park Upgrades working up preliminary site plan for approval

- Citywide Street Paving
  - Woodland Park getting PO for mill/overlay and seal coating
- CSX Crossing Closure (CDBG Funded) 90% submittal submitted to CSX and comment received back, have conference call with CSX today regarding the drainage ditches; surveys and appraisals should be done by mid February to begin acquisition; *March 1<sup>st</sup> NS emailed CSX asking about status of drainage review, responding pending.*
- Dukate Street Paving paving will be scheduled as soon as heavy equipment and dumpster is off the roadway
- East Biloxi Public Access & Living Shoreline Task D (South of Bridge to Point Cadet Marina) and Task E (North of Bridge to Palace); DCD Construction awarded Alt. A & B for a total of \$1.8M; NTP Oct. 8, 2018; Completion Aug. 9, 2019; bulkhead work complete, boardwalk cap being installed; waiting on change order to add shade structures and benches, are going to start working on signage
- East Biloxi Boardwalk (Small Craft to Kuhn St.) Pending design contract
- Eagle Point Park Preliminary surveying expected to be complete this week;
  60% plans by mid-April; final plans ready to bid by mid-May
- Ellzey Place II final plat on this weeks council agenda; Lane Construction submitted a bond for the sidewalk repairs
- Ellzey Place III (Medical Park Drive Extension) Met with DE, outside agency approvals and wetlands permitting are both pending
- Fire Station No. 7 NTP August 15, 2018, Starks Construction; foundation work complete; structure up; CMU walls are up; roof nearing completion
- Fire Station No. 10 Completion Date: 6/28/2019; Contractor: JW Puckett \$2.35 million; foundation work complete & waterline along old Hwy 67 underway; CMU walls are up, roof work starting next
- Glen Eagle Subdivision (formerly Jordan Subdivision) waiting for dry weather to do soil cement
- Henry Beck Park Restroom Have elevation required, working on plans/specs
- Hiller Park Pond Cleaning permit application submitted to DMR; need SAV study
- Hiller Park Trail design on-going, plan to have out to bid by end of May

- Howard Avenue Gulf Breeze Landscaping, only remaining items brick in the crosswalks at Bradford O'Keefe and Dukate/MLK/Howard Intersection.
- Keesler Gate Outside Property acquisitions continuing with only 8 just compensations remaining, and approx. 15 out of 36 acquired.
- Keesler Gate Inside Awarded to Necaise Brothers Const. \$4.8 million, NTP 5/21/2018; 540 Calendar Days; Completion Date 11/12/2019; curb & gutter underway; only remaining items are security fencing, gates, asphalt and striping, Necaise is currently ahead of schedule with planned completion by end of July, we will be adding the work at Forrest Avenue into this project; *need to coordinate burning of house at Division & Forrest with Fire Department*
- Main Street Railroad Crossing Upgrades (MDOT Funding 2020) received executed MOU from MDOT; requested contract from NS to finalize the project and bring up to MDOT standards
- Malpass Landing/Watersview pipe cleaning is complete and regrading of rear yards should start this week
- MGM Stadium Capital Maintenance Developed a list of potential capital maintenance items; dugout steps and hand rail painting being completed by PW; elevator flooring done, scoreboard done, seat covers being worked on, and field lights done
- Moran Alley Contractor should be finished by end of April
- Nature's Trail sewer complete, waterline delayed due to rain
- Natatorium Dehumidifier Getting quotes
- Old Brick House Sidewalk Will have quotes by end of April
- Pine Grove Drainage Getting a PO for video pipes, once we know the pipe condition, we will get a survey; *expecting quote by end of March*
- Pedestrian Crosswalk @ Harbor –Dan Hensarling, Inc. \$2.4M; NTP October 8, 2018; work on-going
- Pedestrian Crosswalk @ MGM warranty and closeout documents still pending
- Point Cadet Marina Electrical Upgrades Full electrical upgrade of entire harbor; Awarded to DNP \$228,360; work has begun and will be completed by end of May

- Point Cadet Marina Improvements (West) #1024 Old Task "A" & "C"; currently on hold
- Point Cadet Marina Pile Repairs Bids opened March 27<sup>th</sup>, will be on the April 16<sup>th</sup> council agenda for approval
- Point Cadet Waterfront (Boardwalk) Design pending final scope of work
- Popps Ferry Extension #913 Coliseum has the draft MOU for Board approval;
  33 parcels to acquire; surveys and appraisals are underway; *met with NS to discuss applying for a Build Grant, they are working me up a cost to do that*
- Popps Ferry Bridge Submarine Cable new generator and switch in place and operational
- Popps Ferry Bridge & Approaches pending EA approval; met with BMA draft EA is at MDOT for preliminary approval once receive comments back final EA will go to MDOT/FHWA for approval; once approval is granted the City can petition MDOT to start ROW Acquisition
- Popps Ferry Causeway Need to schedule meeting to kick off meeting with the landscape contractor
- Post Office Build-out On Hold
- Port Commission Roof Repairs Design contract was on the Feb. 19<sup>th</sup> council agenda
- Public Excursion Pier South of Pine/Cedar #1030 Old Task "B" on hold
- Public Safety Center Roof Leaks opened bids March 27<sup>th</sup>; construction contract should be on April 16<sup>th</sup> council agenda
- Repair/Replace Contract Specs being developed
- Saenger Theater Phase I & II Fly Tower & Exterior open bids on April 10<sup>th</sup>; pre-bid meeting on Wed. March 27<sup>th</sup> at the Saenger; PW should begin demo of concrete this week; have quote for asbestos curtain, will be PO this week
- Saenger Theater Phase III Interior start design in summer 2019, bid for construction by beginning of 2020
