As mentioned in our letter of September 9, 2019, the northern section of Debuys Road (north from Pass Road to Runnymeade) is badly in need of repair and new pavement. Debuys Road is the boundary of our two cities. Additionally, Debuys road leads to the entrance to the Gulf Coast Community College (Jeff Davis Campus) which serves the students of both our cities as well as Harrison County. I'm suggesting that we discuss a joint project to repair and repave this heavily travelled roadway.

Warren Paving has provided an estimate of \$75,205.50 to mill and repave Debuys Road from Pass Road to Runnymeade. Biloxi would be willing to manage this project if the City of Gulfport and Harrison County were to assist with each providing a one-third (1/3) share of the cost.
