You will also be required to provide an affidavit of ownership or ownership documentation (when applicable) in order to claim the item. Failure to meet any of the aforementioned requirements will disqualify you from being able to claim the item in question. **Upon contacting the Crime Scene/Evidence Unit you must provide the eight digit case number and the EX# number listed on the attached sheet and the date of the public notice. DO NOT take the attached sheet.***

Any false claiming of items will result in charges being brought against the person(s) proven to have illegally made claims to the property.
