Failure to meet any of the aforementioned requirements will disqualify you from being able to claim the item in question. **Upon contacting the Crime Scene/Evidence Unit you must provide the eight digit case number and the EX# number listed on the attached sheet and the date of the public notice. DO NOT take the attached sheet.***

Any false claiming of items will result in charges being brought against the person(s) proven to have illegally made claims to the property.
