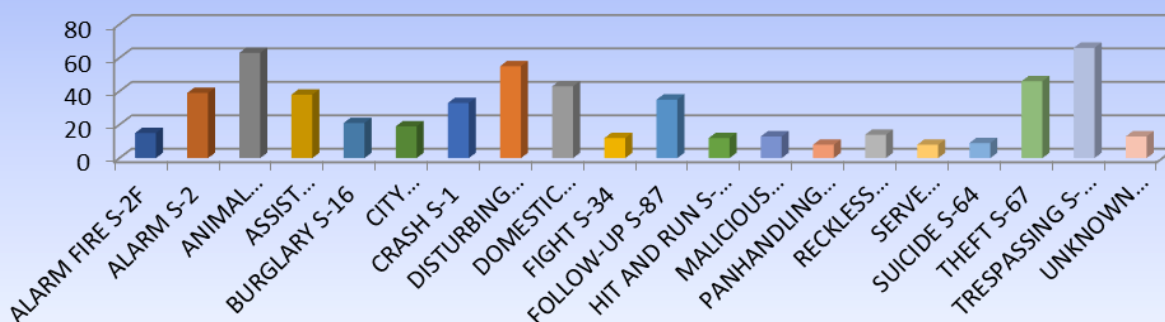

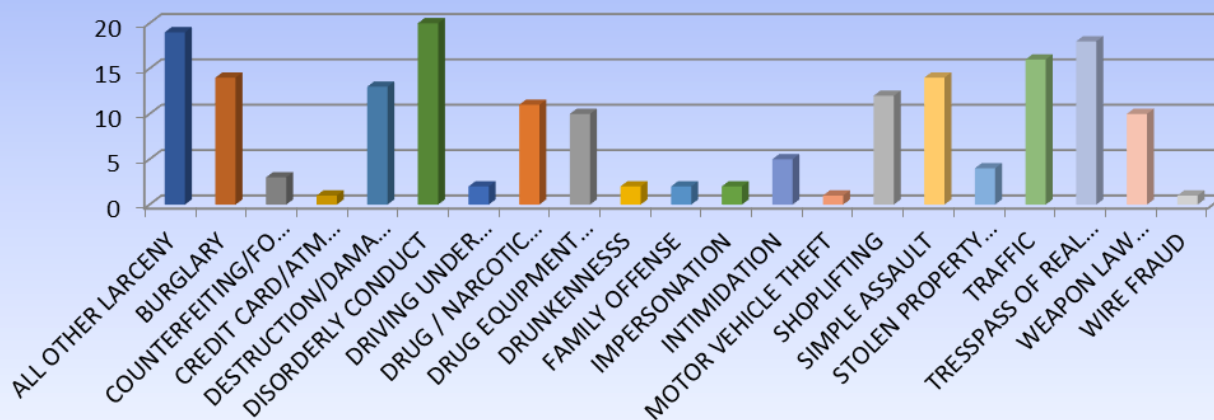

### OFFENSES BY CATEGORY

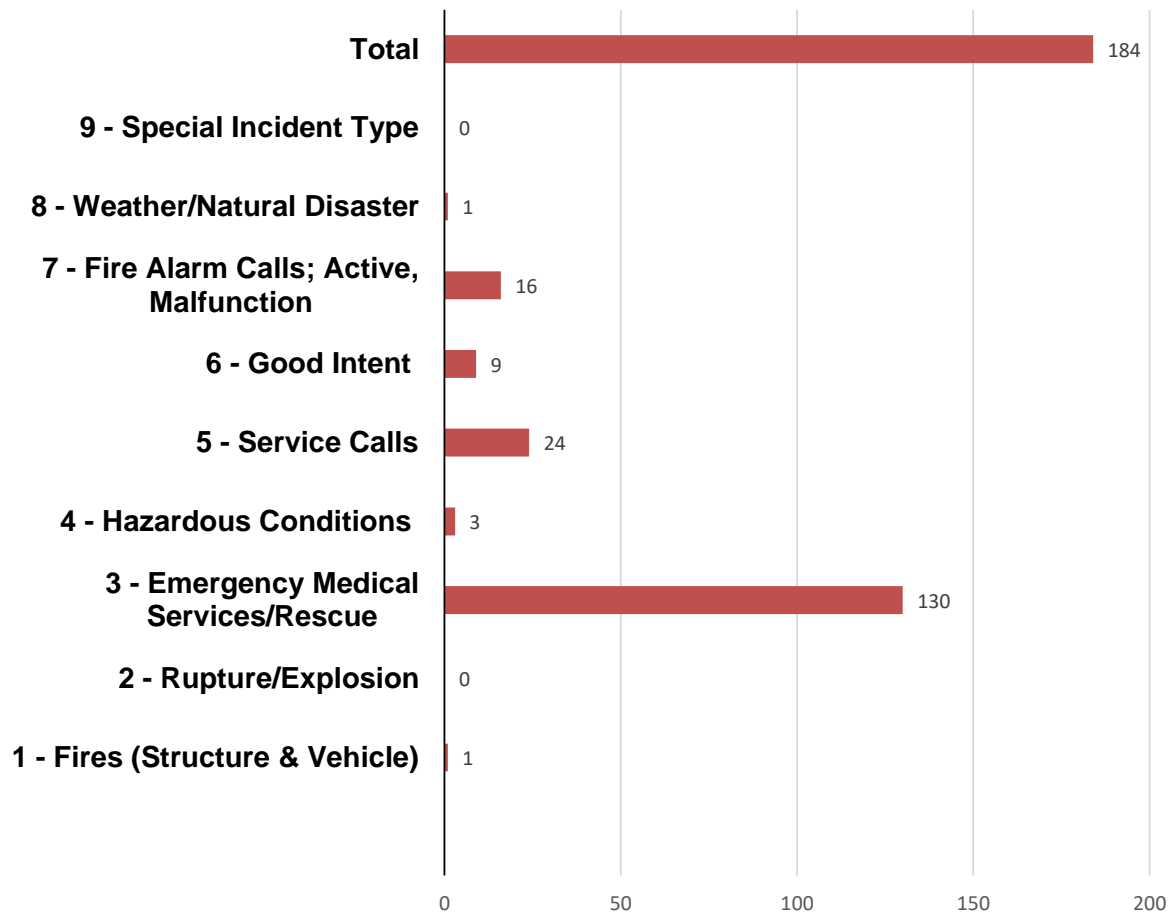
