# NARRATIVE STATEMENT

**City of Biloxi**  
**2020 Consolidated Annual Performance Evaluation Report (CAPER)**  
**for the CDBG Entitlement Program**

**CR-05 - Goals and Outcomes**

**Progress the jurisdiction has made in carrying out its strategic plan and its action plan. 91.520(a)**

In spite of labor and construction material shortages and other challenges caused by the COVID-19 pandemic, the City of Biloxi successfully completed construction of a CDBG-funded, major infrastructure project on schedule in Program Year 2020. Phase I of the East-West Neighborhood Access Road, constructed north of the CSX Railroad tracks between Dorries and Crawford Streets, provides two-lane vehicular access throughout the East Biloxi project area. Improved transportation connectivity helps maintain the cultural heritage identity of the neighborhood while enhancing emergency response times and improving the health and safety of the 4,285 people living in the project area, of whom 2,685 (62.66%) qualify as low- to moderate-income.

The City achieved its goal to complete constructing of Phase I of the East-West Neighborhood Access Road Project, benefitting the 4,285 residents who live in this low- to moderate-income area. Phase II of the project was initiated during PY2020, with the engineering contract awarded in April 2021 and the environmental review underway with completion anticipated by the end of the 2021 calendar year.

A total of \$65,276.43 was disbursed to support public service activities provided by five nonprofit agencies, benefiting 280 residents. The sixth agency selected for a CDBG public service subgrant did not expend any CDBG funds and did not submit any reports to the City. Discounting the 100 projected beneficiaries anticipated to be served by the sixth nonprofit agency reduces the City's program year goal of 406 combined total beneficiaries to 306. Based on this, the City considers the performance of the five other nonprofits successful as they served a combined total of 280 residents successful, 26 people fewer than estimated.

Had it not been for social distancing mandates, temporary and permanent business closures, temporary school closures and other COVID-19 impacts, the City is confident its beneficiary projection would be fully achieved and all budgeted funds expended as intended. However, the Mississippi Center for Justice periodically discontinued face-to-face consultations and the two early childhood daycare programs and the youth educational program periodically closed due to the coronavirus. Of the \$80,000 budgeted for public service activities in PY2020, \$14,724 was unexpended at year end and will be reallocated to CDBG projects in PY2021.

**Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.**

While no progress was made on five of the high priority goals identified in Biloxi's Five-Year Consolidated Plan during Year One of the plan due to insufficient resources, PY2020 CDBG Entitlement funds administered by the U.S. Department of Housing and Urban Development (HUD) allowed the City to achieve success toward the Transportation Improvements goal and in expanding access to several key public service needs of low- to moderate-income residents.

The City invested its PY2020 CDBG resources to address high priority needs that included completing construction of Phase I of a neighborhood road to improve access and emergency response times and high priority nonhousing public services that included affordable early childhood education and daycare programs; affordable recreational programs; affordable legal services to assist residents with filing fair housing violations and addressing other CDBG-eligible issues; and providing housing and expanded supportive services to meet the needs of homeless persons,

especially those needing healthcare and mental health services.

During PY2020, the City also responded to residents' high priority need for expanded access to affordable housing, budgeting 100% of its first CARES Act allocation to address and prevent increased homelessness as a result of the coronavirus. Administered by the Open Doors Homeless Coalition, the PY2019 public services/housing activity provided up to six consecutive months of rent assistance to 25 qualified households impacted by the pandemic in PY2020. The City's CARES Act CDBG-CV funds were budgeted in PY2019 and goals were included in the previous 2015-2019 Consolidated Plan, therefore expected and actual goal accomplishments are not identified in the CR-05 table above, which addresses HUD-funded goals and outcomes for the 2020-2024 period.

#### **Narrative**

During PY2020, most of the families assisted with CDBG-funded activities were Black and none of those served were identified as Hispanic. There was a total of 120 households headed by females; of the 25 households assisted through the CDBG-CV rent program, 19 were headed by females. Among those assisted, 139 were extremely low income, 89 were low income and 49 were moderate income. Three of the residents served by the Mississippi Center for Justice were above moderate income.

In addition to public service activities assisted with CDBG funding during PY2020, the City budgeted 100% of its Round 1 allocation of CARES Act funds to a rent assistance program administered by the Open Doors Homeless Coalition to prevent an increase in homelessness caused by the coronavirus. The employment of many Biloxi residents was impacted by the pandemic, especially those employed in the tourism industry, because of social distancing mandates and periodic school, daycare and business closures. Once HUD guidance addressed rent payment in arrears, Open Doors provided up to six consecutive months of rent and utility assistance on behalf of qualified Biloxi residents.

During PY2020, 25 households, comprised of 65 total people, benefited from this public service activity, which will continue into PY2021. Of the people served, 21 were White and 44 were Black. Seven people identified themselves as Hispanic and there were 19 Female Heads of Households.

The City's investment of CDBG funds did not leverage additional private, state or local funds. The CDBG Entitlement Program does not require matching funds, but City-owned rights-of-way were incorporated into the East-West Neighborhood Access Road Project Phase I, as needed.

**Discuss the difference between goals and outcomes and problems encountered in meeting these goals.**

There is no difference between goals and outcomes.

The City of Biloxi does not receive a HOME, ESG or HOPWA allocation. Because its CDBG allocation is invested to address high priority unmet community needs to benefit the largest number of low- to moderate-income residents possible, the City does not budget CDBG resources to produce, rehabilitate or acquire housing.

The City did not budget any of its PY2020 CDBG resources specifically to support homeless, nonhomeless or special needs households in Biloxi. However, it budgeted its entire CARES Act allocation of \$272,001 to prevent and address increased homelessness in Biloxi caused by COVID-19 by providing rent assistance.

The City executed a subrecipient agreement with Open Doors to administer this PY2019 CDBG-CV public services activity that may provide up to six consecutive months of rent and utility assistance to eligible Biloxi individuals and households that have become homeless or that are at risk of becoming homeless because of COVID-19. The City anticipates that this public service activity will address and prevent homelessness into the 2022 calendar year until all funds have been expended. The activity served 65 people (25 households) rather than the 70 people projected as beneficiaries for PY2020. Implementation of the program was delayed pending HUD guidance regarding payment of rent in arrears, which may have impacted the City's ability to fully reach its beneficiary goal.

The City does not anticipate that these outcomes will impact future annual action plans.

#### **Narrative Information**

The City does not receive HOME funds. The households identified in the table above benefited from public service activities supported with PY2020 CDBG resources.

The CDBG-CV rent assistance program funded through a Round 1 CARES Act allocation of \$272,001 served 65 people (25 households) of whom 45 were extremely low-income, 17 were low-income and 3 were moderate-income during PY2020.

#### **CR-25 - Homeless and Other Special Needs 91.220(d, e); 91.320(d, e); 91.520(c)**

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs**

The City of Biloxi continued to work with the Open Doors Homeless Coalition Continuum of Care and its member agencies during PY2020 to achieve the goal of reducing and ending homelessness in all categories within the City. Open Doors shared information from homeless population assessments with the City to maintain awareness of current affordable housing and related needs of each homeless individual and family in Biloxi.

In collaboration with Open Doors, the City of Biloxi also continued working with the Biloxi Housing Authority, Back Bay Mission, Gulf Coast Center for Nonviolence, the Biloxi Diocese and other agencies and stakeholders to share information about Biloxi's homeless and at-risk of homelessness populations and continued working with these partners to generate private donations to meet incidental needs of homeless populations. The City also continued to support funding applications pursued by local nonprofit agencies to reduce the number of homeless and unsheltered persons in Biloxi.

During PY2020, the City also worked with Open Doors and neighboring local units of government to address and prevent increased homelessness as a result of COVID-19 through CDBG-CV funding made available through the CARES Act.

#### **Addressing the emergency shelter and transitional housing needs of homeless persons**

The City continued to participate as an active member of the Open Doors Homeless Coalition Continuum of Care and supported efforts of Open Doors and its other member organizations to expand emergency shelter and transitional housing inventories in Biloxi. With funding provided through its first CARES Act allocation, the City worked with Open Doors to expand the inventory of affordable housing available for emergency and transitional housing to qualified households to prevent an increase in homelessness due to the coronavirus. Additional hotel/motel units and apartments in Biloxi were made available to address this high priority need, benefiting those at-risk of homelessness as well as the homeless.

**Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs**

During PY2020, the City continued its efforts to decrease homelessness in Biloxi through its continued collaboration with Open Doors, which included encouraging local housing services agencies and religious institutions to expand services to help low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who were being discharged from publicly funded institutions and systems of care such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions. The City worked with agencies to support expanded services and assistance, which included rent, utility and security deposit grants, expanded access to affordable housing for income-eligible households as well as for those being discharged from publicly funded institutions and systems of care.

The City of Biloxi continued to support the public and private agencies that address housing, health, public services, employment, education and



youth needs by endorsing their applications for funding assistance and providing technical assistance as feasible with the City's limited staff and resources. The City also continued to support the Biloxi Housing Authority's ongoing Community and Supportive Services activities and programs.

**Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again**

During PY2020, the City continued to work with Open Doors Homeless Coalition to provide services that expanded access of homeless persons, especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth, to existing affordable housing units through rent, utility and security deposit assistance. 100% of the City's Round 1 allocation from the CARES Act was budgeted for a rent assistance program administered by Open Doors to prevent increased homelessness as a result of COVID-19 by providing rent and utility assistance to qualified Biloxi residents. The City supported Open Doors' efforts to prevent repeat homelessness through ongoing case management assessments and services that include providing access to workforce training, educational advancement and life skills development.

## **CR-30 - Public Housing 91.220(h); 91.320(j)**

### **Actions taken to address the needs of public housing**

During the October 1, 2020 – September 30, 2021 program year, the Biloxi Housing Authority continued to maintain its housing developments and encourage residents to participate in homeownership programs. The City maintains an ongoing working relationship with the Biloxi Housing Authority that includes open communication to support meeting residents' affordable housing needs, based on resources available. Collaborative efforts include development of the City of Biloxi-Biloxi Housing Authority 2019 Analysis of Impediments to Fair Housing Choice and hosting fair housing educational workshops.

### **Actions taken to encourage public housing residents to become more involved in management and participate in homeownership**

The Biloxi Housing Authority continued to support its Resident Councils and the FSS Program to encourage public housing residents to become more involved in management and participate in home ownership.

### **Actions taken to provide assistance to troubled PHAs**

Not applicable; neither the Biloxi Housing Authority nor the Mississippi Regional Housing Authority No. VIII are identified as troubled.

### **CR-35 - Other Actions 91.220(j)-(k); 91.320(i)-(j)**

**Actions taken to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment. 91.220 (j); 91.320 (i)**

Biloxi's official zoning district map allows for a mixture of single- and multi-family residential units on varying lot sizes throughout the City as well as group homes in a variety of areas. Land use regulations support sustainability measures and provide for density bonuses when combined with natural resource preservation and/or other public benefits. Mixed use zoning is permitted in the central business area.

The City has adopted the latest version of the International Building Code, which requires compliance with Americans With Disabilities Act and Fair Housing Act provisions. There are no specific growth limitations or other public policies in place that would affect return on residential investment. Unlike construction costs and insurance premiums, property taxes in Biloxi have not increased during the past 22 years.

The City was successful in its effort to have several areas in East Biloxi federally-designated as opportunity zones, which provides the private sector with financial incentives to invest in these primarily low- to moderate-income areas.

### **Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)**

The City of Biloxi continued to work with other local units of government, religious institutions and area nonprofits to share information about the needs of underserved members of the community in an effort to encourage increased private support to address underserved needs.

City worked during PY2020 with local nonprofits such as Moore Community House to assist in locating facilities to support expansion of affordable daycare services and other high priority community needs. It also continued to work with Open Doors and the Catholic Diocese to expand affordable housing options for Biloxi's homeless and unsheltered populations.

**Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)**

The City of Biloxi continued to share information with residents, housing developers and others about lead-based paint hazards; free information brochures are available at City Hall and in the Building Division. All of the Biloxi Housing Authority's housing units have been assessed and, where required, abated of LBP hazards.

**Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)**

In spite of the pandemic, the City of Biloxi continued to work during PY2020 to reduce the number of poverty-level families by redeveloping and diversifying the local economy to provide expanded employment opportunities. While no official goals, programs or policies have been adopted, the City actively recruits new businesses and facilitates expansion of existing businesses through an expedited development review process and the provision of technical assistance by staff throughout the development process.

The City also continued to support participation of the Biloxi Housing Authority in the HUD/HCV/Family Self Sufficiency Program to help reduce the number of poverty-level families.

**Actions taken to develop institutional structure. 91.220(k); 91.320(j)**

By continuing to participate as an active member of the Open Doors Homeless Coalition, the City stayed informed about activities and services that area nonprofits provide. Staff maintains ongoing communications with the Biloxi Housing Authority and others as it encourages development and implementation of rental housing assistance programs to make existing rental housing stock more accessible to low- to moderate-income households as well as the homeless.

**Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)**

Participation in the Open Doors Homeless Coalition Continuum of Care activities and meetings has enhanced coordination between the City and public and private housing and social service agencies. The annual Point in Time homeless population count and other programs continue to be supported by numerous agencies, including the City of Biloxi. Food, clothing and toy drives are well coordinated by community agencies to maximize their impact on underserved residents.

**Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)**

The City collaborated with the Mississippi Center for Justice and Biloxi Housing Authority to conduct its annual Fair Housing Workshop in January 2020. The workshop was well attended and included representatives from several local nonprofit agencies as well as realtors.

Fair housing education information is shared periodically in the City's monthly Bmail that is mailed to each household in Biloxi and free brochures are available at City Hall, Community Development and Engineering to share Fair Housing Act information and to define how complaints may be filed for Fair Housing Act violations.

**CR-40 - Monitoring 91.220 and 91.230**

**Describe the standards and procedures used to monitor activities carried out in furtherance of the plan and used to ensure long-term compliance with requirements of the programs involved, including minority business outreach and the comprehensive planning requirements**

The City of Biloxi regularly monitors its performance in spending CDBG funds and meeting program goals through timely expenditure of these funds. The City more formally assesses its performance at least once annually and conducts an annual public hearing to inform the public of its progress in implementing and completing CDBG-funded activities each program year.

Expenditures are monitored on an on-going basis throughout implementation of each activity to ensure timeliness of expenditures and compliance with project budgets as well as eliminate opportunity for mismanagement, fraud or waste.

The City complies with its existing policies and procedures to monitor program administration and regulatory compliance. To ensure CDBG Program compliance, the staff monitors specific areas as follows: program performance review; financial management practices; record keeping and reporting practices; general management practices; compliance with EEO, Fair Housing, ADA, anti-discrimination and others.

To document compliance with applicable regulations, policies and procedures, the City monitors its subrecipients on an on-going basis analyzing actual performance against subrecipient agreement requirements and conditions. Provided to each subrecipient at the start of each CDBG program year, Biloxi's CDBG Standard Operating Procedures identify how each subrecipient will set up and implement a CDBG activity and provides the forms necessary to document projected versus actual outcomes; beneficiary eligibility; and compliance with procurement and other regulations. Throughout each program year, the City reviews subrecipients' monthly and quarterly reports, as well as other required

forms, and conducts on-site monitoring of each subrecipient to monitor compliance and timely implementation of each activity. The City takes corrective action as soon as an issue becomes apparent to minimize compliance issues and opportunities for misuse of funds.

To ensure compliance with CDBG program requirements, including minority business outreach, timeliness of expenditures and comprehensive planning requirements, City staff attends HUD-sponsored workshops and training on an on-going basis, participates in applicable webinars and incorporates HUD guidance into its programs and operating procedures. The staff also regularly communicates with HUD Field Office staff and reviews the HUD website for program compliance updates.

City compliance is specifically discussed at each CDBG public hearing, including comprehensive planning and timeliness of expenditures. Compliance with minority business outreach requirements is ensured through ongoing implementation of the City's procedure requiring all HUD-funded Requests for Proposals and Requests for Qualifications be provided in a timely manner to the Mississippi Contract Procurement Center and mailed, return receipt requested, to known minority and female-owned firms.

The City's outreach to minorities and women includes posting information in English, Spanish and Vietnamese on the City's website and in public buildings located throughout the City, including the Biloxi Housing Authority. Written flyers are distributed in English, Spanish and Vietnamese to known local nonprofits that serve and/or represent minorities, low-income residents, and nonEnglish-speaking residents.

#### **Citizen Participation Plan 91.105(d); 91.115(d)**

##### **Describe the efforts to provide citizens with reasonable notice and an opportunity to comment on performance reports.**

The City complies with the intent and literal requirements of its Citizen Participation Plan by making every effort to encourage broad public input into development of activities and programs assisted with CDBG Entitlement Program resources.

In an effort to provide citizens with reasonable notice and opportunity to comment on performance reports and other HUD-required plans and reports, the City of Biloxi not only publishes and posts notices, but delivers flyers in English, Spanish and Vietnamese to known nonprofits that primarily serve nonEnglish-speaking residents, low-income residents, minorities and persons with disabilities. The flyers and notices invite and encourage the participation of all residents into the CDBG process through submission of oral and written comments.

The City of Biloxi makes its Consolidated Annual Performance Evaluation Report (CAPER) draft available to the public for examination and comment for a period of at least 15 days and notifies the public about the report's availability for review on its website and monthly Bmail

newsletter as well as posts notices in public buildings. In addition to posting each annual performance report on the City's website for public review, hard copies are distributed to the four branches of the Biloxi Public Library, the Biloxi Housing Authority, the Mayor's Office, City Hall, the Community Development Department and the Public Works/Engineering Building. CAPER notices indicate where the public review copies are located.



There being no additional comments or questions, Ms. Pickich closed the hearing at 6:00 p.m.



**CDBG-CV ALLOCATION ROUND I**

The city received a CDBG-CV Round I allocation of \$272,001.00 through the CARES Act. The city contracted with Open Doors Homeless Coalition to administer these funds to assist eligible Biloxi residents impacted by COVID-19 with rental assistance to prevent homelessness. 25 HHs were assisted, benefitting a total of 65 people. \$54,404.01 was spent during PY20 with the balance anticipated to be spent in PY21.

**NOTES:**

**Social Services:**

CDBG funds were invested to support activities provided by local nonprofit agencies to address high priority, unmet community needs identified during development of the 5-Year Consolidated Plan and 2020 Action Plan. Funds were budgeted to support five public service agencies to: provide legal services to prevent homelessness due to evictions; expand access to affordable, quality childcare and/or youth education services (Moore Community House, Gulf Coast Center for Nonviolence children's education program; New Bethel/Believe Summer Youth Education Camp); and provide mental health assessments and treatment primarily to homeless residents. Due to state social distancing mandates to prevent the spread of COVID19, one nonprofit agency periodically suspended services during the program year. A sixth agency was approved for funding and no funds were utilized, therefore this activity was cancelled.

**Federal Capital Projects:**

**East BX E/W Neighborhood Access Road Project PH I** - This Project constructed a continuous roadway, approximately 24 feet wide, on the north side of CSX Railroad from Dorries to Crawford Street. It provides transportation connections between low/mod neighborhoods to improve emergency response times. This was a multi-year project that was bid out, with construction beginning in May 2020 and being completed in August 2021. The total project cost was \$1,556,655.71, which included an environmental assessment, engineering design, rights-of-way, acquisition/relocation, and construction.

**East BX E/W Neighborhood Access Road Project PH II** - This Project will construct a continuous roadway, approximately 24 feet wide, on the north side of CSX Railroad from Hopkins Blvd to Porter Avenue. It will provide a transportation connection between neighborhoods to improve emergency response times in a low/mod area. This will be a multi-year project. The engineering design services have been procured and are under contract. The environmental assessment is underway and is anticipated to be completed by January 2022.

**Homeowner's Rehabilitation Program:**

The City contributed \$25,000.00 in **General Funds** to Back Bay Mission to support renovation of three homes. The funds were used to purchase materials to bring the homes into compliance with electrical and plumbing codes; labor was provided by volunteers.

The City of Biloxi is in the process of developing its 2020 Consolidated Performance Evaluation Report (CAPER) in compliance with federal regulations and the City's Citizen Participation Plan. Any comments concerning the housing and/or non-housing community development needs of Biloxi and/or the performance of the City as it relates to its CDBG Entitlement Program during PY2020 are valued and will be considered.



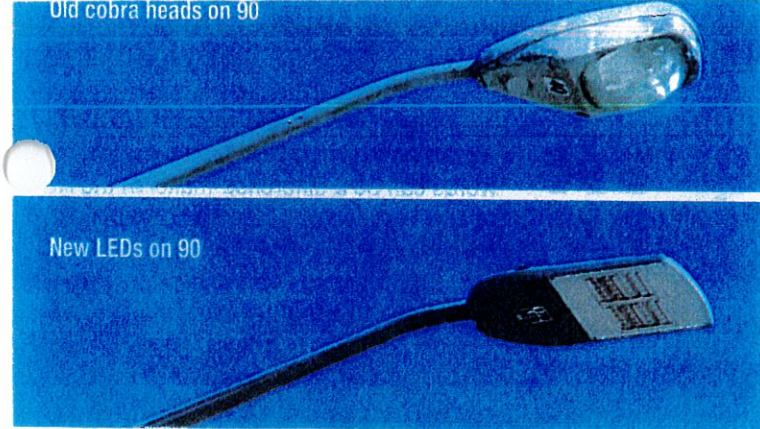

## Upgrade to streetlights making progress in Biloxi

Mississippi Power has begun upgrading Biloxi's 3,500 streetlights to energy-efficient light-emitting diode fixtures as part of the company's upgrade of the 52,000 streetlights in its 23-county service area.

The power company has upgraded 500 of the city's existing lights to LEDs, including many of the 400-watt cobra-head fixtures on U.S. 90, as well as lighting fixtures on Irish Hill Drive and sections of Porter and Howard avenues.

At the same time, the company is installing smart photocells on all fixtures to help monitor service.

"The new lighting will give the city streets a brighter, more uniform coverage," Mississippi Power Lighting Service Supervisor Terri Lee said. "In addition, we are installing smart photocells that are integrated with a central management system, which will monitor the status of the fixtures."

The overall project is scheduled to be completed in 2024.

After the streetlight upgrades, the company will complete the property and security lights that have not already been upgraded with LED and smart photocells.

The new fixtures are priced close to, and in many cases below, the fixture being replaced, so there will be minimal impact to the city's overall street light bill.

## Citizens, the police want you
