AP-05 Executive Summary - 24 CFR 91.200(c), 91.220(b)

1. Introduction

Pursuant to the requirements of 24 CFR Part 91, the City of Biloxi, Mississippi developed its Five-Year Consolidated Plan for the period 2020-2024 in compliance with consolidation of planning and application requirements of the U.S. Department of Housing and Urban Development (HUD) for four of its programs. Biloxi is an entitlement city for one of the four HUD programs subject to these requirements, the Community Development Block Grant (CDBG) Program.

In compliance with CDBG Program national objectives, the City of Biloxi invests almost all of its CDBG resources to principally benefit low- to moderate-income residents by funding projects that support at least one of the program's three broad goals: to provide decent housing; provide a suitable living environment; and expand economic opportunities.

The Five-Year Consolidated Plan consists of three sections: identification of housing and community development needs through data assessment; a housing market analysis; and a strategic plan that prioritizes housing and community development needs and identifies strategies the City will implement with available HUD resources over the 2020-2024 planning period.

The 2022 Action Plan identifies the CDBG resources expected to be available to address the needs and objectives established in the Consolidated Plan and how these resources will be invested to achieve the City's housing and community development goals and objectives, particularly as they relate to low- and moderate-income residents. Biloxi's program year runs from October 1 to September 30.

The 2022 Annual Plan was developed with the participation of residents, elected officials, the Biloxi Housing Authority, the Open Doors Homeless Coalition Continuum of Care, affordable housing representatives, public service providers and many other stakeholders.

2. Summarize the objectives and outcomes identified in the Plan

Objectives identified in the 2020-2024 Consolidated Plan and through the 2022 Action Plan development process focused on maximizing the use of CDBG resources to address high priority unmet needs in the community that primarily benefit low- to moderate-income and special needs residents, with the outcomes of improving residents' living environments and overall quality of life.

Consistently, residents and nonprofit agency representatives expressed support for using CDBG and other resources to improve basic infrastructure and services, including improved public safety; improved drainage to alleviate recurring flooding in Central and East Biloxi; street, sidewalk and parks improvements; and to support public service activities that address and prevent homelessness, provide access to affordable childcare services and youth education/recreation programs; and workforce development activities that expand opportunities for lower income residents to earn a living wage.

3. Evaluation of past performance

Through its Consolidated Annual Performance Evaluation Report (CAPER), the City annually reports on its performance to HUD and maintains a copy of the CAPER available for public review in the Federal Programs Division office.

In conjunction with citizen input and consideration of progress made or blocked toward addressing high priority unmet community needs, evaluation of past performance is considered by the City during the process of identifying projects to be funded each program year.

For example, in PY2018, PY2019, 2020 and 2021, the City was successful in achieving annual goals to address the high priority need to expand access to affordable childcare. Based on past success and on-going community need, the City of Biloxi plans to invest CDBG resources to support qualified public service agencies in providing affordable childcare to eligible households again in PY2022.

Successful implementation of transportation improvement projects, as identified in past performance evaluations, likewise have resulted in the investment of CDBG resources to achieve the goals of providing suitable living environments and improved public safety in primarily low- to moderate-income areas. The City proposes to invest additional CDBG resources in PY2022 to construct an access road to preserve public safety and neighborhood connectivity in a low- to moderate-income area, which will be impacted by closure of at least two railroad crossings.

4. Summary of Citizen Participation Process and consultation process

Planning and development of the Biloxi 2022 Action Plan was launched in March 2022. To broaden public outreach and encourage public input, the City conducted two public hearings, designated a 30-day period for submittal of written comments and complied with HUD regulations and its Citizen Participation Plan as described in template PR-15.

The City consulted with known housing, supportive public service and community development providers to update Annual Plan information and to invite their input about unmet community needs, particularly as they impact low- to moderate-income residents. For the first time, the City invited agency representatives to provide input about an identified broad topic during one of three consultation meetings. Table 2 in Template PR-10 identifies some of the agencies that not only provided input into this document, but that also work with the City on an on-going basis to help address community needs.

5. Summary of public comments

The Citizen Participation Attachment provides documentation of compliance with HUD regulations and the Biloxi Citizen Participation Plan's public participation requirements for planning and developing the 2022 Action Plan. The City conducted two public hearings to encourage public participation into the development process; all known public and private agencies providing public services in the City were invited to participate and to provide input orally or in writing.

All written comments received during the public hearings were considered by the City and a copy of each is included in the Citizen Participation Attachment; none were submitted during the designated 30-day comment period, from June 23 to July 25. Minutes summarizing oral comments received during the two public hearings also are attached. The citizen participation process is described in template PR-15.

6. Summary of comments or views not accepted and the reasons for not accepting them

All comments submitted to the City were accepted and considered.

7. Summary

The Mayor reserves the right to designate qualified subrecipients to assist in the City's on-going efforts to address high priority, unmet community needs through specific, HUD-eligible public service activities, subject to the approval of the Biloxi City Council and in compliance with HUD's annual budget limits on public service activities.

1. Introduction

The City of Biloxi complied with HUD CDBG Entitlement Program regulations and policies as well as the Biloxi Citizen Participation Plan, and consulted with HUD specified community representatives as well as the general public during development of its 2022 Annual Action Plan (AAP).

The Citizen Participation Attachment includes a copy of the City's CDBG mailing list, identifying individuals/agencies contacted by mail to invite and encourage their input and participation in the 2022 AAP development process in compliance with 24 CFR 91.100(a) (1). It also includes a copy of the CDBG email addresses list, identifying those who indicated they prefer email contact regarding Biloxi CDBG public hearings and information.

Consultation meetings were organized by subject group to encourage input from 1) local broadband internet service providers; and those engaged in narrowing the digital divide; 2) agencies whose primary responsibilities include management of flood prone areas, public land and/or water resources and emergency management/hazard mitigation planning; and 3) representatives of protected classes under the Fair Housing Act and agency representatives who work to support enforcement of the Act. As Mississippi does not have a designated state agency responsible for Fair Housing Act enforcement, residents must submit violation complaints directly to HUD; the Biloxi office of the Mississippi Center for Justice assists residents with what may sometimes be an arduous process.

In addition to topic-specific consultation meetings, the City reached out to encourage input from local and regional economic development and planning organizations; local business owners; chambers of commerce; known developers; public service agencies; faith-based organizations; other local units of government; the regional CoC for preventing and addressing homelessness; state and regional mental and public health agencies; organizations representing residents with English as a Second Language; public and private housing agencies; legal, social justice and child advocacy organizations; philanthropic organizations; veterans' services agencies and others.

To enhance coordination between public and assisted housing providers, private and governmental health, mental health and services agencies, the City of Biloxi encourages all known public and assisted housing providers, private and governmental health, mental health and service agencies to participate in the process for developing each of its Annual Action Plans, including attending its CDBG public hearings. The City also encourages these agencies to attend regularly scheduled public program meetings hosted by the Open Doors Homeless Coalition, which support the exchange of information and encourage on-going collaboration among those working to improve the overall quality of life of residents in the lower three counties of Mississippi.

Describe coordination with the Continuum of Care and efforts to address the needs of homeless persons (particularly chronically homeless individuals and families, families with children, veterans, and unaccompanied youth) and persons at risk of homelessness.

The City of Biloxi consulted with the Open Doors Homeless Coalition Continuum of Care throughout development of the 2022 Action Plan. The Federal Programs Manager, who has the day-to-day responsibility for administering the Biloxi CDBG Entitlement Program, attends meetings of the Continuum of Care and the Executive Director of the Open Doors Homeless Coalition regularly attends and provides oral and written comments at the City's CDBG-related public hearings.

The City works with Open Doors during the CDBG Program Year to address needs of Biloxi's homeless and at risk of homelessness populations, including chronically homeless individuals and families, families with children, veterans and unaccompanied youth. During Program Year 2022, the City will continue to collaborate with and support efforts of Open Doors to prevent and address homelessness in Biloxi. The Biloxi Police Department coordinates with the Open Doors Homeless Coalition on an on-going basis, participating in the annual Point in Time count and working to balance public safety with the needs of homeless individuals and families.

The City of Biloxi does not receive ESG funds but provides feedback to and supports the efforts of the Continuum of Care to administer its ESG award to best meet the needs of Biloxi residents.

Narrative (optional)

The City continues to work in cooperation with the Mississippi HOME Corporation and Mississippi Center for Justice (MCJ) to update information about local and state impediments to fair housing choice. MCJ collaborated with the City in 2020 and 2021 to offer no-cost Fair Housing Act Workshops, which were well attended, and has committed to supporting City efforts to conduct a workshop during Program Year PY2022.

Letters with questionnaires were mailed to other local units of government, including Harrison County, requesting input about shared transportation, infrastructure and community needs as well as about projects or programs that may warrant a multijurisdictional approach to address. Jackson County completed and returned the survey, a copy of which is included in the Citizen Participation Attachment.

AP-12 Participation – 91.105, 91.200(c)

1. Summary of citizen participation process/Efforts made to broaden citizen participation

The Biloxi Citizen Participation Plan (CPP) identifies the City's processes for inviting and encouraging community wide participation and input into its CDBG Entitlement Program, from five-year planning and annual project development through project/program implementation and evaluation.

The City initiated its citizen participation process regarding development of the 2022 Action Plan in March by publishing a notice of information availability and the schedule of public hearings in the B-News, a multipage publication mailed monthly to each Biloxi water/sewer account holder. The City distributed notices that were posted in public buildings, the four branches of the Biloxi Library and Biloxi Housing Authority offices, which invited the public to attend the hearings; informational flyers were mailed or emailed to residents, agencies, organizations and other stakeholders on the City's CDBG Master Mailing and Email Lists. Notices also were hand delivered to nonprofit agencies representing NonEnglish speaking residents.

The first public hearing was held on Tuesday, May 24 at 5:30 p.m. with six residents and agency representatives attending in addition to one Councilman and staff. Two residents and agency representatives attended the 5:30 p.m. Wednesday, June 22 public hearing, in addition to staff.

All oral comments offered at the public hearings were accepted and considered by the City in developing the final plan. No written comments were submitted during the first public hearing. One was submitted at the June 22 public hearing by Carol Burnett, Executive Director of Moore Community House, identifying the City's continued high priority need for affordable daycare services, especially for very young children; to support efforts to address this on-going need, the City budgeted \$25,000 in PY2022 CDBG public services funds for MCH's affordable early childhood education program.

One written comment dated June 14, 2022 was submitted in response to the Notice about the CDBG hearings published in the June B-News. The resident indicated he would not be able to attend either hearing, but requested the City's assistance in having the Biloxi Housing Authority address specific maintenance issues at its Seashore Oaks Assisted Living Facility. The City contacted BHA, which reported that it is in the process of addressing the maintenance issues. No written comments were submitted during the June 23 – July 25 30-day comment period.

AP-15 Expected Resources – 91.220(c)(1,2)

As a participant in HUD's CDBG Entitlement Program, the City of Biloxi receives an annual allocation of federal funds to address local housing and non-housing community needs. Because of the program's many successes in meeting community needs across the country and its proven effectiveness in directly benefiting primarily low- to moderate-income households, the City of Biloxi anticipates the federal government will continue funding the CDBG Program and that annual entitlement allocations will remain at about the same amount during the 5-Year period covered by the current Consolidated Plan.

The City received a Program Year 2022 CDBG allocation from HUD in the amount of \$415,164 and the City anticipates generating approximately \$175,784 in program income. The City anticipates that an estimated \$97,600 in previously allocated but unexpended entitlement funds and program income will be carried over and re-allocated to support PY2022 projects. Any additional program income or carried over funds will be budgeted for the East Biloxi East-West Neighborhood Access Road Project, Phase 2.

HUD allocated \$415,164 in CDBG funds to the City of Biloxi for Program Year (PY) 2022 and the City anticipates generating program income of \$175,784 during the year, which will be budgeted to support PY2022 projects. The City also anticipates carrying over \$97,600 in previously allocated but unexpended funds that will be re-allocated to support PY2022 projects and activities.

In spite of the decrease in its annual CDBG allocation, the City is again budgeting \$70,000 to support high-priority public service activities that benefit low- to moderate-income residents as further identified in Template AP-38.

Describe the reasons for allocation priorities and any obstacles to addressing underserved needs

Input provided during development of Biloxi's CDBG 2020-2024 Consolidated Plan helped identify and prioritize community needs as well as guided allocation of limited CDBG resources to specific projects and activities to meet those needs. Input provided during development of the 2020, 2021 and 2022 Action Plans continues to guide allocation of the City's limited and decreasing CDBG resources and supports the City's efforts to maximize benefits to neighborhoods in which a majority of residents qualify as low- to moderate-income.

PY2022 CDBG resources will be invested to support implementation of Phase 2 of the East-West Neighborhood Access Road Project to preserve public safety in a low- to moderate-income neighborhood north of the CSX Railroad tracks between Hopkins Boulevard and Porter Avenue. The proposed access road will maintain neighborhood connectivity while preserving access for emergency response vehicles as opposed to creating dead-end streets and negatively impacting response times. Investment of CDBG funds in this project will preserve public safety and the overall quality of life for the 2,450 people living in one of the few East Biloxi neighborhoods that is still intact after Hurricane Katrina in 2005. Based on HUD Census data, 1,325 or 54.08% of those benefiting from this project qualify as low- to moderate-income.

There are no anticipated obstacles to addressing the high-priority need for public safety and transportation improvements. The project is under contract and environmental review is essentially complete; construction is anticipated to begin in late 2022.

Discussion

In its 2019 Action Plan, the City budgeted its first CARES Act allocation, totaling \$272,001, to prepare for, prevent and respond to the coronavirus by providing rent and utility assistance to residents negatively impacted by the coronavirus. Under a subrecipient agreement between the City and Open Doors Homeless Coalition, qualified residents' applications for up to six consecutive months of rent assistance may continue to be processed until CARES Act funds are depleted or until the federal deadline for expending these funds.

AP-60 Public Housing – 91.220(h)

The Biloxi Housing Authority (BHA) Executive Director provided the City with a written update, which is the basis of information for this template. The City of Biloxi and BHA enjoy a good working relationship that includes on-going exchange of information, collaboration in implementing identified actions in the Joint Analysis of Impediments to Fair Housing Choice and partnering to support public and assisted housing activities that benefit Biloxi residents.

BHA has successfully transitioned from the Public Housing platform to the Rental Assistance Demonstration (RAD) Project Based Section 8 platform and therefore no longer has traditional Public Housing units.

Actions planned during the next year to address the needs to public housing

During PY2022, BHA will continue to maintain its housing developments and will continue to explore the need for additional or replacement housing units. During the program year, the BHA will continue its outreach efforts to expand landlord participation in the local voucher program to increase the number of housing units available to Tenant Based Voucher recipients.

To improve public housing resilience, the Biloxi Housing Authority will consider the cost and effectiveness of rehabilitating or retrofitting public housing units and office space to eliminate or at least reduce flood damage. Retrofits that provide an acceptable level of flood damage protection to warrant the high cost of improvements may not be possible in the current economy.

Concurrent with exploring those options, the BHA also will consider relocating housing units and/or office space. However, available property that also is suitable to the BHA's needs and has an adequate elevation to decrease the risk of being in a future flood zone, if FEMA maps are changed again as predicted, may not be possible.

To be most suitable for public housing residents, the property would be located on or near a regular bus route of Coast Transit Authority, have convenient access to a grocery store and supportive service providers. The City supports the goal of locating public housing outside of special flood zone areas, but it may be cost prohibitive.

Actions to encourage public housing residents to become more involved in management and participate in homeownership

The Biloxi Housing Authority will continue to support its Resident Councils and the FSS Program to encourage communication between residents and management and will continue to encourage participation of residents in available programs for self-sufficiency.

The BHA will continue to refer interested public housing residents to local homeownership programs during PY2022 in spite of increased interest rates and flood insurance uncertainties that are impacting affordability of housing along the Mississippi Gulf Coast, especially in areas south of Interstate-10.

AP-65 Homeless and Other Special Needs Activities – 91.220(i)

Introduction

The City of Biloxi works with the Open Doors Homeless Coalition Continuum of Care and its other member agencies and organizations to reduce and end homeless within the City.

Describe the jurisdictions one-year goals and actions for reducing and ending homelessness including reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

The City of Biloxi's one-year goal for Program Year 2022 is to continue working with the Open Doors Homeless Coalition, the Biloxi Housing Authority, Gulf Coast Center for Nonviolence, Coastal Family Health Center, Back Bay Mission and other agencies to coordinate resources to meet the housing and supportive services needs of the City's homeless and near-homeless populations.

The City did not receive any PY2022 public service applications requesting funding to provide housing for Biloxi's homeless populations. The BHA, Open Doors and the City will continue encouraging the local Veterans Administration to expedite referrals so all VASH Vouchers are issued to benefit homeless veterans.

Addressing the emergency shelter and transitional housing needs of homeless persons

The City will continue to participate as an active member of the Open Doors Homeless Coalition Continuum of Care and will support efforts of Open Doors and its other member organizations to expand emergency shelter and transitional housing inventories in Biloxi.

The City also will continue to work collaboratively with the Open Doors Homeless Coalition to identify appropriately-zoned property in Biloxi for development of an assessment center to better serve homeless individuals and families as they are assessed and linked with housing assistance and supportive services.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

The City of Biloxi will continue to work collaboratively with the Biloxi Housing Authority and Open Doors to encourage the Mississippi Gulf Coast's Veterans Administration to issue all of its VASH Vouchers as quickly as possible to benefit homeless veterans. The City also will continue to work with Open Doors to provide services that expand access of homeless persons, especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth, to existing housing through rent, utility and security deposit assistance as funds allow.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); or, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs.

Collaborating with Open Doors, the City will continue encouraging local housing services agencies to expand services to help low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are being discharged from publicly funded institutions and systems of care such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions. Assistance that includes rent, utility and security deposit grants, would expand access to affordable housing for low-income households as well as for those being discharged from publicly funded institutions and systems of care.

Discussion

The City of Biloxi will continue to support the public and private agencies that address housing, healthcare, public services, employment, education and youth needs by endorsing their applications for funding assistance and providing technical assistance as feasible with the City's limited staff and resources.

The City also will continue to support the Biloxi Housing Authority's ongoing Community and Supportive Services activities and programs.

AP-75 Barriers to affordable housing – 91.220(j)

The City of Biloxi invests public resources to support efforts of its professional planning staff to keep apprised of legal decisions regarding land use at the local level as well as urban planning trends and policies that may change availability of affordable housing or impact individuals' property rights. Consideration is being given to allowing increased density in lower-density residential zones to accommodate the increased number of VRBO conditional use requests and to allowing multiple principal uses on a single lot of record. This may be in response to trends in other communities permitting location of tiny houses and/or small studio housing units in what traditionally were open backyards, as a means of supplementing property owners' income to ease increasing housing cost burdens.

Biloxi officials, planners and community development staff are aware of and considering how best to adapt local codes to meet the growing need for a wider range of housing types, which may include updating zoning classifications to expand options for development by right of affordable group homes and residential "compounds" that include 4 - 6 residential units with shared common areas.

Codes that restrict adaptation of existing single-family houses to incorporate attached or detached "mother-in-law" type units and infill residential development that doesn't meet minimum square footage requirements for a given classification may need to be revised to meet the need for additional affordable housing inventory, particularly for populations requiring on-site guidance/supervision. These populations may include those in substance abuse rehabilitation programs; those with mental or

physical disabilities; young adults aging out of the fostercare system; elderly and frail elderly; and those recently released from institutions.

Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment

The City worked with the Biloxi Housing Authority to develop the 2019 joint City of Biloxi-Biloxi Housing Authority Analysis of Impediments to Fair Housing Choice during 2018-2019, which included a review of local land use controls, including zoning, ad valorem tax policies, building codes, fees and charges, growth limitations and policies affecting return on residential investment. At that time, no zoning restrictions or limitations were identified as being barriers to affordable housing.

Biloxi's official zoning district map allows for a mixture of single- and multi-family residential units on varying lot sizes throughout the City as well as group homes in more than one zone. Mixed use zoning is permitted with no parking requirements in the downtown area, which improves affordability of development and redevelopment.

The City has adopted the most current version of the International Building Code, which requires compliance with the Americans with Disabilities Act and Fair Housing Act provisions. Unlike construction costs and property insurance premiums, property taxes in Biloxi have not increased in more than 25 years. With increasing inflation and interest rates and a relatively low residential vacancy rate, almost no affordable housing currently is available for low- and middle-income residents in Biloxi. High costs for construction materials and residential property insurance premiums (wind and water) will preclude many families from pursuing homeownership in Biloxi at least in the near-term.

The interim Overview of the Apartment Housing Market for 2020, prepared by the Gulf Coast Regional Planning Commission, identified the City of Biloxi as the only municipality anticipating construction of unassisted apartments (30 units) at that time. No other Coast city or unincorporated area reported plans for apartment unit construction in 2020. According to the interim report, which is the most current available, Biloxi's 6.5% market rent apartment vacancy average rate for unassisted units was slightly higher than the overall three-Coast County apartment vacancy average rate of 5.4% and Harrison County's rate of 6.2%.

While the 2020 apartment vacancy rate is about 2% higher than it was in July 2019, when the last Loper Apartment Survey for the Mississippi Gulf Coast was prepared, there has been minimal movement in the rental housing market. GRPC's interim report advises users to consider the impact national eviction bans had on the rental housing market during the COVID-19 pandemic, which "altered the dynamic state of the usual housing market of previous years."

And, even though the need for and number of affordable housing units seems to have been relatively stable for the last decade, the City of Biloxi is mindful of the gap between its affordable housing inventory and the affordable housing needs of the community.

Local realtors consistently identify the need for additional affordable housing adapted for the nation's expanding +65 population. With many military retirees choosing to live in Biloxi because of Keesler Air Force Base's top ranked medical services and commissary access, well built two- and three-bedroom single family and multifamily units located in close proximity to regular public transportation routes is in high demand.

Affordable housing in close proximity to major resort casino/hotel employers, is limited and also is in high demand yet it is extremely challenging to meet code requirements while maintaining affordability due to several factors, not least of which is uncertainty associated with new "Risk Rating 2.0" federal flood insurance pricing changes. It is not certain if regulations impacting building and rehabilitation of structures in special flood zones will change in the near-term and there is uncertainty about how final resolution of National Flood Insurance Program issues will impact homeowners. Until there is resolution of these issues at the federal level, they are another barrier to local affordable housing.

Discussion:

The current low volume of multifamily rental housing construction and continued apartment absorption has resulted in a return to market equilibrium in almost all segments of the local apartment market. While property owners enjoyed a sellers' market during the first half of PY2021, interest rate increases and climbing inflation have cooled the local real estate market. What was considered affordable housing six months ago may now be cost prohibitive for potential buyers without a purchase contract that locks in the purchase price or a pre-approved, fixed, low rate mortgage.

AP-85 Other Actions – 91.220(k)

Actions planned to address obstacles to meeting underserved needs

The City of Biloxi will continue to work with other local units of government, supportive service agencies and faith-based organizations to share information about and collaboratively meet the needs of underserved members of the community. Climbing interest rates, a lack of market stability and forecasts for economic recession are creating new challenges to meeting underserved needs as limited resources must be stretched even further than they were during the pandemic.

Actions planned to foster and maintain affordable housing

The City of Biloxi plans to continue working with housing developers and realtors to encourage affordable infill housing development and it will consider zoning changes that allow a wider range of affordable housing types throughout the City to meet the needs of different populations, including the elderly and those with special needs.

The City plans to continue offering its rental housing incentive program to expand availability of workforce housing in the Biloxi Main Street area. Funded through the City's General Fund, the program has encouraged rehabilitation of numerous residential rental units to date.

Actions planned to reduce lead-based paint hazards

All RAD units owned by the Biloxi Housing Authority have been assessed and LBP hazards have been abated.

The City of Biloxi will continue to support the efforts of the Mississippi State Department of Health (MSDH), the Biloxi Housing Authority and others to improve awareness among parents and caregivers about the hazards of lead-based paint to children, especially those aged six and under. Biloxi building codes require lead-based paint testing for rehabilitation of residential units built before 1978-79 and, if LBP positive, property owners are required to abate and properly dispose of LBP chips/dust or to contain the LBP in compliance with applicable standards.

Data for LBP testing of children residing in Biloxi area codes in 2020 was provided by the MSDH to the City in June 2022 and identifies that of the 306 children age six and under who were tested for elevated blood lead levels, only one was identified with a venous lead level of 5 or higher and none were identified with venous lead levels of 15 or higher. This indicates efforts to improve public awareness about permanent damage LBP poisoning can have on young children may be effective and should be continued.

Brochures regarding LBP poisoning hazards and symptoms are available at no cost at the Biloxi building permit counter in the Community Development Department and through MSDH's Healthy Homes Program.

Actions planned to reduce the number of poverty-level families

The City of Biloxi will continue to work with local partners to reduce the number of poverty-level families by redeveloping and diversifying the local economy to provide expanded employment opportunities that pay a living wage. While no official goals, programs or policies have been adopted, the City actively recruits new businesses and facilitates expansion of existing businesses through an expedited development review process and the provision of technical assistance by staff throughout the development process.

The City will continue to collaborate with Open Doors, and its other member agencies and organizations, to provide the supportive services needed to help break the cycle of poverty. Those able to work will be encouraged to participate in existing workforce development and job skills training programs to expand their employment opportunities.

The City also will continue to support participation of the Biloxi Housing Authority in the HUD/HCV/ Family Self Sufficiency Program as part of the effort to reduce the number of poverty-level families.

Actions planned to develop institutional structure

Continuing to participate as an active member of the Open Doors Homeless Coalition, the City will stay informed about the activities and services of area nonprofits that play a role in the institutional structure.

Federal Programs staff will continue to maintain ongoing communications with the Biloxi Housing Authority and others as it encourages development and implementation of affordable housing programs and rental housing assistance programs to improve accessibility of existing rental housing stock to low- to moderate-income households as well as the homeless.

Actions planned to enhance coordination between public and private housing and social service agencies

Participation in the Open Doors Homeless Coalition Continuum of Care activities and meetings has been effective in enhancing coordination between public and private housing and social service agencies in Biloxi. The annual Point in Time homeless population count and other programs will continue to be supported by the City of Biloxi as will food, clothing and toy drives as part of the communitywide effort to meet the needs of underserved residents.

AP-90 Program Specific Requirements – 91.220(I)(1,2,4)

Introduction:

The City of Biloxi received a CDBG allocation of \$415,164 for Program Year 2022 and anticipates generating \$175,784 in program income to be budgeted in support of PY2022 projects. Also, an estimated carry over of \$97,600 in previously allocated but unexpended funds will be re-allocated to support PY2022 projects.

The City will invest \$518,548* of its PY2022 CDBG resources in the Transportation Improvement Project that will preserve neighborhood access and public safety in a low- to moderate-income neighborhood in East Biloxi. Dear Ms. Pickich:

Thank you for the opportunity to respond to public comments received by the City of Biloxi regarding our property known as Seashore Oaks. Our funding is received from the federal government, through the U.S. Department of Housing and Urban Development (HUD). We do not receive state or local funding. As a result, we are not a program included in your Federal Programs budget. However, we always want and are happy to receive feedback from the general public, especially our residents. This feedback aids us in determining ways we can improve the living experience of residents in our developments. Below are the comments presented to the City of Biloxi, followed by our responses:

Comment 1: "Need both front and rear entrance awning replacements – damaged by Hurricane Zeta. Since then, they are still never replaced."

Response: We are aware of this issue and the inconvenience the lack of awnings has created for our residents. The replacement of the awnings is part of a large construction package for which we have been unable to procure a contractor. Because of the ongoing labor shortage, as well as ongoing supply chain issues, our Hurricane Zeta repair program has been a challenge. This challenge has made it extremely difficult to complete this project any sooner. We anticipate the awnings will be replaced this year.

Comment 2: "Need road resurfacing – too many holes. Paint yellow lanes for parking areas; blue lanes for handicapped parking areas; red curbs for fire/emergency parking."



Response: The infrastructure of our properties is important to us as well as our residents. The repair of these items has been under contract now for in excess of six (6) months. Unfortunately, weather delays and ongoing contractor staffing issues have presented challenges that have delayed the completion of this project. Fortunately, this infrastructure work is currently underway at this time.

Comment 3: "Need to build a nice gazebo area on a now demolished swimming pool area."

Response: The quality of our properties and their respective amenities is as important to us as it is to residents. However, because of funding constraints, we must give priority to repairs related to life and safety issues. Because of the large increase in insurance costs, rapidly rising inflation and no additional funding to meet these challenges, projects like the gazebo are delayed while we focus on projects necessary for the health and safety of our residents.

We appreciate all that you do for us and all of the residents of the City of Biloxi. If you need any information from us, please don't hesitate to reach out to my office.




At 5:30 p.m., Susan Pickich, Biloxi Federal Programs Manager, opened the second CDBG Public Hearing regarding development of the 2022 Action Plan, a component of the City of Biloxi's 2020-2024 CDBG Consolidated Plan. The hearing was held in the Biloxi Community Development Department auditorium, located at 676 Dr. Martin Luther King, Jr. Boulevard. A copy of the sign-in sheet and agenda packet is attached to these minutes.

Ms Pickich asked everyone to be sure to sign in before they leave. She then introduced Grace Aaron, consultant, and thanked Ray Carter, representative of the Mississippi Secretary of State's Office, and Carol Burnett, Executive Director of Moore Community House, for attending. Ms Pickich invited questions to be asked and comments offered during the presentation of information


Ms Pickich presented an overview of items on the agenda, identifying PY2022 CDBG resources available to fund projects and activities during the upcoming program year and, directing attention to page 4 of the agenda packet, presented an overview of projects proposed to be funded. Mr. Carter asked Ms Pickich to discuss the program income formula. Ms Pickich explained that HUD and the City worked together to negotiate the formula in the mid1990s, in response to the rapid growth of the casino gaming industry within City limits. She said 5.13% of gross revenue generated by local casino gaming on a monthly basis was returned by the State, after applicable taxes and fees were deducted in compliance with lease terms, to the City as CDBG program income.

Mr. Carter thanked her and asked if there was anything the Secretary of State's Office could do to assist the City in terms of administering its CDBG program income or with its CDBG Entitlement Program. Ms Pickich said she appreciated his offer of assistance but, to her knowledge, none was needed at the time and indicated it was the first time a State agency representative had offered assistance.

A general discussion followed about the public service agencies proposed to receive PY2022 CDBG funding and the services to be provided to Biloxi residents by the five nonprofit agencies. Ms Pickich thanked Mr. Carter and Mrs. Moore for attending the hearing and invited them to submit written comments during the 30-day comment period, June 23 to July 25, referencing information in the agenda packet identifying where to send comments. She adjourned the hearing at 6:35 p.m.

Summary

The 2022 Action Plan is a requirement of the U.S. Department of Housing and Urban Development (HUD) that is designed to develop a coordinated and cooperative effort to identify housing, community development and supportive housing needs of the City of Biloxi. The Action Plan is based on prioritized needs and strategies for meeting those needs identified in the 2020-2024 Consolidated Plan.

Both the Action Plan and Consolidated Plan are designed by HUD to consolidate the planning and application requirements of four HUD formula grant programs:

1. The Community Development Block Grant Program (CDBG)
2. Home Investment Partnerships (HOME)
3. Housing Opportunities for People With AIDS (HOPWA)
4. Emergency Shelter Grants (ESG)

The three broad goals of these four HUD programs are:

1. To provide decent housing;
2. To provide a suitable living environment; and
3. To expand economic opportunities.

Community Development Block Grant Program

Biloxi is an entitlement city under the rules of HUD's Community Development Block Grant Program (CDBG) and as such, receives an annual allocation of funding, which in Program Year 2022 is \$415,164. Biloxi does not receive an annual allocation of funds under HOPWA, ESG or HOME but must work with other agencies to compete for funding from those programs.

During PY2022, the City anticipates generating program income of about \$175,784 based on previous years. At this time, the amount of entitlement allocated funds and program income previously allocated but unexpended is estimated to be approximately \$97,600, which will be carried forward and budgeted for use in PY2022. Any other funds carried forward for use in PY2022 will be reallocated to the East Biloxi East-West Neighborhood Access Road Project, Phase II.

Availability of Information

Information concerning the Action Plan, the Consolidated Plan, the Assessment of Fair Housing/Analysis of Impediments to Fair Housing Choice and the Community Development Block Grant Entitlement Program are available for public review at the Biloxi Federal Programs Manager's Office, located at 214-A Delauney Street in downtown Biloxi, between the hours of 8 a.m. and 4:00 p.m., Monday through Friday.

National Objectives of Community Development Block Grant Program

1. Projects that principally benefit low- and moderate-income persons. A project or activity will be considered to principally benefit low- and moderate-income persons if it is designed to meet identified needs of low- and moderate-income persons.
2. Projects that prevent or eliminate slums or blight.
3. Projects designed to meet needs having a particular urgency.

PROJECTS MUST MEET AT LEAST ONE OR MORE OF THE ABOVE NATIONAL OBJECTIVES.

Examples of Basic Eligible Activities for the CDBG Program

1. Acquisition of property for a public purpose.
2. Public facilities infrastructure improvements including water improvements, wastewater improvements, solid waste improvements, streets and storm drainage improvements, etc.
3. Urgent needs and emergency grants to address community development needs having a particular urgency because existing conditions pose a serious and immediate threat to the health or welfare of the community.
4. Interim assistance requiring immediate action to alleviate emergency conditions.
5. Relocation payment and assistance for permanently or temporarily displaced individuals, families, businesses and organizations, and reimbursement for loss of rental income incurred in holding housing units to be utilized by relocation of individuals and families displaced by program activities.
6. Special economic development activities.
7. Public services to address high priority unmet community needs.

MINUTES
City of Biloxi CDBG Entitlement Program Public Hearing
2022 CDBG Action Plan
5:30 pm Tuesday, May 24, 2022

At 5:30 p.m., Susan Pickich, Biloxi Federal Programs Manager, opened the first CDBG Public Hearing regarding development of the 2022 Action Plan, a component of the 2020-2024 Consolidated Plan. The hearing was held in the City of Biloxi Community Development Department auditorium, located at 676 Dr. Martin Luther King, Jr. Boulevard in downtown Biloxi. A copy of the sign-in sheet and agenda packet is attached to these minutes.

Ms Pickich welcomed those present and asked everyone to be sure to sign in and pick up an agenda packet; she then introduced Councilman Tisdale and Grace Aaron, consultant.

Ms Pickich reviewed the items on the agenda, presenting an overview of the CDBG Entitlement Program and CDBG resources available to fund Program Year 2022 projects. She directed attention to page 4 of the agenda packet, presenting proposed projects for PY2022. Mr. Moore asked if the City had any grant funds available to assist with developing a grocery store co-op in East Biloxi. Ms Pickich explained the City had budgeted PY2019 CDBG funds for an East Biloxi small business forgivable loan program but since no applications were received - in spite of considerable public outreach - the funds were reallocated to another CDBG project. Ms Pickich recommended that Mr. Moore meet with Mayor Gilich or Gerald Blessey to ask about the Biloxi Main Street area grant program.

Mr. Moore said he'd met with the Mayor about the proposed project, explaining that Phase 1 will involve construction of an approximately 7,000 s.f. building on the northeast corner of Division and Caillavet that will include some lease space for vendors. Membership in the co-op is \$100 and, when asked about the project area to be served, he identified White Avenue as the western border, bound by Back Bay to the north and east and the Mississippi Sound to the south. Mr. Moore said a market study had been conducted for a study area that extended to Debuys Road.

Ms Pickich again recommended that Mr. Moore meet with someone with the Biloxi Main Street Program about available grant assistance as well as with Beverly Martin, the Harrison County supervisor representing the project area. Mr. Jackson asked about availability of American Rescue Act funds for the co-op project, which Ms Pickich said her office was not involved with. Ms Pickich indicated Supervisor Martin may have information about that, also. Mr. Jackson invited all present to a June 2 Community Action Meeting for the Resilient East Biloxi Redevelopment Project that will include discussion of the co-op project.

Ms Pickich thanked Mr. Moore and Mr. Jackson and asked if there were any questions or comments about information in the agenda packet. There being none, she turned the floor over to Ms Aaron, who reviewed additional opportunities residents and other interested parties have to participate in developing the 2022 Action Plan. She explained that on June 23, the draft 2022 Action Plan will be posted for public review on the City's website and hard copies will be available for public review at City Hall, the Community Development Department, the Biloxi Housing Authority Administrative Offices, and

all branches of the Biloxi Library. She encouraged those present to review the draft document and provide written comments to the City prior to the July 25 deadline.


Reminding those present of the 15% cap on public services, Ms Pickich indicated that the City anticipated budgeting up to \$70,000 for those activities. She said that by the June 22 public hearing, review of the applications would be complete and that she anticipated the Mayor's recommendations for funding would be announced. Mr. Moore asked if the co-op project would be eligible to apply for the public services funds and Ms Pickich explained that they are limited to nonprofits that provide a high priority community service or program during that specific program year that directly benefits eligible residents of Biloxi, such as affordable daycare services provided by Moore Community House.


The representative from the Biloxi Boys and Girls Club stated they would be applying to the City for CDBG public service funds and Ms Pickich reminded her that the deadline is June 1. She asked the BBGC representative to speak with her following the hearing if she had questions about the application or review process.


Councilman Tisdale provided information about development of the City's fiscal year 2022-2023 budget and timeframe, recommending that those who planned to ask for City support should contact the City prior to July. The BBGC representative said their proposed new facility also will be developed in phases as funds become available, with a Phase 3 gymnasium anticipated to be constructed in 2024.


Ms Washington asked if any City funds were budgeted to renovate private property on Main Street north of the CSX Railroad tracks. Ms Pickich stated that she could only address questions regarding use of the City's CDBG funds and that unless renovation of a privately-owned building resulted in the direct creation of jobs or housed a public activity that was open to the public during regular business hours, it would not be eligible for CDBG assistance. Ms Aaron suggested that the Mississippi Department of Archives and History may have funds available to help preserve buildings with local historic significance and also suggested Ms Washington to check with the Mississippi Heritage Trust.

There being no additional questions or comments, Ms Pickich reminded everyone that a second CDBG public hearing is scheduled for 5:30 p.m. on June 22, in the same location, and that the public review draft of the 2022 Action Plan will be posted on the City's website as well as at City Hall, the Community Development Department, Biloxi Housing Authority and Biloxi Libraries. She thanked everyone for attending and closed the hearing at 6:25 p.m.

Summary

The 2022 One-Year Action Plan is a requirement of the U.S. Department of Housing and Urban Development (HUD) that is designed to develop a coordinated and cooperative effort to identify housing, community development and supportive housing needs of the City of Biloxi. The Action Plan is based on prioritized needs and strategies for meeting those needs identified in the 2020-2024 Consolidated Plan.

Both the Action Plan and Consolidated Plan are designed by HUD to consolidate the planning and application requirements of four HUD formula grant programs:

1. The Community Development Block Grant Program (CDBG)
2. Home Investment Partnerships (HOME)
3. Housing Opportunities for People With AIDS (HOPWA)
4. Emergency Shelter Grants (ESG)

The three broad goals of these four HUD programs are as follows:

1. To provide decent housing;
2. To provide a suitable living environment; and
3. To expand economic opportunities.

Community Development Block Grant Program

Biloxi is an entitlement city under the rules of HUD's Community Development Block Grant Program (CDBG) and as such, receives an annual allocation of funding, which in Program Year 2022 is \$415,164. Biloxi does not receive an annual allocation of funds under the HOPWA, ESG or HOME programs but must work with other agencies to compete for funding from the programs.

During PY2022, the City anticipates generating program income of about \$175,784 based on previous years. At this time, the amount of entitlement allocated funds and program income previously allocated but unexpended is estimated to be approximately \$57,512, which will be carried forward and budgeted for use in PY2022. Any other funds carried forward for use in PY2022 will be reallocated to the East Biloxi East-West Neighborhood Access Road Project, Phase II.

Availability of Information

Information concerning the Action Plan, the Consolidated Plan, the Assessment of Fair Housing/Analysis of Impediments to Fair Housing Choice and the Community Development Block Grant Entitlement Program are available for public review at the Biloxi Federal Programs Manager's Office, located at 214-A Delauney Street in downtown Biloxi, between the hours of 8 a.m. and 4:00 p.m., Monday through Friday.

National Objectives of Community Development Block Grant Program

1. Projects that principally benefit low- and moderate-income persons. A project or activity will be considered to principally benefit low- and moderate-income persons if it is designed to meet identified needs of low- and moderate-income persons.
2. Projects that prevent or eliminate slums or blight.
3. Projects designed to meet needs having a particular urgency.

PROJECTS MUST MEET AT LEAST ONE OR MORE OF THE ABOVE NATIONAL OBJECTIVES.

Examples of Basic Eligible Activities for the CDBG Program

1. Acquisition of property for a public purpose.
2. Public facilities infrastructure improvements including water improvements, wastewater improvements, solid waste improvements, streets and storm drainage improvements, etc.
3. Urgent needs and emergency grants to address community development needs having a particular urgency because existing conditions pose a serious and immediate threat to the health or welfare of the community.
4. Interim assistance requiring immediate action to alleviate emergency conditions.
5. Relocation payment and assistance for permanently or temporarily displaced individuals, families, businesses and organizations, and reimbursement for loss of rental income incurred in holding housing units to be utilized by relocation of individuals and families displaced by program activities.
6. Special economic development activities.
7. Public services to address high priority unmet community needs.

Consultation Meeting Minutes

Kristin Greger, Biloxi Community Rating System (CRS) Coordinator, attended the 9:30 a.m. consultation meeting for agencies with primary responsibility for Emergency Management/Hazard Mitigation, Management of Flood Prone Areas, Public Land or Water Resources. Susan Pickich, Biloxi Federal Programs Manager, and Grace Aaron, Consultant, also were present.

Ms Pickich thanked Ms Greger for attending and explained the purpose of the meeting, referring to the agenda packet that included a CDBG Fact Sheet. They discussed the City's current CRS rating, which is a voluntary incentive program to encourage local floodplain management activities that exceed the minimum federal requirements. Ms Greger confirmed that the City's currently rated a Class 6, basically because of recent changes in the national program's requirements. She agreed with Ms Aaron that the CRS program has directly benefited Biloxi residents through reductions in flood insurance premium rates and also in terms of reducing flood risks for residents.

Ms Greger explained that changes made in 2021 to the National Flood Insurance Program (NFIP) are only now coming to the attention of many Biloxi residents because policies renewing on or after April 1, 2022 are subject to a new risk rating methodology that factors in a property's distance to a flooding source – regarding of the property's elevation – which likely will result in flood insurance premium increases for most Biloxi property owners. NFIP's new pricing methodology, nicknamed "Risk Rating 2.0," is based on a unique flood risk profile for each individual property to "ensure any rate increases or decreases are uniform and equitable" across the nation.


When asked about MEMA's revised organizational structure in terms the City of Biloxi's responsibilities for hazard mitigation planning, Ms Greger said that there currently is a countywide, approved plan in place but that the next update may be prepared at the MEMA district level with input provided by local municipalities and counties.

There being no other comments or questions, Ms Pickich thanked Ms Greger for her input and invited her to continue participating in development of the 2022 Action Plan, then ended the meeting.

Ms Aaron said that on at least two occasions, the City had scheduled meetings to assist interested businesses in applying for the grants.





Statewide Analysis of Impediments to Fair Housing Choice, summarized by the Mississippi Home Corporation

July 2021

In 2019, the Mississippi Home Corporation (MHC) in collaboration with the state's other 57 entitlement entities – including the City of Biloxi and Biloxi Housing Authority - completed the nation's first ever statewide comprehensive Analysis of Impediments to Fair Housing Choice assessment (AI) to better identify impediments to fair housing choices statewide.

MHC's determined approach was to more effectively and efficiently incorporate into planning processes the duty to affirmatively further the purposes and policies of the Fair Housing Act, which not only prohibits discrimination but, in conjunction with other statutes, directs HUD's program participants to take significant actions to overcome historic patterns of segregation, achieve truly balanced and integrated living patterns, promote fair housing choice, and foster inclusive communities that are free from discrimination.

A prioritization of the contributing factors identified for each fair housing issue and a justification for the prioritization was established in each jurisdiction. In prioritizing such factors, program participants gave highest priority to those factors that limit or deny fair housing choices and access to opportunity, or negatively impact fair housing or civil rights compliance.

Each of the partners in conjunction with MHC held a Fair Housing Public Input meeting. This created an opportunity for the public to provide commentary about fair housing issues impacting their communities. MHC facilitated 36 of the state's 64 Fair Housing Public Input meetings statewide with an estimated 1,000 people in attendance. Participants at statewide public meetings were able to paint a better picture describing locations where disparities in access to opportunity were experienced.

By working collaboratively with every housing authority and the state's six largest cities, MHC created the state's most highly detailed housing analysis ever developed that has shaped policy changes to drive new program initiatives and funding projects for the next five years.

Never before in the United States has an entire state engaged in a comprehensive statewide collaborative effort to identify and analyze the nature and extent of barriers to fair housing through an Analysis of Impediments to Fair Housing Choice assessment.

Consultation Meeting Minutes

Tina Ross Seamans, Executive Director of the Biloxi Bay Area Chamber of Commerce (BBACC), attended the 9:30 a.m. consultation meeting regarding Broadband Service Providers and Those Working to Narrow the Digital Divide. Susan Pickich, Biloxi Federal Programs Manager, and Grace Aaron, Consultant, also were present.

Ms Pickich explained the purpose of the meeting and thanked Mrs. Seamans for attending. They discussed the agenda items and gave examples of how the City of Biloxi previously used CDBG Entitlement Program resources. As an example of a successful CDBG project, they discussed East Biloxi East-West Access Road Project, Phases I and 2. Mrs. Seamans stated that the Phase I section of the new road was a “definite improvement in the neighborhood” where she grew up. She agreed that preserving and improving neighborhoods, especially in lower income areas, is important for the community as well as for residents in the project area.

Mrs. Seamans said the Chamber relies on reliable and affordable broadband Internet services in Biloxi for numerous Chamber activities, from providing regular membership services throughout each year to scheduling ribbon cuttings and promoting new businesses. She explained how the Chamber’s numerous monthly information “blasts” that are emailed to general members, committees and special projects volunteers are much more cost effective and efficient than using the U.S. Postal Service. Being able to exchange a similar amount of information each month with hundreds of members would be impossible with her small staff if they didn’t have reliable broadband Internet access.


They then discussed how the Chamber supports efforts of the Biloxi Public School District and some other nonprofit members who work to narrow the digital divide in Biloxi. Mrs. Seamans said the pandemic emphasized how important it is for all residents to have access to the Internet since word-of-mouth communication was limited by state and local restrictions limiting the size of meetings and events in addition to social distancing mandates. She said that keeping track of children’s school assignments; changes in businesses’ operating hours; using restaurant and grocery store drive through/pick up services; and participating in healthcare virtual appointments relied on the Internet.

Ms Pickich invited Mrs. Seamans to continue sharing her input during development of the 2022 CDBG Action Plan, referring to the public participation schedule on the second page of the agenda packet and the comment sheet provided. There being no additional questions or comments, the meeting was concluded.

NOTE: Gregory Capranica, General Manager of Sparklight (broadband service provider) emailed that he would be out-of-state during the May consultation meeting. The May 2 letter of invitation mailed to Mr.

Capranica included a schedule identifying other citizen participation opportunities available to him to encourage his participation in developing Biloxi's 2022 Action Plan.

Net neutrality is the principle that Internet service providers treat all data on the Internet the same and not discriminate or charge differently by user, content, website, platform, application, type of attached equipment, or method of communication.

Internet Network Management

Do network management tools or techniques target specific usages or applications or focus in a content-neutral manner on bandwidth usage in real time, with the goal of providing reasonable and equitable access to the network for all similarly situated customers?

Narrowing the Digital Divide in Biloxi

The Internet was developed for the “free exchange of ideas, information and knowledge.” It has simplified our lives by its ability to connect users to like-minded people, communities, shopping, healthcare services and information that is used to inform, enhance and entertain us.

The **digital divide** refers to the gap between those with regular, effective access to digital and information technology and those without this access. It encompasses both physical access to technology hardware and, more broadly, skills and resources which allow for its use. Research about access to and use of technology points to a digital gap or “divide” along the lines of location (rural vs urban), income, age and education. This is important because lack of access to affordable, regular, high-speed internet connections may negatively impacts lives.

Location

Nearly one-quarter of rural Americans say access to high-speed internet is a major problem where they live. (source: 2018 Pew Research Center survey “What Unites and Divides Urban, Suburban and Rural Communities”) A lack of available Internet access can have negative impacts on people’s health according to research that found rates for seven leading causes of death were higher in rural than urban communities. (source: *Health Affairs*, “Healthy People 2020: Rural Areas Lag in Achieving Targets for Major Causes of Death,” December 2019)

Income

Income is also a factor contributing to the “digital divide.” A 2019 Pew Research Center study identified that 44% of lower-income adults (those with annual household incomes less than \$30,000) didn’t have home broadband services. Nearly half (46%) of low-income Americans lacked a computer and 29% didn’t own a smartphone.

Like location, not being able to afford a computer or Internet connection service can negatively impact one’s health. For example, those who could not afford a computer or Internet connection services were not able to benefit from wider availability of “video visits” with physicians during the pandemic when in-office healthcare services were not always available. Without a computer or Internet access, lower-income people also may not have access to other telehealth services like remote monitoring at home using web-based or mobile devices that capture and deliver patient data in real time to clinicians at other locations.

Age and Education

The “digital divide” is not always created by lack of income or lack of availability of Internet access or problems in infrastructure in a certain geographic area, it also includes a divide that may be created by age and/or education. Without an interest in or exposure to computer technology, some people choose not to adapt to modern ways of accessing information and services or are overwhelmed by the speed of technological advances that require an openness to change.

Critical thinking and information analysis generally aren’t innate skills but are necessary to understand the ways that technology is used and how information is being communicated to the general public by the media and social media.

With Internet and media “filter bubbles,” it is becoming harder to distinguish between “real” news and “fake” news because of the content filters that exist when searching in Google, for example. Based on past searches, Internet information systems filter results based on a person’s interests or themes in online activity, catering to those interests and thus narrowing the online experience.

This can shape how people think because the Internet can limit information to skew it to reflect our opinions or values, based on our past on-line activity. We think we’re receiving unbiased information from unbiased sources but, in reality, we aren’t. Without applying critical thinking skills to burst the “filter bubbles,” most people don’t reflect on their digital presence and accept a narrowed perception of information sharing that re-enforces rather than breaks down biases, contributing to the gap

With the world adapting to the pandemic in many new ways, it also means that newer and better skills are expected from people doing any job in any walk of life. Regardless of where one lives, income, age or education, to be competitive everyone must keep up with the times and constantly keep learning and honing existing technology skills.

Some learn to upskill on an on-going basis; some switch jobs to lower-tech occupations; some learn to function in the modern world with minimum adaptation only when it’s absolutely necessary, but in all these cases there is choice involved. To minimize the gap between ever-changing technology, both private and public platforms will need to keep investing and developing digital ecosystems that create affordable and effective education and training programs at a larger scale that enables all who choose to participate in the digitally-driven modern world to do so, regardless of income or location.

Biloxi Residential Internet Coverage

As one of the biggest cities in Mississippi, Biloxi has a lot to offer its residents. This is a coastal city that has an extremely large military population. The internet offers residents ways to conduct business, study, stay entertained, and stay in contact with loved ones. **Overall, 100% of the city has one or more internet connection options.**

There is only one cable provider in Biloxi. ~~Cable One~~ Sparklight offers residential and business service in all of Biloxi, not to mention much of the city's outlying areas.

DSL has a lot in common with cable, particularly in terms of speed and price. If you're interested in a DSL plan, consider **AT&T**. The AT&T network in Biloxi reaches 92% of the city with various residential and business service options and extends into many local suburbs.

There is a third broadband business service provider option in this region, **OOMA Broadband**.

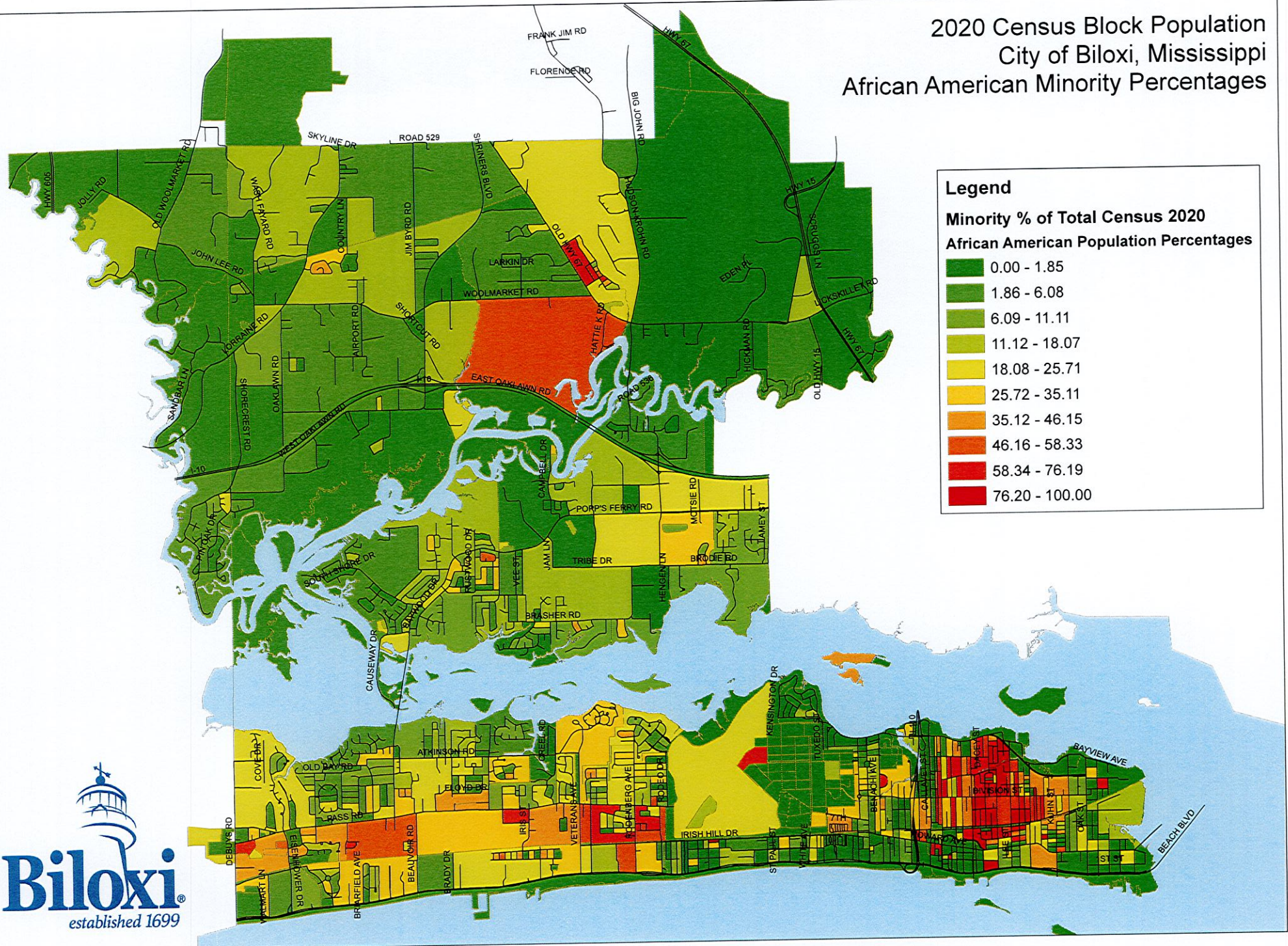

2020 Census Block Population City of Biloxi, Mississippi African American Minority Percentages

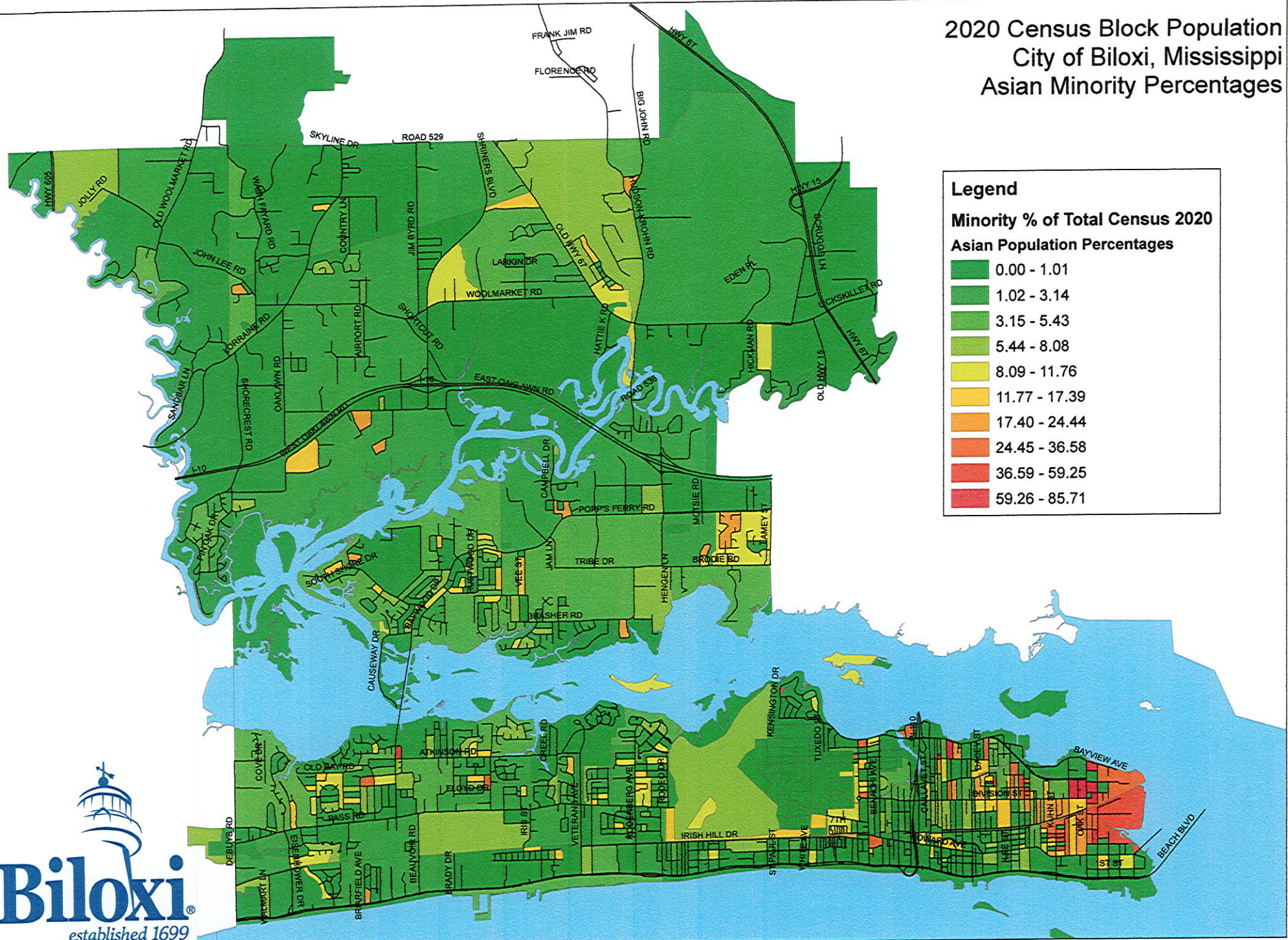


