NARRATIVE STATENT

CR-05 - Goals and Outcomes

Progress the jurisdiction has made in carrying out its strategic plan and its action plan. 91.520(a)

With the successful completion of the East Biloxi East-West Neighborhood Access Road, Phase I during Program Year 2020, the City was successful in transitioning into Phase 2 of this CDBG-funded, major infrastructure project. Phase I involved right-of-way acquisition and construction of a two-lane vehicular access road between Dorries and Crawford Streets, north of the CSX Railroad tracks. That phase directly serves the 4,285 people living in the project area, of which 2,685 or 62.66%, qualify as low- to moderate-income. Phase 2 also involves right-of-way acquisition and construction of a two-lane vehicular access road between Hopkins Boulevard and Porter Avenue, serving a project area that includes 2,450 residents, of whom 1,325 or 54.08% are low- to moderate-income. Improved transportation connectivity in this historic neighborhood will enhance public health and safety and improve emergency response times. During PY2021, Phase 2 survey, preliminary design work and environmental review were completed; construction is anticipated to begin in PY 2022 and be completed in PY2023.

In PY2021, four subrecipients delivered public services to help address high priority community needs identified in Biloxi's 2020-2024 ConPlan, which benefited a total of 247 residents, 100% of whom are low- to moderate-income.

Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

The City of Biloxi's Program Year 2021 goals included funding necessary activities that precede construction of a federally-funded infrastructure project, such as design and environmental review. These activities were completed on schedule and construction is anticipated to begin in

PY2022 for East Biloxi East-West Neighborhood Access Road, Phase 2. To achieve ConPlan goals to help address high priority community needs, the City budgeted \$70,000 of its CDBG resources and contracted with experienced agencies to provide public services that benefited 247 LMI residents through: improved access to affordable, educational childcare; a therapeutic youth program for those who have experienced domestic violence; assessment and mental health services provided primarily to homeless residents; and support for a summer education camp for income-eligible youth. For two of these activities, proposed targets were exceeded. The Coastal Family Health Center provided mental health assessments and treatment services to 68 residents rather than the 150 proposed. The considerable amount of federal funding made available to support the needs of homeless persons during the pandemic likely made the City's goal unrealistic. Likewise, the pandemic likely impacted participation in the PY2021 summer education camp, with 21 attending instead of the 25 proposed.

During PY2021, no CDBG-CV funds were expended by the City and no additional households were served through the public service activity to provide rent assistance for eligible residents negatively impacted by the coronavirus. The City anticipated assisting 20 households/70 residents and successfully assisted 25 households/65 residents with rent assistance before the influx of federal assistance made it virtually impossible for the City to comply with Duplication of Benefit documentation requirements. The City considers this activity, identified as Public Services-Natural Disasters & Emergencies in the above table, a success in terms of meeting a high-priority community need for emergency shelter and transitional housing early in the COVID-19 crisis, rather than an example of a lack of progress when it wasn't prudent for the City to expend CDBG-CV funds in PY2021 in compliance with federal requirements.

In terms of assessing annual use of funds, the City made progress toward its goals to provide: Transportation Improvements, which include high priority street improvements to enhance public safety and neighborhood connectivity in primarily LMAs; Public Services to address high priority needs; assist LMI residents with housing needs during Natural Disasters and Emergencies.

CDBG-CV funds were budgeted in the City's 2019 AAP and goals were included in the previous 2015-2019 ConPlan but expected and actual goal accomplishments are identified in the table above, which also addresses CDBG-funded goals for the 2020-2024 period. The City worked with HUD, the Open Doors Homeless Coalition and other nonprofit organizations, but efforts to structure a Nonprofit Facility Improvement Project that included acquiring and reconfiguring an existing building into a homeless shelter and assessment center, to be partially funded with the City's \$939,808.99 in unexpended CDBG-CV funds, was not successful. No CDBG-CV funds were expended for the Nonprofit Facility Improvements Goal and the five residents expected to be assisted were not.

Narrative

During PY2021, the City budgeted 100% of its Round 1 allocation of CARES Act funds to a rent assistance program administered by the Open Doors Homeless Coalition to prevent an increase in homelessness in Biloxi caused by the coronavirus. During PY2020, 25 LMI households, comprised of 65 total people, benefited from this public service activity, which was planned to continue into PY2021. However, with rent assistance subsequently being made available through several federal agencies, the City's ability to document compliance with Duplication of Benefit requirements limited its rent assistance expenditures to \$54,404.01; no additional CDBV-CV funds were spent in PY2021 and no additional households were assisted during PY2021.

Because the City's CARES Act funds were budgeted in the 2019 AAP, goals were included in the previous 2015-2019 Consolidated Plan and beneficiaries were reported in the PY2020 CAPER, racial and ethnic data for the CDBG-CV public services activity is not included in Table 2.

Narrative

In Program Year 2021, the City of Biloxi had a total of \$1,214,014.61 available in CDBG resources from the following sources: 2019 carryover \$435,524.23; 2020 carryover \$452,491.00; 2021 allocation \$183,570.92; 2021 actual Program Income. The majority of these funds were budgeted to a major CDBG-funded infrastructure project, the East Biloxi East-West Access Road Project, to primarily benefit residential areas in which a majority of households are low- to moderate-income. The project is designed to maintain and improve connectivity in the neighborhood north of the CSX Railroad tracks, which will improve public health and safety through improved emergency response times.

Narrative

The City of Biloxi does not invest its CDBG resources based on target or geographic areas; instead it plans, develops and funds CDBG-eligible projects that will help address high priority needs in the community as identified in its ConPlan. The City also considers the number of eligible residents who will benefit from project implementation, with the intent of providing suitable living environments for the highest number of LMI households possible.

Discuss the difference between goals and outcomes and problems encountered in meeting these goals.

The City does not anticipate adding housing construction, rehabilitation or acquisition to its CDBG program goals. Typically, the City does not invest its limited CDBG resources to build, rehabilitate or acquire housing due to the high cost of housing construction and increasing costs for property insurance south of Interstate 10 (there are no census blocks that qualify as low- to moderate-income in North Biloxi at this time). On-

going changes to the national flood insurance program are resulting in higher costs for homeowners, also. The City budgeted 100% of its first allocation of CDBG-CV funds to provide rental assistance on behalf of residents negatively impacted by the pandemic but was limited in its ability to expend those funds as detailed in CR-05.

Discuss how these outcomes will impact future annual action plans.

Unless the cost of housing construction, rehabilitation and insurance, as well as federal housing program elevation requirements and building restrictions change considerably, the City does not anticipate funding housing activities with its CDBG resources during the remainder of the period covered by its current ConPlan.

Narrative Information

Issues with elevation & changing federal flood insurance program rating criteria & requirements, compounded by limited CDBG resources, preclude the City from investing in housing in LMAs. Biloxi housing is no longer considered sustainable for low- to moderate-income households, based on high property insurance requirements, the high cost of elevating structures, and NFIP restrictions that now factor in a home's proximity to water bodies that may flood, rather than a home's base floor elevation, when calculating flood insurance premium costs. Federal program restrictions limiting housing redevelopment and retrofitting costs over a ten-year period also negatively impact housing quality and living conditions.

Evaluate the jurisdiction's progress in meeting its specific objectives for reducing and ending homelessness through:

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

During PY2021, the City of Biloxi continued to work with the Open Doors Homeless Coalition Continuum of Care and its member agencies to reduce and end homelessness in all categories within the City. Open Doors shared information with the City from its homeless population assessments to maintain awareness of the lack of available affordable housing and related needs of homeless individuals and families in Biloxi.

In collaboration with Open Doors, the City of Biloxi continued working with the Biloxi Housing Authority, Back Bay Mission, Gulf Coast Center for Nonviolence, the Biloxi Diocese and other agencies and stakeholders to share information about Biloxi's homeless and at-risk of homelessness populations and continued working with these partners to generate private donations to meet incidental needs of homeless populations. The City also continued to support funding applications of local nonprofit agencies to reduce the number of local homeless and unsheltered persons.

As part of the local effort to comprehensively address the needs of Biloxi's homeless populations, the City worked with the Open Doors Homeless Coalition, other regional nonprofits and the HUD Field Office during PY2021 to structure a CDBG-CV eligible project that included acquisition and redevelopment of an existing structure to serve as a homeless assessment center and emergency shelter facility. Following attempts to work with three different sites, the City and Open Doors concluded there was insufficient time remaining to implement a public facilities type project before the CDBG-CV expenditure deadline; the balance of the City's unexpended CDBG-CV funds will be returned to HUD in PY2022.

Addressing the emergency shelter and transitional housing needs of homeless persons

Ongoing community effort to provide emergency shelter and transitional housing for the unsheltered in Biloxi will continue on a case-by-case basis, led by the Open Doors Homeless Coalition. Related needs of homeless populations will be met as funding and other resources become available.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions);

and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

During PY2021, the City continued to work in collaboration with the Open Doors Homeless Coalition and participated in the effort to encourage local housing services agencies and religious institutions to expand services to help low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who were being discharged from publicly funded institutions and systems of care such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions. The City supported local and regional efforts to continue providing housing services and housing-related assistance programs that were expanded in response to the pandemic, such as expanded access to rent, utility and security deposit grants, expanded access to affordable housing for income-eligible households including those being discharged from publicly funded institutions and systems of care.

The City of Biloxi continued to support the public and private agencies that address housing, health, public services, employment, education and youth needs by endorsing their applications for funding assistance and providing technical assistance, as feasible, with the City's limited staff and resources. The City also continued to support Biloxi Housing Authority's ongoing Community and Supportive Services activities and programs.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

During PY2021, the City continued to work with Open Doors Homeless Coalition to provide services that expanded access of homeless persons, especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth, to existing affordable housing through rent, utility and security deposit assistance. The City budgeted 100% of its first allocation of CDBG-CV funds for a rent assistance program administered by its subrecipient, the Open Doors Homeless Coalition. With the goal of addressing existing homelessness and preventing increased homelessness as a result of COVID-19, the program offered up to six consecutive months of rent and utility assistance on behalf of qualified Biloxi residents. The City supported Open Doors' efforts to prevent repeat homelessness through ongoing case management assessments and services that included providing access to workforce training, educational advancement and life skills development.

CR-30 - Public Housing 91.220(h); 91.320(j)

Actions taken to address the needs of public housing

During PY2021, the City continued working with the Biloxi Housing Authority to maintain open communication regarding local efforts to meet residents' affordable housing needs, based on available resources. Examples of collaborative actions include development of the City of Biloxi-Biloxi Housing Authority 2019 Analysis of Impediments to Fair Housing Choice and conducting an annual fair housing education workshop hosted by the City, BHA and the Mississippi Center for Justice.

Actions taken to encourage public housing residents to become more involved in management and participate in homeownership

The Biloxi Housing Authority continued to support its Resident Councils and the FSS Program to encourage public housing residents to become more involved in management and participate in home ownership. During PY2021, the City and BHA worked collaboratively to encourage public housing residents to attend CDBG-related public hearings as well as the annual fair housing education workshops.

Actions taken to provide assistance to troubled PHAs

CR-35 - Other Actions 91.220(j)-(k); 91.320(i)-(j)

Actions taken to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment. 91.220 (j); 91.320 (i)

Biloxi's official zoning district map allows for a mixture of single- and multi-family residential units on varying lot sizes throughout the City as well as group homes in a variety of areas. Land use regulations support sustainability measures and provide for density bonuses when combined with natural resource preservation and/or other public benefits. Mixed use zoning is permitted in the central business area.

The City has adopted the latest version of the International Building Code, which requires compliance with Americans with Disabilities Act and Fair Housing Act provisions. There are no specific growth limitations or other public policies in place that would affect return on residential investment. Unlike construction costs and insurance premiums, property taxes in Biloxi have not increased during the last 23 years.

The City was successful in its effort to have three areas in East Biloxi federally-designated as opportunity zones, providing the private sector with financial incentives to invest in these primarily low- to moderate-income areas.

Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

During PY2021, the City continued working with other local units of government, religious institutions and area nonprofits to share information regarding the needs of underserved members of the community as part of an overall effort to encourage increased private support to address those needs. The City continued to work with local nonprofits, which included assisting Moore Community House in its ongoing efforts to secure suitable facilities to support expansion of affordable daycare services. The City also continued to work with the Open Doors Homeless Coalition and other nonprofit agencies to identify an existing facility to acquire and redevelop as a homeless assessment center and emergency shelter during PY2021.

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

Throughout PY2021, the City of Biloxi shared information with residents, developers and others about lead-based paint hazards through free information brochures available at City Hall and in the Building Division. The City continued to support the educational outreach efforts of the Mississippi State Department of Health, which re-enforces awareness of the serious health hazard LBP poses, particularly to children under the age of six. All of the Biloxi Housing Authority's housing units have been assessed and, where required, LBP hazards have been abated.

Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

In spite of the on-going pandemic, the City continued its efforts to recruit new and expanding businesses to Biloxi as part of its effort to expand employment opportunities and reduce the number of poverty-level families. While no official goals, programs or policies have been adopted, the current administration has an informal "open door" type policy, encouraging potential developers and existing business and industry leaders to meet individually and as groups with the Mayor, CAO and employees responsible for various steps of the local development process. The City also is actively involved with two Chambers of Commerce and the Gulf Coast Business Council to identify growth opportunities that will benefit residents' quality of life by improving their living environments and expanding the tax base rather than raising taxes. The City works to limit expenditures, which also helps limit the cost of utility and recreation-oriented user fees.

During PY2021, the City continued to support participation of the Biloxi Housing Authority in the HUD/HCV/Family Self Sufficiency Program to help reduce the number of poverty-level families.

Actions taken to develop institutional structure. 91.220(k); 91.320(j)

Through its participation as an active member of the Open Doors Homeless Coalition, the City stayed informed about programs and services provided by area nonprofits during PY2021. City leaders and staff also maintain ongoing communication with the Biloxi Housing Authority, public housing residents, the Biloxi Catholic Diocese, local nonprofit agencies and other local units of government as part of the City's ongoing effort to encourage development and implementation of rental housing assistance programs to improve access of low- to moderate-income households to Biloxi's existing housing stock and to address homelessness.

Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

The City's participation in the Open Doors Homeless Coalition Continuum of Care activities and meetings continued in PY2021 to enhance coordination between the City and public and private housing and social service agencies. A positive outcome of the pandemic has been an increased level of support from many nonprofit organizations to more comprehensively address the needs of Biloxi's homeless and special needs populations, through activities such as Open Doors' annual Point in Time count and the numerous food, clothing and toy drives coordinated by collaborating nonprofits to maximize benefits to underserved residents. Enhanced coordination has helped reduce duplication of services while increasing community morale.

Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)

In PY2021, the City collaborated with the Biloxi Housing Authority and Mississippi Center for Justice to provide information about residents' rights under the Fair Housing Act through public notices and free brochures available to the public at City Hall, Community Development and Engineering. The annual Fair Housing Workshop hosted by these three public entities was conducted late in the program year after waning of the pandemic.

Fair housing education information continued to be published periodically in the City's monthly "Bmail," a multipage newsletter that is mailed to approximately 25,000 households and businesses in Biloxi and free brochures were made available at City Hall and the Community Development and Engineering Departments to share Fair Housing Act information and to define how complaints may be filed for Fair Housing Act violations.

CR-40 - Monitoring 91.220 and 91.230

Describe the standards and procedures used to monitor activities carried out in furtherance of the plan and used to ensure long-term compliance with requirements of the programs involved, including minority business outreach and the comprehensive planning requirements

On an ongoing basis during PY2021, the City monitored its performance investing limited CDBG resources to meet program goals through timely expenditure of these funds. As part of its formal annual performance assessment, the City conducted a public hearing to inform the public of progress made toward implementing and completing CDBG-funded projects and activities. The City complied with existing policies and procedures that help monitor CDBG program administration and regulatory compliance. To ensure comprehensive CDBG Entitlement Program compliance, the staff monitored specific areas as follows: program performance review; financial management practices; record keeping and reporting practices; general management practices; compliance with EEO, Fair Housing, ADA, anti-discrimination and others.

Expenditures were monitored on an on-going basis throughout implementation of each project/activity to ensure timeliness of expenditures and compliance with project budgets as well as to eliminate opportunity for mismanagement, fraud or waste.

In addition to ongoing desk reviews supported by monthly reports, emails and telephone conversations, each subrecipient was monitored on site in compliance with Biloxi's SOPs pertaining to its CDBG subrecipients. The City takes corrective action as soon as an issue becomes apparent to minimize compliance issues and opportunities for misuse of funds.

City staff participated in HUD-sponsored webinars on an on-going basis throughout PY2021 and incorporated HUD guidance into its programs and operating procedures. The staff also regularly communicated with the HUD Field Office and reviewed the HUD Exchange website for program compliance updates.

City compliance with applicable federal regulations and policies was specifically discussed at each CDBG public hearing, including comprehensive planning and timeliness of expenditures. Compliance with minority business outreach requirements was ensured through ongoing implementation of the City's procedure requiring all HUD-funded Requests for Proposals and Requests for Qualifications be provided in a timely manner to the Mississippi Contract Procurement Center and mailed, return receipt requested, to known minority and female-owned firms.

The City's outreach to minorities and women included posting information in English, Spanish and Vietnamese on the City's website and in public buildings located throughout the City, including at the Biloxi Housing Authority housing sites. Written flyers were distributed in English, Spanish and Vietnamese to known local nonprofits that serve and/or represent minorities, low-income residents, and nonEnglish-speaking residents.

Citizen Participation Plan 91.105(d); 91.115(d)

Describe the efforts to provide citizens with reasonable notice and an opportunity to comment on performance reports.

The City complied with its Citizen Participation Plan requirements by making every effort to encourage broad public input into development of activities and programs assisted with CDBG Entitlement Program resources. The City of Biloxi published and posted notices and delivered flyers in English, Spanish and Vietnamese to known nonprofits that primarily serve nonEnglish-speaking residents, low-income residents, minorities and persons with disabilities as part of its overall effort to provide citizens with reasonable notice and opportunity to comment on performance reports and other HUD-required plans and reports. All CDBG-related flyers and notices invited and encouraged the participation of all residents into the CDBG process through submission of oral and written comments.

The City of Biloxi also made its Consolidated Annual Performance and Evaluation Report (CAPER) draft available to the public for examination and comment for a period of 15 days and notified the public about the report's availability for review on its website, in a notice published both in the local newspaper and in the monthly Bmail newsletter in addition to posting notices in public buildings. At 5:30 p.m. on Tuesday, November 15, 2022, Susan Pickich, Biloxi Federal Programs Manager, opened the public hearing regarding administration and performance evaluation of the City's Program Year 2021 CDBG Entitlement Program. She introduced herself and Grace Aaron, CDBG consultant, and welcomed the one attendee, Paul Tisdale, Councilman Ward 5.

Ms Pickich explained the purpose of the public hearing was to present a public review draft of the 2021 Consolidated Annual Performance and Evaluation Report (CAPER) and to provide an opportunity for the public to ask questions and provide oral and written comments regarding the City's program performance and the draft report. A proposed amendment to the City's Citizen Participation Plan also is under consideration, which would re-insert the requirement for publication of CDBG-related notices in the local newspaper of general circulation (the *Sun Herald*).

Following a review of agenda items, Ms Pickich reviewed the City's PY2021 CDBG project budget and identified actual CDBG funds expended and goals/objectives achieved. She reported that goals established for the Program Year 2021 were achieved and construction will begin during PY2022 on Phase II of the East Biloxi East-West Neighborhood Access Road Project, with completion of preliminary design and environmental review in PY2021.

Following her presentation, there was a discussion about the use of CDBG-CV funds allocated to the City that had been proposed for use in developing a homeless assessment center and shelter in partnership with the Open Doors Homeless Coalition. Ms Pickich and Ms Aaron explained the various project configurations that had been proposed and the issues that precluded implementation. With development of the timeline for development of the third proposed project, the City and Open Doors were made aware of the concurrent CARES Act expenditure deadline for the first and second allocations. After many more discussions, the City and Open Doors decided not to move forward with the assessment center and shelter. Ms Pickich verified that the unexpended balance of CDBG-CV funds is \$939,808.99.

There being no additional comments or questions, Ms. Pickich closed the hearing at 6:00 p.m.

CITY OF BILOXI PERFORMANCE HEARING

CDBG-CV ALLOCATION ROUND I

The city received a CDBG-CV Round I allocation of \$272,001.00 through the CARES Act. The city contracted with Open Doors Homeless Coalition to administer these funds to assist eligible Biloxi residents impacted by COVID-19 with rental assistance to prevent homelessness. 25 HHs were assisted, benefitting a total of 5 people. \$54,404.01 was spent during PY20 with the unexpended balance anticipated to be reprogramed in PY2021.

CDBG-CV ALLOCATION ROUND III

In spite of considerable effort working with HUD, the Open Doors Homeless Coalition and other local nonprofit organizations, the City was not successful in developing a Nonprofit Agency Facility Improvement Project, as identified as a ConPlan goal, that involved acquiring and reconfiguring an existing building into a homeless shelter and assessment center to be supported with all or a portion of its unexpended CDBG-CV fund balance of \$939,808.99. No CDBG-CV funds were expended for the Nonprofit Agency Facility Improvements Goal identified in the CR-05 table, and the five residents expected to be assisted were not.

NOTES:

Social Services:

CDBG funds were invested to support activities provided by local nonprofit agencies to address high priority, unmet community needs identified during development of the 5-Year Consolidated Plan and 2021 Action Plan. Funds were budgeted to support four public service agencies to: expand access to affordable, quality childcare and/or youth education services (Moore Community House, Gulf Coast Center for Nonviolence children's education program; Program Believe/Summer Youth Education Camp); and provide mental health assessments and treatment primarily to homeless residents.

Federal Capital Projects:

East BX E/W Neighborhood Access Road Project PH II - This Project will construct a continuous roadway, approximately 24 feet wide, on the north side of CSX Railroad from Hopkins Blvd to Porter Avenue. It will provide a transportation connection between neighborhoods to improve emergency response times in a low/mod area. This will be a multi-year project which includes an environmental assessment, engineering design, rights-of-way, acquisition/relocation, and construction. The engineering design services are under contract and underway. The environmental assessment is complete and awaiting final approval from HUD.

Homeowner's Rehabilitation Program:

The City contributed \$25,000.00 in **General Funds** to Back Bay Mission to support renovation of three homes. The funds were used to purchase materials to bring the homes into compliance with electrical and plumbing codes; labor was provided by volunteers.




