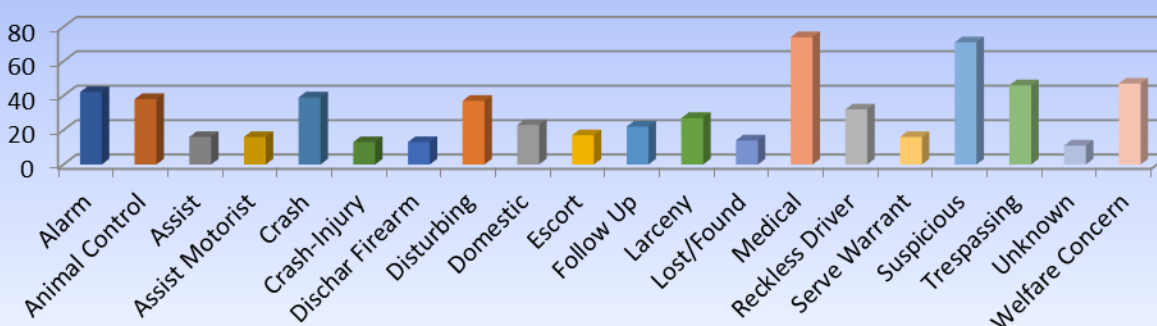
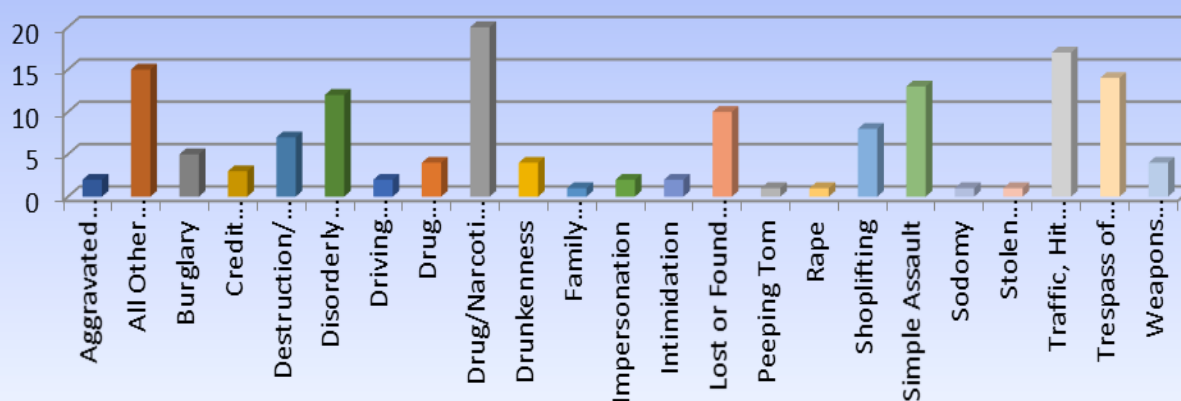

- Causeway Parking Floating docks (DN) – project awarded to JE Borries, project complete, ready to use
- Canaan Fishing Dock Improvements (reconstruction) (ML) – received DMR & Corps permits, on hold for GOMESA funding
- Cedar Lake Bridge Repairs (CL) – Plan to submit for MDOT Emergency Road & Bridge Repair Grant and BRIC Grant for M&E and structural repairs

- Concrete Annual Contract (DN) (ADS)
 - Concrete panels in The Bluff Subdivision – one side of street panels have been demo'd, concrete pour has been delayed due to extensive groundwater, all but 2 panels have been replaced and the driveways are finished
- CSX Crossings – Nixon and Dorries Closed: Delauney and Iroquois next
- Dredging – Tidelands grant for Parkers Creek boat ramp dredging was received. Permit mitigation issues with Subsurface Aquatic Vegetation being worked. Permit received for maintenance dredging in Point Cadet Marina, will start working on Parkers Creek boat ramp permitting contract
- East Biloxi Connector Road Porter to Hopkins (CL) (CDBG Funded) – appraisals have been started, expect to start making offers in December
- Fire Station No. 5 – acceptance of grant on 11/22/22 council agenda, Williams contract on next agenda
- Hwy 90 Small Craft to Oak Street Curb & Gutter Repairs – pending design contract, have conceptual
- Keesler Gate Outside (MH) – Completion date November 2022, expecting CO for MDOT electrical to traffic signal at exit ramp, expecting CO for water leave at a valve, final striping has been started and all light poles have been installed, pulling wire now
- Lighthouse Pier (GP) – design efforts continue, Corps permits out for public hearing
- Keegan Bayou Restoration (GP) – Permits being requested, GOMESA project submitted to DMR, also in the Restore Act Portal
- Kuhn St. Boat Launch Expansion (GP) – Conceptual started by Pickering, vegetation removal started, project scope revised to match tidelands funding grants, have 60% design review meeting this week

- Lorraine Road Water Line Extension Ph 2 (CL) – Design complete, ready to bid, ARPA application for funding submitted, water/sewer funding is available if not selected for ARPA
- Main Street Railroad Crossing Upgrades (CL) – Award to Gulf Breeze approved at 9/20 Council Meeting, MDOT authorization to award process is underway
- McDonnell Road Extension (DN) – Completed design of roadway and extension of utilities \$220K
- Oak Street Pier (South) (DN) – Cypress presented conceptual plans, working on a design contract
- Pickleball Restroom (GP) – design complete ready to prepare bid package, need funding
- Point Cadet Development #1092 (GP) – Machado Patano is working concept
- Point Cadet Living Shoreline (GP) – BMA started design, topo complete, Tidelands/National Fish and Wildlife Funding, cultural resource survey being scheduled, this is required by MDAH, have 90% set of plans to review
- Point Cadet Nearshore (CL) #1096 - Accepted the grant on 11/22/22 council meeting, waiting on contract from BMA for design
- Point Cadet Marina West (MH) – AnderCorp NTP 10/24, 240 day contract, construction laydown area complete, electrical components and floating docks is 58 weeks the change order to address delay of electrical components will be on the Dec. 20th agenda
- Popps Ferry Extension #913 (ML) – Coliseum has the draft MOU for Board approval; ROW acquisition continues, funding secured for construction, close one additional RR crossing and send final crossing design to CSD, final roadway design required, Plan is to bid in 2023 and begin construction in 2024
- Popps Ferry Bridge & Approaches (ML) – Ph I design complete, contract for right of way acquisition being developed, EA being updated, top priority to obtain funding to repair existing bridge, submitted to emergency road and bridge repair program
- Repair/Replace Contract (DN)
 - Franks Drive Storm drain – done
 - Park Drive Drainage – mobilizing this week
 - Boyette Drive Washout – done
 - Wildwood Lane – received PO, coordinating start date
 - Bilmarsan – waiting on paving
- Rodenberg at Pass Road Intersection (CL) – Activated with MDOT, kickoff meeting held and parcel research underway as initial steps in row & easement acquisition process starts

- Saenger Theater Restoration (MH) – ticket booth and entrance doors removed. Brick wash in progress and nearing completion, waiting on new brick for lower part of west façade, waiting on MDAH to approve parge coat color for concrete at base of west façade, waiting on change order to repair the signs (replace bulbs & repair) this should be the last CO, latest delivery date for new bricks for area beneath canopy is 12/12
- Sand Re-Nourishment #1064 (GP) – GOMESA Project, RFP for sand acquisition and trucking/spreading is in final draft, bids open the 14th of December
- Sediment Removal Phase III – hydrographic surveys complete, working on the permit applications, the sites that have SAV, Seymour is trying to work with DMR on a way to mitigate, Seymour updated council on Aug. 25th
 - Hiller Park Pond (have permits)
 - Cedar Lake Rd. Canal
 - Cedar Lake Broadus (have permits)
 - Kennedy Ln (SAV)
 - Savannah Estates (DMR stated not eligible)

- Shriners Blvd. Oaklawn to I-10 Widening – (Jason Overstreet) design contract is at MDOT for review
- Shriners Blvd. Water & Sewer Extension – (Jason Overstreet) awarded construction on 11/22/22, met with HCUA and discussed connecting to their line, we have enough existing funding to extend our line to loop with the HCUA line
- Small Craft to Oak St Boardwalk (MH) – waiting on summary change order and final payment for warranty period to begin
- Sports Complex #1093 – (Machado Patano) design kickoff meeting held
- Tanglewood Infrastructure Ph II – ARPA project that was not awarded, working on getting this project out to bid
- Visitors Center Repairs (CL) – Hopkins Construction for Zeta & non-Zeta repairs, Mangal's completed roof, now waiting clay tile and manufacturers roof warranty package, architect has started close out documentation
- Woolmarket Road Sidewalks (CL) – Sidewalk extended to Shriners Blvd., bid package reviewed by MDOT, working changes that resulted from MDOT review, environmental permitting documentation submitted and being reviewed by MDOT

- Woolmarket Road Traffic Study (CL) – Traffic counts for 3 intersection involving Shriners with (I-110, Shortcut, and Woolmarket Rd), 2 intersections with Old Hwy 67 (Hudson – Krohn, Woolmarket Road), and 1 intersection at Wash Fayard & John Lee Roads, activated with MDOT, contract at MDOT for review
- Woolmarket Water & Sewer Improvements Ph I (Tiffany, Oaklawn, Boyette, Shorecrest) – (Overstreet) working out details of the design contract with the consultant, planning to have this contract on the agenda before the end of December
