 BMA contract will review and then to get on council agenda for approval
- Point Cadet Marina Phase III have preliminary layout that needs approval so a cost estimate can be developed so we can be ready for round 3 of funding

 using the old lights from the tennis courts to replace softball and baseball lights
- Sport Complex Tennis Court Lights Received one proposal from Weaver Electric on Dec. 20th, met with Weaver again last week, the Bowmans were happy with the photometrics submitted by MUSCO, will get this on the council agenda for approval
