 - A. Zach Harris provided an update on the Reef Express, LLC (owner) Freddie Fountain w/Fountain & Assoc, LLC to discuss the request to remove five (5) protected trees for the property (Case No 23-083-PC), Ward 5, identified as 126 Debuys Rd Tax Parcel No. 1110M-03-008.002. The two damaged trees have been removed. He is checking on that property regularly.
 - B. DRC meeting Tuesday March 12, 2024 on the property at Point Breeze (Beach Blvd and Grandview Dr.) This plan will not be approved as provided for the meeting.
 - C. No tree hearings coming up.

They have even moved the roadway to accomplish this. He is working on having the tree documented to have it designated a Champion Tree when the State reinstitutes this program. The program is now administered by the State of Tennessee.
