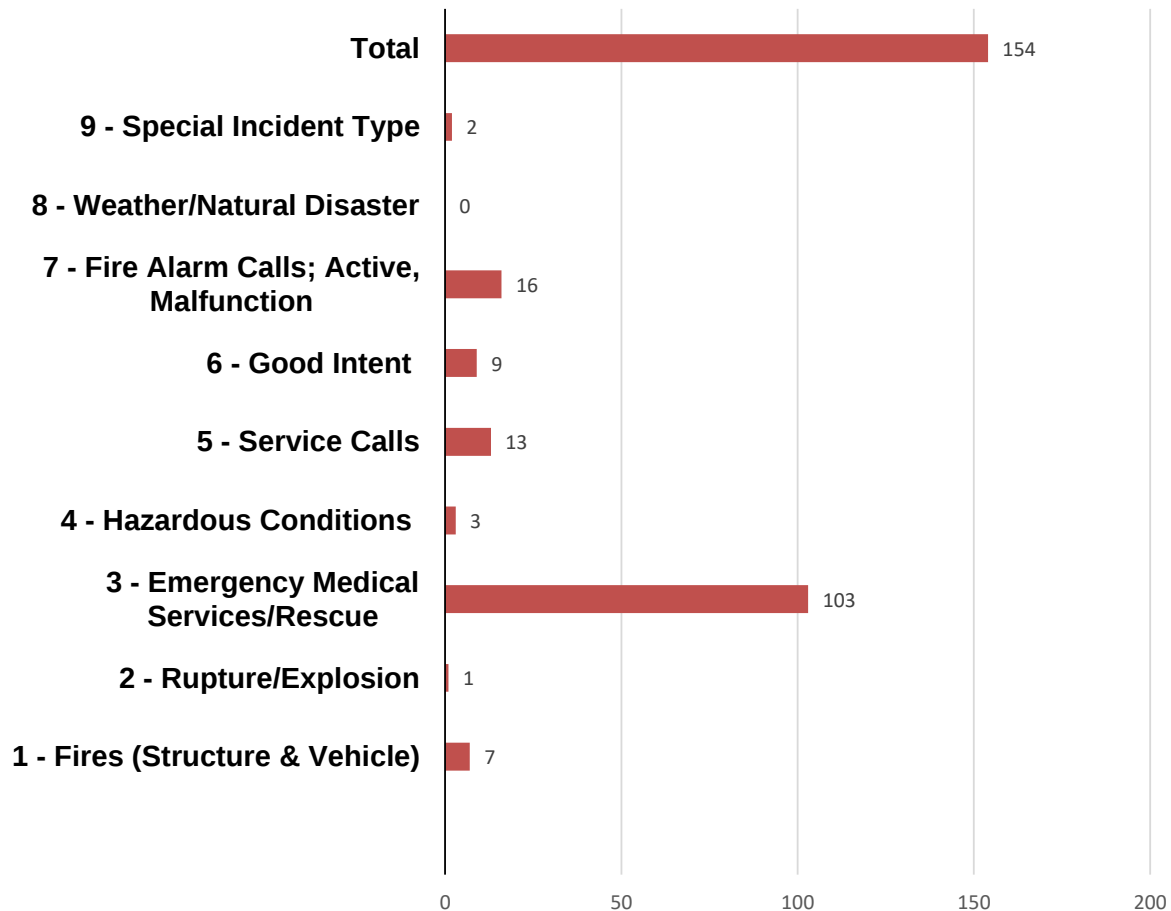

WEEKLY COUNT OF INCIDENT TYPE

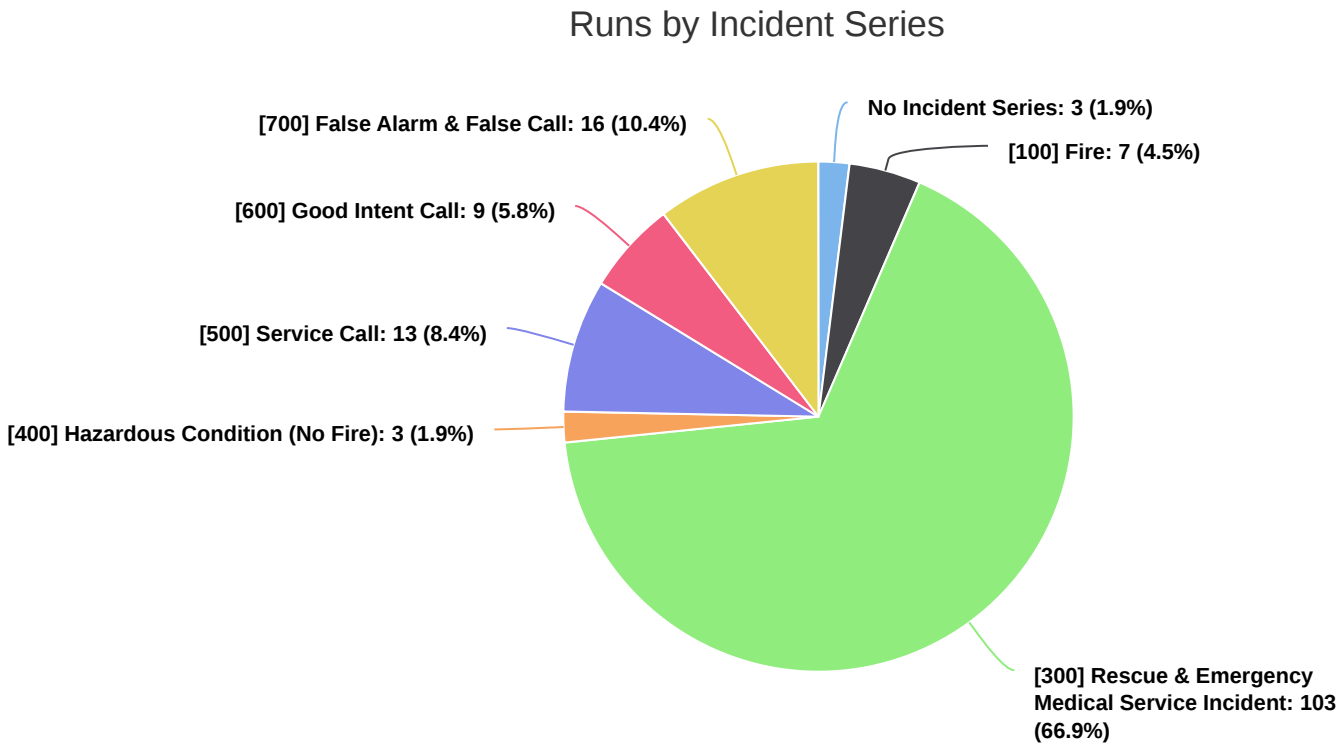

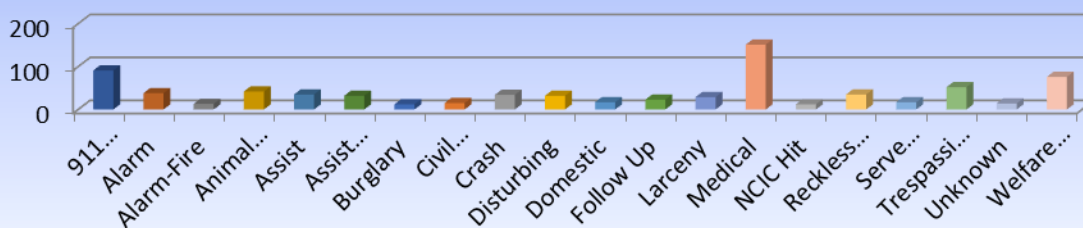

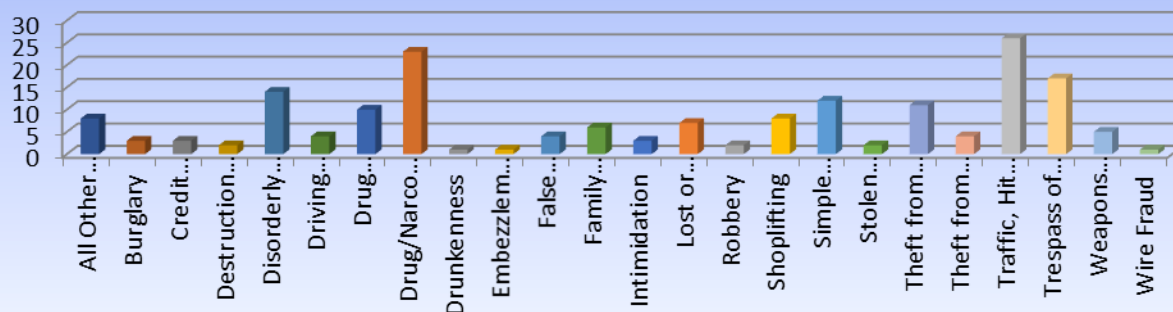

- Bay Vista Water Well – Received bids July 17, 2024; apparent low bidder Lyman Well at \$1.7m; Project was awarded on August 6, 2024; **Pre-con & NTP pending the return of contract documents from the contractor**
- Bay Vista Water Line Replacement Project No. 1013 – Working toward 60% plans
- Belle La Vie Lift Station – Will be out to bid by the end of July
- Biloxi-OS Bridge Walking Path Ramp – Have a plan to submit to MDOT, verbal discussions with MDOT indicate there won't be any issues with receiving a permit
- Brashier Bayou Sediment Removal – have all the permits, getting plans/specs ready to advertise need funding, received Tidelands funding but the money won't be available until 2025
- Bridge Repairs
 - Cedar Lake Bridge – Have fracture critical repairs that need to be made, don't have quote yet on repairs or funding
- Causeway Pier Repairs (east side) – Work is on-going
- Cedar Lake Bridge BRIC Grant – Met on August 1st to determine potential routes to be included in the study
- Concrete Annual Contract – See Repair-Replace list attached
- CTA Pass Road preemption/priority agreement – installation of preemption/priority equipment in the traffic signals along Pass Road, the City will be equipment to be installed in Fire Trucks as well, no cost to the City for 5 years, after 5 years will cost about \$4300 per year;
- Desporte Building Lean-To – **Issued addendum to clarify the scope of work; pushed bid opening back to August 21st**
- Hwy 90 parking improvements – 90% set of plans being reviewed
- Lighthouse Pier – design complete, received Corps Permit, waiting on FEMA/MEMA funding issues to be resolved

- Keegan Bayou Restoration – Permits being requested, GOMESA project submitted to DMR, also in the Restore Act Portal, Working with DMR to get dredging permit approval; Corps permit is out for public comment until July 15, 2024
- Kuhn St. Boat Launch Expansion – rejected bids, will rebid project once funding is available
- MGCCC Traffic Signal – Received bids July 17, 2024; apparent low bidder Powell Construction Services at \$450,000, Project was awarded on August 6, 2024; **waiting on MDOT concurrence to send out contract documents to be executed by the contractor.**
- Oak Street Pier (South) – Held 30% design meeting on August 1st
- Parker’s Creek Sediment Removal – Received the DMR permit, waiting on Corps permit; **consultant checked on status of Corps permit on August 5th, waiting on response**
- Paving – Phase I is complete, working on cost estimates to determine how much funding is needed for Phase II
 - Phase II Paving (Ward is parenthesis)

- Point Cadet Living Shoreline (BMA) – DMR approved the scope change, will have 100% plans for final review by City and Covington by the end of this week
- Point Cadet Nearshore #1096 (BMA) – design on-going, permitting is going to take longer than we thought, it’s probably going to be another 6-12 months in permitting
- Point Cadet Marina Phase II – will be receiving \$5.5 million in Restore funding, have BMA contract will review and then to get on council agenda for approval working on the Restore grant paperwork with Contracts to get the MDEQ agreement in place
- Point Cadet Marina Phase III – have preliminary layout that needs approval so a cost estimate can be developed so we can be ready for round 3 of funding
- Popp’s Ferry Extension #913 –
 - CSX formal easement documents should be received soon
 - Awarded contract to Necaise Bros. in the amount of \$20.8M, working through the MDOT process to get approval to hold pre-construction meeting

- Popp’s Ferry Bridge Draw Replacement – NS contract is under preliminary review by MDOT
- Port Repair Replace Contract – Emergency repairs to piers to Point Cadet Marina are complete;
- Repair/Replace Contract – See attached
- Rodenberg at Pass Road Intersection – ROW acquisition underway; letters to property owners asking if they will be willing to donate property will be going out in the next week
- Sediment Removal – the sites that have SAV, Seymour is trying to work with DMR on a way to mitigate, asked them to do another SAV survey under their existing contract; DMR is starting to allow invasive SAV to be removed meeting with Seymour this week for an update
 - Hiller Park Pond - have permits
 - Point Cadet Marina – have permits
 - Parkers Creek – pending Corps permit
 - Brasher Bayou – Have permits, ready to bid, need funding
- Shriners Blvd. Widening – This project is in the draft TIP for approval, it still has to go to MDOT and be adopted in the STIP, construction funding will be in 2027, but we will be able to start the design process in September or October
- Sports Complex #1093 – (Machado Patano/Talley Construction/\$5.0M); Change order to additional time to complete the baseball parking lot will be on August 6th agenda, additional time is being approved because this is additional scope outside of original contract
- Sport Complex Tennis Court Lights –Weaver Electric - \$178K, 70% complete, still have to retrofit one pole and then will put the new poles in the ground, should be done about the middle of August
- Tanglewood Infrastructure Ph II (MP) – DNA Underground - \$2.3m – NTP: 02/05/2024 - 270 days – Comp: 11/01/2024, work has started so far, no major concerns
- Tanglewood Sewer Replacement – Held design kick off meeting, project will be ready to bid in November 2024
- Ward 2 Recreational Center – Site plan has been approved by DRC, building plans are at 100%, Pickering is going to submit for building plan review so when the project goes out to bid the building permit will be ready to be applied for by the contractor

- Woolmarket Road Sidewalks – (Machado Patano) – Landmark Construction; \$998,507.43; **Preconstruction meeting August 13th, NTP date will be set at that meeting**
- Woolmarket Acres Infrastructure Improvements (Tiffany, Oaklawn, Boyette, Shorecrest) (Overstreet) design is 60% complete, met with consultant to bring the scope of work back into budget
