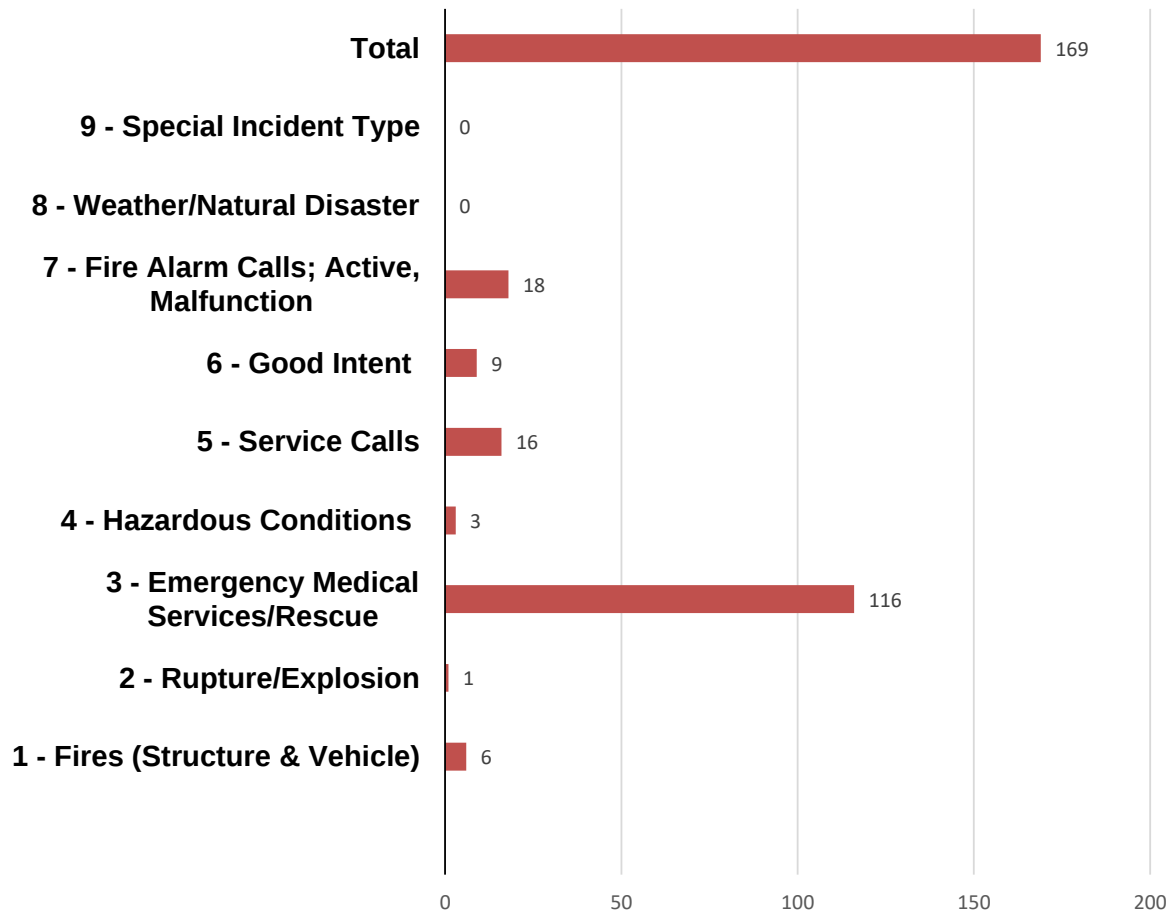

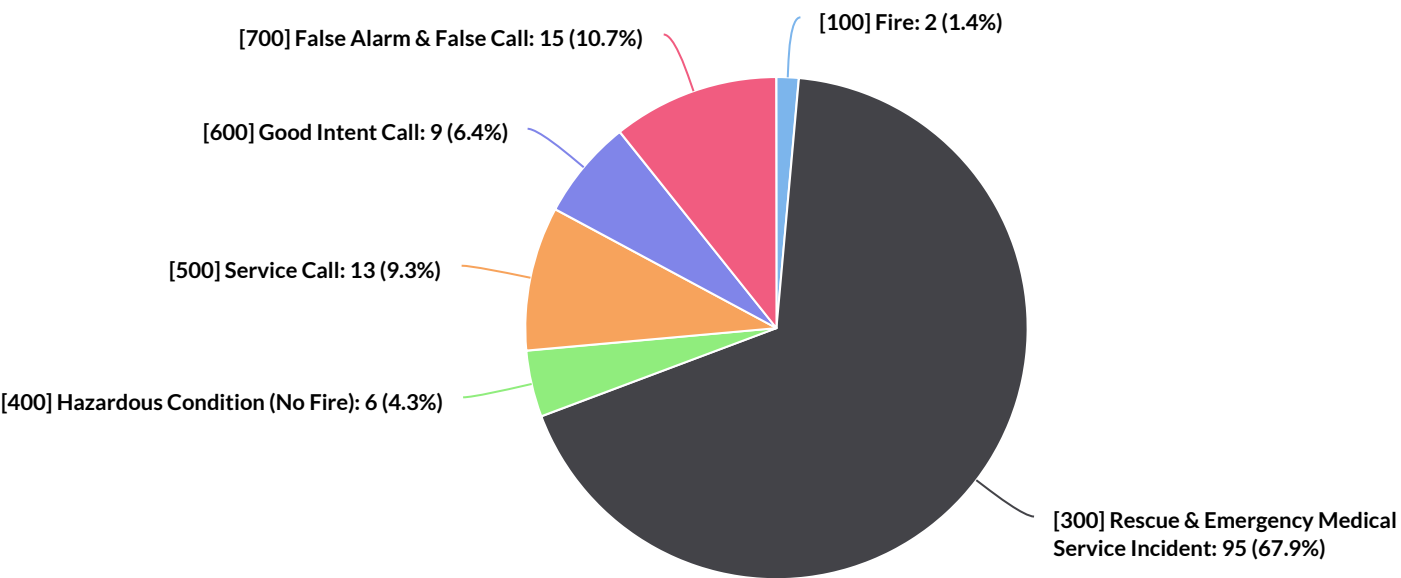
WEEKLY COUNT OF INCIDENT TYPE

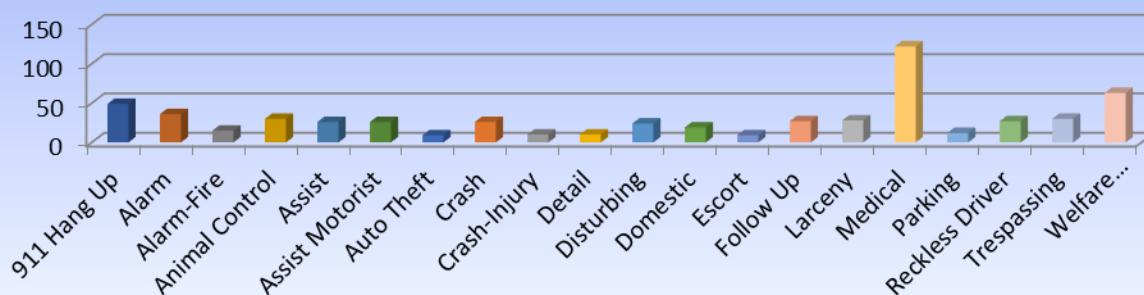
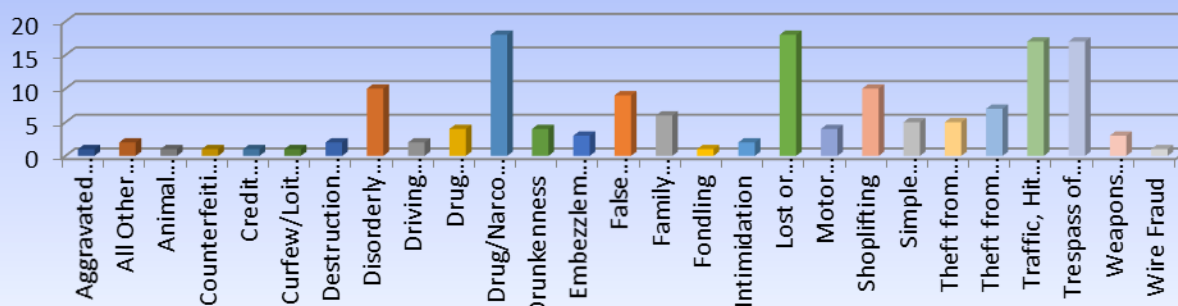

- CTA Pass Road preemption/priority agreement – installation of preemption/priority equipment in the traffic signals along Pass Road, project started
- 321 Division Lean-To – Tapout Construction \$264K; **building has been delivered; footers will begin being installed the end of the week.**

- Howard Creek Bridge (Old Hwy 67, just east of Hudson Krohn/Cedar Lake Intersection)
 - Received \$1.6M in State Aid funding (\$0 match) to replace this bridge, Rackley Engineering is expecting to have this project ready to bid by late summer
- Hwy 90 parking improvements – Ready to submit to MDOT for permit, construction is pending MDOT permit approval and funding
- Gruich Center HVAC upgrades – CDBG funded; project will be ready to advertise for bids by beginning of March
- Lighthouse Pier – design complete, received Corps Permit, waiting on FEMA/MEMA funding issues to be resolved
- Keegan Bayou Restoration – All permits have been received; receive bids March 19th
- Mallard Creek Subdivision (Wash Fayard Rd.) – Sewer complete, contractor will begin working on water next
- MGCCC Traffic Signal – Powell Const. \$450,000; NTP January 13, 2025; **construction has started**
- Oak Street Pier (South) – Received 60% design plans
- Old Brick House Roof Repairs – getting two quotes to replace the roof, gutter and downspouts
- Preserve at Parker’s Creek Phase II (Shriners Blvd.) – construction plans under review by engineering;
- Parker’s Creek Sediment Removal – Received the DMR permit & Corps permit, receive bids March 19th
- Paving – Phase I is complete, working on cost estimates to determine how much funding is needed for Phase II

- Point Cadet Living Shoreline (BMA) – Received bids January 29th, apparent low bidder with base bid and alternate Krause Marine Construction \$586,759.00, **Pre-construction meeting March 12th**
- Point Cadet Nearshore #1096 (BMA) – design on-going, permitting is going to take longer than we thought, it's probably going to be another 6-12 months in permitting
- Point Cadet Marina Phase II – will be receiving \$5.5 million in Restore funding, waiting on Restore grant agreement from MDEQ to begin design
- Popp's Ferry Extension #913 – Necaise Bros. \$20.8M, NTP 11/25/2024
 - Physical construction is expected to start on Jan. 13th on the water line bore under the CSX railroad pending CSX sending out flaggers this work is delayed because CSX has not yet provided a date flagger can be available heard back from CSX last week stating they are trying to get us flaggers scheduled but no date yet 3/3/2025 still waiting on CSX flaggers; **3/7/2025 talked to Kelly Wisely with STV she said she's going to try to push to get us flaggers here as soon as possible**
 - Contractor is working on cutting the road bed down to grade, have one area of bad material that we're working on how to handle
 - The tunnel on the south side of the railroad has been started
- Popp's Ferry Bridge Draw Replacement – Neel-Schaffer contract has been approved by FHWA and MDOT, NTP on Feb. 5, 2025; kickoff meeting will be March 27th design expected to be complete by Feb. 2025
- Port Repair Replace Contract
 - Dredging Point Cadet Marina – pending construction have issued PO
 - Sherman Canaan Marina – working up costs for make substantial repairs
- Pre-Event Debris Removal 2024-2028 – Due to new FEMA guidelines issued late 2024, we're going to reject bids and readvertise
- Repair/Replace Contract – See attached
- Rodenberg at Pass Road Intersection – ROW acquisition underway; First just compensation package was on the Dec. 3rd council agenda for approval
- Sediment Removal – the sites that have SAV, Seymour is trying to work with DMR on a way to mitigate, asked them to do another SAV survey under their existing contract; DMR is starting to allow invasive SAV to be removed meeting with Seymour this week for an update
 - Hiller Park Pond - have permits
 - Point Cadet Marina – have permits
 - Parkers Creek – Received both permits ready to bid
 - Brasher Bayou – Received bids Jan. 29th

- Shriners Blvd. Widening – Project was approved in the STIP; ready to begin the MDOT process by requesting Project Activation
- Southern Magnolia Subdivision (Shriners Blvd.) – Construction plans have been approved; construction pending outside agenda approvals; **preconstruction meeting will be held this week**
- Tanglewood Infrastructure Ph II (MP) – DNA Underground - \$2.3m; Comp: 03/15/2025, currently doing clean-up work, Park Circle water line is the only remaining work; no major concerns
- Woolmarket Road Sidewalks – (Machado Patano) – Landmark Construction; \$998,507.43; NTP October 23, 2024; Completion – April 2025; work is on-going; have poured from Jim Byrd to Lighthouse Marble, making their way west; pouring about 140 feet per day
- Woolmarket Acres Infrastructure Improvements (Tiffany, Oaklawn, Boyette, Shorecrest) (Overstreet) design is 75% complete, this project will have to be broken out into phases but we're waiting to see how much funding we receive before doing that and finalizing the design
